## **Mary Maxwell's Preface, updated for Revised Edition, 2026**

In July 2024, I learned from the Internet's Michelle Moore podcast, that a man named David Quigley claimed to be the real son of President Kennedy, and that he should be called "John F Kennedy, Jr." He was supposedly living at that time in Arizona.

Sounds like nonsense, right? Give me a couple of hours to show you that it's true. He's real and deserves a hearing. ## **PREFACE by John F Kennedy, Jr (Written in 2025)**

My father, John Kennedy, was born in Boston in 1917. He was in the Navy in World War II. In 1953 he had the good sense to marry Jacqueline Bouvier. My sister Caroline was born in 1957.

In 1960, John F Kennedy ran for president against Richard Nixon and won. The honesty of that November 8th election leaves room for doubt; my grandfather Joseph P had ties to Chicago's Mayor Daley who controlled some of the unions. The electoral college vote was 303 Kennedy, 219 Nixon.

Anyway, what did I care? Just 17 days later I entered the world -- on November 25, 1960! My childhood in the White House was as happy as could be. Even after my father's assassination in 1963, I remained close by my mother's side, for a while.

The story I will tell below contains information about deaths in the family, ones that have been hidden from the public. There is no point hiding it any longer. The truth won't kill anyone, and it may bring relief -- or even a major turn-around.

I recounted part of my story in the book *Stolen Identity* (2023). Jackie Goldman assisted me in writing it. I had been trying to "step forward" since 2019, or earlier, but was, naturally, not believed. That book made it possible for podcasters to offer me an interview, for which I am deeply grateful.

Because of MK-Ultra, I have many gaps of memory. Almost the entire chunk from age 14 to age 30 is missing. Some memories are starting to come back, however, as is happening to many mind-control survivors. And I have a woman friend, Robin, who helps me figure things out, and is a source of joy.

Any help with my court cases would be appreciated. It's time this country got back on the track of justice, do you agree?

## Timeline of Events, 1917 to 1974 -- **Non-controversial**

**1914:** **Joseph P Kennedy**, a bank president, marries **Rose Fitzgerald**, daughter of Boston Mayor Honey Fitz. They beget nine children, of which Teddy, the youngest, is born in 1932.

**1917:** **John F Kennedy** is born in Brookline, Massachusetts.  
**1937-1940:** FDR appoints “Joe” as US Ambassador to the UK.

**1944:** Joe’s oldest son Joe Jr dies in war, his body never found

**1940:** John graduates from Harvard, *cum laude*, joins US Navy.

**1946:** John elected to US House of Reps from Massachusetts.

**1952:** He is elected a US **Senator**

**1953:** Senator Kennedy marries **Jacqueline** Bouvier, age 24.

**1957:** Their first child **Caroline** is born November 27.

**1960:** John wins November 8 **election** against Dick Nixon.

**1960:** Jackie gives birth to son John, Jr, November 25.

**1961:** John inaugurated as president. Americans proud, happy.

**1963:** Jacqueline gives birth to **Patrick** Bouvier Kennedy on August 7. Reportedly, baby dies Aug 9, hyaline membrane disease.

**1963:** President **assassinated** in Dallas, November 22. John’s saluting father’s casket (on his 3rd birthday) becomes iconic:



## **Timeline of Events 1960-2026 -- Controversial, Hidden**

**1960:** A boy is born secretly in Milan to opera star Maria Callas. He is named Omer and is said to have died (but probably did not). The likely father is Aristotle Onassis.

**1965:** John Jr is placed near Fresno Cal, with Quigley family, and is called **David Keith Quigley**. He's 'bought' by a powerful 'federal agent' code-named **Wayne**.

**1965-1988:** John suffered in the MK-Ultra program for years. Sometimes stayed with mother Jackie in New York. Attended first grade at St David's New York, then Collegiate School.

**1971:** But Omer, playing role as a false John F Kennedy, Jr is at same school, Collegiate. Two students with identical names!

**1968:** Assassination of **Robert F Kennedy** devastates Junior.

**1968:** Jackie marries **Aristotle Onassis**. Thus John gains two stepsiblings, Alexander and Christina. From 1968 to 1975, John was sometimes with Quigleys in California or in NY with Mom or on Ari's Skorpios Island. Sometimes Omer was there. On Skorpios. Jackie once referred to Omer as 'your brother.'

**1973:** **Alexander Onassis**, age 24, was shot dead in a plane, as witnessed by John. Ari ordered John: "Never, ever, tell or we'll look weak." The public was told it was a plane crash.

**1983:** 'Omer' graduates from Brown University as "**JFK, Jr.**"

*Note:* The next page lists 7 murders, as reported by John. i.e., the real John. I (Mary Maxwell) do not have enough evidence to proclaim them proven. This book will discuss them in detail. They sound plausible and I have not yet caught John in any lie.

**1975. Death of Ari.** First it should be noted that both Jackie and her spouse Ari moved to Bullhead City Arizona, perhaps out of fear of being killed in Greece or NY. One day, John saw children carrying axes to a yard where Ari was alone, and a man carried a video camera. John says the kids were told to do the murder. They'd be caught on camera, to blackmail them. Thus **Ari died.** Media said he died in Paris of respiratory trouble. Granted the one who was axed may have been a body double.

**1975. Death of Martha Moxley.** It's undisputed that a girl in Connecticut died by being beaten with a golf club, within a block of the house where the Skakel family lived. home. A nephew of Ethel Kennedy, Michael Skakel, was convicted (probably wrongly) of Martha's murder. John says there is a possibility that Martha was really his sister **Caroline.** 'Martha' was 15 but if she is Caroline, that girl's true age was 18. John isn't sure about it, but he estimates that the last time he saw Caroline she was age 10 or 12. He thinks she was replaced by the lady we all know today as Caroline Kennedy Schlossberg.

**1975. Death of Jackie Kennedy Onassis.** Starting even in the White House, Jackie used body doubles. John's real mother Jackie (who was bullied and given LSD) **died in 1975.** It took place in Bullhead City and was by gunshot. John heard the noise and found Mom on the ground. After this, he, at age 14, hid on the yacht, with kind permission of its owner, Christina.

**1988.** Christina died at age 37, perhaps killed. She is survived by her daughter Athina, but Athina is possibly a Replacement.

## Chapter 1. Introduction: What I Can Offer Today?

My father had just a bit more than 1,000 days in office. All around him, people were feeling something new. The feeling extended overseas, too. Because I was only two, going-on-three, I can't claim to have been aware of "The New Frontier", "the Peace Corps," or any of his policies. At this late date I am only hearing about them. And noticing his strength.

Evelyn Lincoln was Kennedy's personal secretary from 1953 until he died. On November 19, 1963, her diary records:

"As Mr. Kennedy sat in the rocker in my office, his head resting on its back he placed his left leg across his right knee. He rocked slightly as he talked. In a slow pensive voice he said to me, 'You know if I am re-elected in Sixty-four, **I am going to spend more and more time toward making government service an honorable career.** I would like to tailor the executive and legislative branches of government so that they can keep up with the tremendous strides and **progress being made in other fields.** -- from Evelyn Lincoln's 1968 book, *Kennedy and Johnson*. [Emphasis added]

I am 65 and my last 50 years were pretty tough. Still, there are crises of this nation that must be worked on urgently, and I see some ways to get started. One is "a restoration of truth-telling." That would turn things around quickly, wouldn't it?

Another theme I can contribute, based on my particular biography, is “Let’s start caring for each other.” Or to paraphrase a famous man: “Ask not what your country can do for you. Ask how to give some love and protection to those who need it.” I also urge you to recognize natural leaders; we have gone too far believing in celebrities. Unofficial activists are a treasure.

To prepare for this book, I surveyed umpteen old photos and was touched to note the expression of very great sadness on the face of people at President Kennedy’s funeral -- including Army and Navy men. They suffered a great loss that day. Lately, our military suffers 8 suicides per day. Why is that?

This book tells how another boy replaced me in my youth, and how I now dare to reclaim my identity. I offer my support to others like myself who were kidnapped and tortured. I was MK-Ultra’d – mind controlled – like thousands of Americans!

It’s time to get real. Stop being embarrassed to say that some of our fellow Americans do terrible things to us. They are not ‘exempt’ because they are wealthy. It’s natural for us to kowtow to the powerful but we’ve got to overcome that trait. Isn’t the whole point of the 1776 Declaration of Independence that when there is “a train of abuses” it is time to act?

## Chapter 2. I Thank God for My Detached Earlobes!

This will be a short chapter, as it exists only to make one point, *viz.*, the little boy whom everyone saw in the White House, had a certain type of earlobe known as “detached.” Clearly, he must be the real son of the president! Not because he has detached earlobes, but because it would have been impossible for photographers to doctor so many photos ‘retroactively.’

Are you with me? The kid shown above with Jackie is indisputably JFK, Jr (myself). No one makes any argument against *that*. So where did he disappear to? And how is it that when he reached 15 or so, the newspapers started to show a different boy, with that name, in photos. People simply accepted him!

Unless transhumanism occurred sooner than we realized, that teenage boy is a substitute. We call it, in the trade, a Replacement. Oh, which trade is that? Um. It may be either ‘Identity Theft,’ done for money. Or sometimes there are ‘baby swaps’ in which a baby gets inserted into another family, with a plan for him to emerge later. I think in my case it was Identity Theft. I hypothesize that the Mafia knew that President Kennedy was very wealthy and that it would be possible to kill off his son, insert a new one, and that son would inherit the money.

Admittedly I was too young to see exactly what happened -- I may be wrong that the motive was money. But rest assured that the dark-haired man shown on the previous-page cannot be the son of Jacqueline. Her real son has *detached* earlobes but that guy has attached – see? Which kind of earlobes have you got?

## How Did ‘George’ and I Meet?

As stated in this book’s Timeline, the replacement may be an Onassis out-of-wedlock baby named Omer, born of Maria Callas. I never heard the name Omer but I gave him the nickname ‘George,’ based on the *George* magazine that he produced.

I was effectively orphaned when my mother was killed in 1975. But even before that, as early as age 5, I underwent the torture known as MK-Ultra. By now it’s “declassified” that the CIA conducted that kind of mind control (which involves electric torture, beatings, etc). One result is that I have a hazy memory.

However, I do recall meeting “George” when I attended the Collegiate School in New York City near my (widowed) mother’s apartment. You won’t believe it, but both of us boys attended that school using the same name: JFK, Jr. You could ask the school to explain it.

I am calling him George in this book to relieve the need for sarcastic quote marks 'JFK'. Here's a photo that a French Canadian recently sent me (*merci!*), that shows both of us boys. Plus a girl named 'Caroline,' is on the boat with us. In my youth I was presented with at least three fake sister Caroline's.

The one on the boat told me she did not want to see me anymore as she knew that "They" were planning to 'un-alive' me. It's miraculous that I did not get un-alived. Constantly, for decades, I received death threats.

If you meet people who say I'm an interloper or a mental case, please tell them that I admit I haven't yet got the proof that I am Jackie's baby. But there is conclusive proof that George is *not* Jackie's baby. And what is that proof? Attached earlobes.

So far, contributors have given me \$2,600 to obtain a DNA test, but the lab in Colorado took that money and won't give me the results. I apologize to -- and am grateful to -- the folks who have been showing much care. I won't let you down.

## Chapter 3. My Days As a Child Actor in Hollywood

If you are old enough, you may recall seeing me on TV-shows *Adam-12*, and *Mayberry-RFD* (with 'Gomer Pyle'). Many of these shows are still available; some are on YouTube.com.

Since going public on podcasts, I have received material from kind citizens, to help me prove my identity. A very valuable one was found to have been published by NBC. It shows that I was a child actor from around 1968 to 1972, using the stage name "Richard Steele." You can find it at [Archive.org](http://Archive.org).

I was also in commercials, possibly including Wrigley's Double Mint Gum. I don't claim to have played leading roles -- only small parts. My age was 7 to 11. I met the real John Wayne at Hollywood rehearsals and thought he was very impressive. Actors who knew me then were aware, I believe, that I was the son of the late president. That didn't create a troublesome issue as my Replacement had not yet made his debut.

'Wayne' is my code-name for a man who was assigned to me as a child and watched out for me as an adult. He was powerful in many organizations including military, the casino business, and Hollywood. It was he who introduced me to music stars and actors. They all seemed to know him and they obeyed him. He saved my life. I think maybe his father was big in the mafia.

For sure, Dolly Parton knows my story and I think so does Rosie O'Donnell (with whom I had a few fights), and Clint Eastwood. Others whom I remember who would likely recognize me: Kid Rock, Jim Fallon, Ozzie Osborne, Reva McIntyre, LaToya Jackson, and Hank Williams.

Some of them were hurting, like me. Most were MK-Ultra'd. And don't forget that Mel Gibson and Corey Feldman have both said that child abuse is institutionalized in Hollywood.

Here is the lovely document made by **NBC**. It helps a lot since it lists me as both John Kennedy, Jr *and* David Quigley:

In 1980, I was in Australia with Wayne when *Roadgames* was being made. I was 20 and Jamie Lee Curtis was 22; she is the daughter of Tony Curtis. She was in the movie, but I wasn't -- I just helped out with props. I called Jamie my sister, and I am sure she will stand up for me.

Note: Grandpa Kennedy had big investments in Hollywood.

## Chapter 4. My Miniscule Contribution re “Dallas”

About that awful day, November 22, 1963, much has been written. I cannot contribute any knowledge about the event itself, as I was only a toddler. But I do distinctly remember one thing. Dad and I were riding in his convertible, the one with red upholstery. That car was kept at Hyannis, so it must have been summer, 1963. He was very upset and was crying. He banged both hands on the steering wheel and said “Shit! They’re going to kill me. I know they are going to kill me.”

One guilty party to my father’s assassination has got to be a compound of all the government personnel who refused to examine the evidence in the well-established ways of justice.

The main body of inquiry consisted of the Warren Commission, headed by the then-Chief Justice of the United States, Earl Warren. Two members, Alan Dulles (head of CIA) and Rep Gerald Ford, who became president in 1974, were extreme tormentors of children. I’m mentioning that to alert you to the fact that “official commissioners” for anything can be liars.

Their “**Warren Report**” came out later. It was backed up by 26 volumes of testimony. However, Sylvia Meagher (1921-1989), an official at the WHO, made an index-card collection

of the material, and found that the final Report didn't accurately reflect the contents of those volumes. Thus, from the beginning, someone was covering up. Note: coverup is a crime.

In 1976, the House of Representatives took it upon itself to establish the **HSCA** -- House Select Committee to do "a full and complete investigation of the circumstances surrounding the deaths of President John F. Kennedy and Dr Martin Luther King, Jr." who was shot dead on a hotel balcony in 1968.

The conclusion drawn by HSCA was that Lee Harvey Oswald was guilty, as Warren Commission had said, but that he seemed to have had a helper and therefore a conspiracy is "probable." Yet that conclusion got only light attention from the media.

Next we had The President John F. Kennedy Assassination Records Collection Act of 1992. It ordered the executive to release all the files. So there you have the proper chain of command. The Congress is the People's branch of government. I'm a People and have a right to know what is known about JFK.

The Act allowed for some material to be held back, due to National Security concerns [?]. Presidents Trump and Biden did release thousands of documents but with huge redactions. Retired Judge Andrew Napolitano says that Trump told him that he was *shocked* when he saw what is still secret. Let's have it.

Interruption: By now, many redactions have been 'unredacted.' In this revised edition of *The Historian's Tale*, Mary Maxwell has added anew "Part III" to discuss the Assassination.

## **Prominent Theories**

The first theory of the assassination was that communist Cuba was involved. Of course media supported this "official narrative." The Cold War was a major cultural theme in the US in the 1960s, and people readily believed anything about The

Communist threat. Over the decades, many theories were proposed and over two thousand books written on the subject.

There was never a trial. Oswald was killed on November 24, 1963 by Jack Ruby, so no one has ever been subpoena'd to tell what they know. Along the line of circumstantial evidence, we have the book *Hit List* by Richard Belzer and David Wayne, listing 50 deaths of likely witnesses or whistleblowers. These include journalist Dorothy Kilgallen, scientist David Ferrie, and strippers from Jack Ruby's Carousel Lounge.

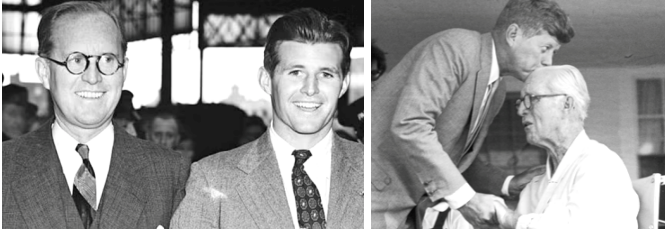
Of many books blaming the CIA, one is by ex-CIA man Fletcher Prouty. Some blame CIA man James Angleton, who was a friend of Israel and this leads to Guyénot's *The Unspeakable Kennedy Truth* which blames Ben-Gurion -- re JFK wanting to halt Dimona, Israel's "factory" of nuke weapons.

A main guilty party must have been LBJ, as he got what he wanted, a sort of accelerating of the 1964 election. His mistress Madeleine Duncan Brown wrote a book in 1987, *Texas in the Morning*, claiming that LBJ said to her, the night before the assassination: "After tomorrow, those goddamn Kennedys will never embarrass me again."

LBJ was referring to both Dad and Uncle Robert who, as US Attorney General, was hounding the mafia, and had even deported Carlos Marcello. Since the mafia had also helped our family, this was deemed a betrayal which, among mafiosi, calls for clear revenge. Because my life experience involved suffering under the mafia, I'd be pleased to blame them for anything.

I may yet contribute by filing, as a son, a wrongful death claim re Dad. (Recall the Goldman family did so for the death of their son, against OJ Simpson). Clearly I am the sole survivor of JFK -- unless, possibly, Mom's baby, Patrick Bouvier Kennedy, didn't die but was sent into hiding like me. There is also a guy, born 1951, who says his parents are JFK and Marilyn Monroe.

## Chapter 5. Grandpa Joe Had Illuminati Morals

When this book gets printed, it will no doubt cause an outbreak of criticism of the Kennedy family. Let me pre-empt that! This chapter is about Joseph P Kennedy. It is also about the Illuminati and its moral code which completely *opposes* virtue!

I need to fit myself into this picture. I am not a saint. There are no saints. Every person, like every animal, tries to survive. For humans, this may mean using virtue (which brings support from one's community), or may rely on selfish calculation.

For a half century I've been more or less alone -- from Jackie's passing in 1975 to today in 2025 when I suddenly have friends, thanks to Internet publicity. I know that I am craving a role in society where **I can at least rescue the many people** who have been as controlled as I was, plus share some high ideals that seem to come naturally to me. I have a warm heart.

Using Fritz Springmeier's deep research, in *Bloodlines of the Illuminati*, we see that the Kennedy's are from both Scotland and Ireland. Their name was also spelled Caeneddi and by 1500 they married into royalty. I have not yet found out how "Joe" is an American representative of the Illuminati, or whether he took orders from above. Someday I may get into that research. For now, I think he was more like business-mafia than like a "World Orderist." Mary Maxwell tells me that my story so far

-- which means material in my book *Stolen Identity* plus remarks I have made to several interviewers -- has made her think that by the 21st century the mafia guys and the World Order guys must have merged, for mutual protection.

**Grandpa Joe.** By the time Joe -- my father's father -- was born, in 1888, there had already been a generation of political involvement in this family. Namely, his father PJ Kennedy had been a ward boss in East Boston. Politics was a standard way for Irish immigrants to get power.

I do not yet know much about Joe's life. I met him, of course, because we all assembled regularly at 'the Kennedy Compound' in Hyannis Port (a boat haven in Cape Cod, Massachusetts). There are now many histories of the 35th presidency in which it is claimed that Joe pushed JFK into politics and that he gave many firm instructions, such that Bobby must be appointed Attorney General. By the way, someday I may find out if Joe had any part in my getting the name "Quigley" in 1965 or so.

Grandpa has got much criticism for sending his daughter Rosemary off to be lobotomized. This incapacitated her, but it motivated my Aunt Eunice Shriver to create the Special Olympics which has given many disabled persons a taste of the athletic life.

## **Sexual Morality and World Order**

There is no denying that President Kennedy had lovers galore. It is known that at the time of Jackie's delivery, Dad went on a Mediterranean cruise with his buddy Senator Smathers. Surely, he'd want to attend his baby's birth!

When Joe married Rose Fitzgerald, who seemed to get her strictness from Catholicism, there might have been an agreement that he could keep mistresses. She put up with it. I have read that she allowed a mistress to go on vacation with them! It could also be that he had a sexual addiction. I think JFK's need for extra-women may have been an actual addiction.

Joe was mean to his lover Gloria Swanson. He contracted with her to produce a movie together. She did not read the fine print that made her liable for all losses, so she ended up in debt. Joe made a lot of money from Hollywood.

This chapter title, *Illuminati Morals*, hints at something bigger. It is known that some branches of Illuminati are devil worshippers. In fact **satanism** has recently been outed in connection with **child trafficking worldwide**.

The gist of satanic belief is, as Alister Crowley put it "Do what thou wilt is the whole of the law." *Paraphrased*: "We smarties think morality is stupid." I do not know if my family had any satanic involvement. Maybe.

Was Joseph P involved in rackets including banking and bootlegging? If so, did he foresee that all of this is "World Order" stuff? He was not philosophically globalist. I think he was mainly ambitious for money. Still, Kennedys are Illuminati. By the way, he was ambassador to the UK, a 'special' position.

## Chapter 6. The 1999 Plane Crash Near Martha's Vineyard

*Herewith a transcript of Mary Maxwell questioning me, unrehearsed, on November 14, 2024. Note: When I say “John” I am referring to my Replacement, whom I nickname George. There were 4 of us on that plane:*

MM: We are here in Arizona at a truck wash, and I have asked Mr Kennedy if he will show us ... what happened on the night of the plane crash. I must say I didn't believe it when I first read it in his book [*Stolen Identity*]. For one thing, I thought if a plane is underwater, you'd have no hope of opening the door against the pressure.

So I'll ask him to explain that, and ask him to as to how quickly he thought about what he should be doing. Apparently, he's no slouch. OK, here we go. Mr Kennedy, please sit on the edge there, like you are doing... and pretend you are in the seat of a helicopter. Now where would your shoulders be?

**JK.** Uh, it was actually an airplane.

MM: OK, a plane. So you're in the back seat.

**JK:** Yeah, and it was really tight quarters, just like we are now, and John was the pilot to my [front] left and his wife to the right, yep, and it was really tight quarters so the seats were right at our knees. When John announced that he could not steer the plane, we were in a left-hand turn. Um, the minute he said that, his wife started arguing with him; he started arguing with her. They were swearing at each other; it got worse, it didn't stop. I

told John “If you can’t steer the plane, just reduce your speed and we’ll just keep going in a circle until we slow down and crash.” They were too busy arguing to hear what I said. I reached down at my feet and grabbed the life preserver.

I put it over my head. I put my arms in the position over the preserver in front of my body as a cushion. I put my shoulder and head down behind the seat and I don’t know if I instructed Lauren to do the same. Maybe she followed my instructions, but I was already in the position to crash before we crashed.

MM: So what you’re saying now occurred before the water was reached by the plane.

**JK:** OK, yes, when we hit it was like hitting a brick wall, like a head-on collision. We hit hard. I probably dislocated my shoulder into the back of the seat.

MM: Was there any blood? **JK:** I do not know. I was concerned about that when I was in the water, because sharks are very intelligent: it only takes a drop and they will track you down. So it was a big concern. Um, the door was in the forward position, but like you said we were already on top of the water we had not gotten under the water as soon as we hit I was opening the door. I grabbed her probably by the arm and drug her away.

MM: Was there a question of seat belts, were you using seat belts during the flight?

**JK:** I was not. I was in the position with no seat belt, already bracing myself. I had the life preserver as a cushion in between me and the ... once we got out, like I said about the same distance as that van there um 20 ft or so, and the plane was like this and we were to the right of the aircraft and it was nose dived into the water and she [Lauren] was struggling with me.

So, we were at the right of the plane, she was screaming she had to go check on her sister, and she was struggling with me. I let her go at that time and as soon as she reached the plane the plane disappeared.

MM: Did you ... **JK:** I never saw the three again.

MM: Now at that point, was it night time? Had darkness to fall?

**JK:** Yes, it was night time. There were clouds and a mist in the air, and the waves were as tall as that white car right there [a small car, maybe 4.5 feet tall]. Once a wave hit, I would float up and I was in this position the whole time, holding the life preserver against my body. When I would get to the top, I would turn my head.

I think I messed up my neck and my shoulder. It was really hard for me to move my neck but I would look for lights in the distance. I thought I had seen a light way off in the distance. Um, once I got to a top and I just started paddling. And the shark concern was really concerning.

MM: And wouldn't you mainly freeze? Was it frozen?

**JK:** It was really cold and I went, I did go, into shock and um my guess is I was conscious for 20 minutes or a half hour. I wasn't conscious long. I was trying to get to shore but after that time all I remember is being hoisted on the front end of a ship, the bow, and covered with blankets.

MM: And you probably were carrying a GPS. Even though that's 25 years ago, you probably were traceable.

**JK:** I probably, as a son of our president, had one at that time, at a very, very young age.

MM: Yeah, OK, and now at the moment of a ship coming for you, did they know who they were looking for?

**JK:** I was so out of it. All I remember is being covered with blankets and what I believe was the captain of the ship walking in front of me pacing in front of me. And I was in shock, they just kept covering blankets on me and that's all I remember that was it, OK.

MM: Well, thank you for the description. Now that night, before that happened, you were waiting on another island, or back on the mainland, to get on the plane? Where were you?

**JK:** I was actually at a truck stop, and a Secret Service agent picked me up, along with John. I didn't want to go; they were like "Come on you'll have fun, we're going to a wedding." I was like "I really don't want to go," and they persisted. And I just was like, what the hell, I got to figure out what this is all about. Um thinking they were planning on killing me. Which, come to find out, they were.

MM: At that wedding. But you were kind of an incidental death to the other deaths, were you?

**JK:** I believe that they wanted all of us to die that day, and cover up the whole story, his story, my story, all of it at once, yeah.

MM: Do you think Lauren is really Carolyn's sister? They don't look at all alike. But then I don't look like my sister.

**JK:** I really, I really couldn't answer that. I don't know, OK?

MM: All right, thank you very much. I'm going to end that little interview right now, in the truck stop of Kingman, Arizona.

*Note: John realized only after this that his Navy Seal training saved him.*

Thousands of people have suffered identity theft lately. In my case there were big motives, but for most people it may be that someone just wants to cause harassment in general. Keeping people in 'turbulence' is one of the goals of the Big Boys.

In either case, it's difficult to reclaim one's documents. What if I go to the Washington DC records office where the birth certificate of JFK, Jr is held? The clerk will tell me I'm a fraud. So at present I'm trying to get the BC of 'David Quigley.' I do have the above photocopy, given to me by Dorothy Quigley. It shows Dorothy as having birthed a boy in 1966. Not me, I was post-kindergarten at that point. Did she have a boy in 1966? I saw her around that time and she did not look prego.

I assume this BC is a forgery, although California gave me a driver's license based on this photocopy, and banks have given me credit cards based on that license! For some reason I was told to use 1966 (not 1960) as my date of birth. Moreover I was made to look younger in my school years: I was given a handful of 'vitamins' every morning -- puberty blockers? (I was also told to stop being a lefty, apparently so I'd match up with a future substitute. How did they know the substitute is a righty?)

Since I won't be able to get a US passport, I can try to get one from Ireland! Grandpa's father was PJ, son of an immigrant. JFK Presidential Library in Dorchester, run by Congress, gives this information about PJ, the father of Grandpa. He was:

“born in 1858, youngest of five children born to immigrants Patrick Kennedy (1823-1858) and Bridget Murphy Kennedy [You can't beat a name like that!] (1824-1888), from New Ross, Co Wexford. Patrick died soon after his son PJ was born. PJ left school at age fourteen to begin working as a stevedore on the Boston docks [!!!]. In the 1880s, following in his mother's [!!!] footsteps he bought a downtown saloon and launched his business career and he soon owned three bars and a whiskey import firm. Kennedy became a major figure in the Democratic Party. He was elected to serve in the Massachusetts House of Representatives (1884-1889) and Massachusetts Senate (1889-1895), although most of his political power was wielded unofficially as a local 'ward boss' for more than thirty years.”

## Chapter 8. Where Is the Real Caroline Kennedy?

The last time I recall seeing my dear Caroline alive was around 1969; I was 8, so she was 11. (We have November birthdays.) In due course I may have further memories. In 1974 the Moxleys moved to Greenwich CT. Their house was only a block away from the home of the Skakel family. The dad of the Skakels was a brother of Ethel Skakel who became a Kennedy in 1950, upon marriage to my dear uncle Robert. (And yes, Mom and Robert were close and he looked after me well, so that was another assassination that was hellish for me.)

On Halloween morning, 1975, I was taken to see Martha’s body on the ground. Her hair covered her face. I don’t have anything to contribute. If it wasn’t Caroline, where is she?

## Chapter 9. My Sweet Son, David R.

Now I'd like to tell you an even more hard-to-grasp story. It is about my dear boy, born 1988. He died 6 months ago, in 2024, at age 36 and I should be in mourning. However, the pressure to get other things done as fast as possible today means I am not giving him his proper due.

It was lovely to have his companionship for all those years. When a baby is first placed in your arms, you fall in love with it. And you start to imagine his or her future. This is true whether the child is adopted or natural born, and even some foster parents get completely attached and love their 'ward.'

When David called me "Dad" I was thrilled. By the way, don't forget that for much of my life I have been operating as David Keith Quigley. (I was told it was a name assigned to me under a Witness Protection arrangement, which I sort of doubt.) I was said to be the child of Max and Dorothy Quigley, who had no love for me whatsoever. We lived near Yosemite Lakes, Cal.

**The Right To Life and the Right To Propagate.** If you don't want to hear sad stuff, that's OK. Just jump over this chapter. It is about what took place when I was age 27.

There was a plan, apparently, to make me become the legal father, but not the biological father, of a child. How to do that? First, I was forcibly vasectomized. It took place on a kitchen table and made me ill for two weeks. The amateur surgeon, Charlie Brown, was later killed, as far as I can figure out.

Second, I was dragooned into a marriage. I was given some drugs and then taken to the Northern California home of the grandparents of my then-girlfriend, Lisa. They had set up a Las Vegas chapel wedding ceremony for us. We went to it and we did the legal thing, complete with a wedding cake.

Subsequently, in 1988, Lisa birthed a child. Oddly, she took it to Vermont and swapped it with a friend's child. After two weeks, she brought that other boy to me. I named him David R, and cared for him until he was in school but I had no money. (Absolute impoverishment is part of the MK-Ultra' experiment.) Later, Dorothy Quigley got full custody of my boy.

Although I was a long-distance truck driver, I came home as often as possible to see David R, my dear son, and I will miss him. In his adulthood we did everything together.

We have high heat in Arizona, over a hundred degrees. In July 2024, David passed away at home. I was not there, but was on the phone with him. By the time I got to him, he was sitting on the sofa, deceased. Evidence suggests he had been outside doing exercises, in high temperature, and suffered heat stroke.

Yet it could have been a type of programmed suicide. The thing known as 'programmed suicide' does exist – a person is unfairly planted with a code that tells them when to kill themselves. By the way, I, and many others, are walking around with a chip in the brain that allows our controllers not only to see what we are doing, but to control us long-distance, e.g., by buzzing us to wake from sleep in order to do a 'task' for them.

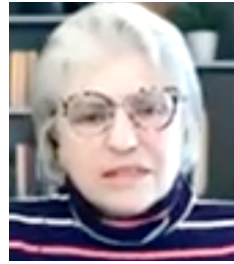
## Chapter 10. And So to MK-Ultra

As you'll see in Chapter 7, I had the strength to survive a plane crash in the ocean. Maybe it's thanks to my basic training in both Army and Navy Special Forces. I am a strong dude. It's also possible that some of the victims of MK-Ultra are able to make up their mind to *not* be defeated, even by torture.

This chapter is not about me, but about MK-Ultra as such. You can see a YouTube video of Ms Maxwell interviewing me about my experience. She says she wasted her money traveling to Arizona to inspect me, as she already knew from my book that I had been 'under' (that's a name for mind control or hypnosis).

To sum it up, MK involves taking your life and ruining it. It involves hurt, humiliation, and hunger, plus sexual abuse, terror, and using you for their needs whatever that may involve. The perps include politicians, psychologists, doctors, nurses, priests, military personnel, just about anyone. IT MUST STOP.

### **The CIA (What the Hell Is the CIA, Anyway?)**

You are free to doubt anything I say, of course, but if you doubt what the CIA did on mind control, just hop over to their website [cia.gov](http://cia.gov) where they admit to all their horrors (with no apology). This includes radiation experiments carried out on children and soldiers, and dispensing of LSD to the unwary.

CIA also gave syphilis to Tuskegee men, and Abu Ghraib pix show CIA torture and military dogs. (Did you try to stop it?).

In 1976, Senator Frank Church held hearings on mind control. The program used on me had been called Project Artichoke. But in 1953, it was renamed MK-Ultra. I've only started to come out of it and have not added much to the literature yet. I offer instead some quotes for survivors who published books:

**On suppressed memories.** From Juliette Engel, MD, *Sparkey, Surviving Sex Magic* (2020), p 194:

“The Aeroflot charter landed and our group of Americans was escorted into Moscow. I'd never been to Russia, but it looked familiar...I could read the street signs n Cyrillic. Russian words kept popping out of my mouth. I pointed out where ancient churches along the river had been torn down. Then I recognized Taganskaya Square. I heard the clicking sound of a wheel and a remembered voice said “You’ve made it! Good work.” I asked my KGB host “Are there tunnels under here?” “Of course, we have bomb shelters for hundreds of kilometers....”

**On Hope.** From Fiona Barnett, *Eyes Wide Open* (2021) p 155:

“I hear of people giving up hope because they don’t want to live in the emerging social structure in which people are subjected to the same torturous conditions I experienced as a child at the hands of military mind controllers: **isolation**, deprivation, confusing and contradicting instruction, **loss of identity** and culture, discrimination, shock and trauma, excessive scrutiny, **humiliation, and reduced self-worth.** [Emphasis added]

“To such fragile folk, I implore: Humanity has been promised that we will never be tested beyond what we can endure. What you experience now, I have endured my entire life. I say with confidence that even in these dark times there is indeed Hope.”

**On Love Bonds.** From Wendy Hoffman's *White Witch in a Black Robe: ... about Criminal Mind Control* (2016) pp 41-42: [Note: Those who run MK-Ultra are experts at giving a child love so they can manipulate this later. Wendy Hoffman speaks of her friend Daniel, who was ritually sacrificed at age 13. He had been her only way to experience the love of a caring soul]:

“Even though the criminals made us get rid of body parts together, the year I spent with Daniel (he 12, me 3) became the year of my connection, the year of learning about love. Take me as a child who know only about torture and betrayal, take a depleted, harmless 3-year-old and add the heartbeat and genuineness of a grieving boy.... I imagine they calculated that this grief and anger would motivate my murdering people. [Such a goal!] But the pressure of his heartbeat never left me.”

“I thought I walked alone... but at times ... when in the deepest despair or an assignment overseas or in the black chair that administered electric shock ... or while walking in luscious, invigorating nature, I would, out of the blue, feel a curtain fall over my face ... covering me with an adoring kind of caress... My eyes well up with tears. Then he never left me. Daniel said he would be with me always. 68 years later I still feel his heart giving birth to mine and turning me into a human being.”

**Sexual Addiction.** Anastasia Sprout spoke out, in her 2015 book *Naked in Public*, about sexual addictions, but she did not discover until later that a person can be mind-controlled into it. She also verifies tunnels: “Driven to Paine Field by the Everett WA Boeing Plant to an elevator, to a tunnel far, far below ground. With two men, I boarded a maglev train to the *Las Vegas underground*. This place was a massive Death-Cult nest that I believe remains in criminal use there to this day, most likely even more depraved than what I suffered 1987.” [Ahem]

**On Recontact Programming.** From *Svali Speaks*, by the marvelous Svali, a former cult programmer, at [omnia-veritas.com](http://omnia-veritas.com):

“All Illuminati members have recontact programming. It is never left to chance. The group has put in years of effort into training them. They may be given false screen memories. Hang up calls, three or six in a row, or calls where a series of tones are heard, may fire off internal programming to make the person come back to the cult. Birthday or we-miss-you cards may be sent.” [At one point, the Quigleys said “We miss you. We love you” and sent me \$5000 to travel back to them – JK.]

**Multi-generational Incest.** Note: It’s not always CIA. There are families who have been doing “intergenerational incest” and/or satanic ritual abuse for centuries. Wendy Hoffman connects her torture in New York to Josef Mengele of Nazi fame, (yes) but her grandfather was a pro at it. Fiona Barnett says some Slavic immigrants brought sadism to Sydney after 1945.

**Exhibits.** Please read Part Four at end of this book: Gunther Russbacher shows how they can wipe an old personality and insert, or “overlay” a new one. [This did not happen to me. ## Chapter 12. Builder, Lumberjack, Cleaner, Trucker, CIA

Let's face it – it's not every child of a head of state who gets to sweep gutters, fill potholes, fiddle around under the hood, and make jewelry. Or deliver parcels in most of the 50 states. And few would have a Hell's Angel's patch, or be as tatoo'd as I am. And this head-of-state's kid has no high school diploma, OK?

The guy named Wayne was always in the background, I guess, which must mean that he designed the many set-ups I encountered of getting fired from one job after another. **Restaurants.** This is a nice part. At least there was some food around. I was always hungry. 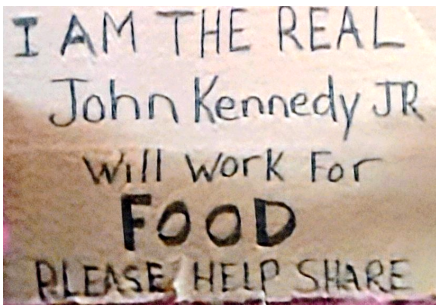

## Chapter 13. Suddenly a Breakthrough on My Plane Crash!

Recall the plane crash which I survived by great luck? In Chapter 7 above, Mary Maxwell interviews me about it. I had only made her acquaintance the previous day and it was *ad hoc*, unrehearsed, in the parking lot of a truck stop in Kingman AZ. You can see it on YouTube (9 minutes). The crash occurred on July 16, 1999 around 10pm, close to Martha's Vineyard airport.

Neither Mary nor I knew there was any “conspiracy theory” on this topic. Recently, however, when Mary was searching for an article on cancer by Ty Bollinger, she found that his 2013 book, *Monumental Myths*, contained a chapter on my crash. Great!

Mary gleaned these items from the Bollinger book:

1. Several witnesses, including a reporter from *Vineyard Gazette*, reported seeing a “**big white flash in the sky,**” like an explosion, around the time of the crash.
2. The pilot JFK, Jr (whom I dub ‘George’) had phoned in to Martha's Vineyard **air traffic control** at 9:59pm, to announce he was about to land, just before starting to descend.
3. Supposedly there is a rule that if a pilot making such an announcement fails to show up at the airport, **a search is automatically begun within 5 minutes**, but the Kennedy search did not begin for 15 hours – around 3pm the next day. Hello?

Quoting Ty Bollinger, on page 194 of his *Monumental Myths*:

“Why didn’t they want to search immediately? I’ll tell you why. They needed time to find the plane and **remove the battery from the cockpit voice recorder, remove the Flight Log that listed all passengers, and remove the body of anyone else that was on that plane but wasn’t supposed to be on that plane.**” [Emphasis added]

Of course Bollinger, writing in 2013, did not know about the Replacement. (The real JFK – me -- was in hiding from at least 1970 till around 2019.) **Bollinger deduced that the missing person listed on the Flight Log was a Certified Flight Instructor.** Technically, George was not qualified to fly “instruments only” (in poor visibility) unless he had a CFI on board.

The lack of a CFI gave rise to the Legacy narrative that George was an incompetent pilot, so accidentally caused his own death, plus the death of his wife Carolyn Bessette her sister Lauren. The NTSB (of 9/11 fame) attributed the crash to **pilot error.**

4. Bollinger reports that “Carol Ratowell, a Kennedy family friend, phoned the Coast Guard at 2:15am and **said that there was a CFI** on board.” (Woo-oo-oo.)

(Note: Ratowell is probably a misspelling of Radziwill. Carol had married the son of Jackie’s sister, Princess Lee Radziwill. Sadly, that son died of cancer, a few weeks after the crash.) I presume there was **no CFI** on board, and that the ‘secret’ fourth person is ... drumroll ... myself.

5. Bollinger reports that the “extra” body was never found, and that **one of the seats of the aircraft was missing.**

6. Another juicy bit is about **helicopters.** Thank God it has an official’s name:

“Lt Col Richard Stanley of the Civil Air Patrol had initiated a search for the missing plane on dry land by 7:30am and advised the news media at that time (hours before the official focused search and discovery) that he had seen helicopter searchers circling the area. But that the Coast Guard said the helicopters weren’t theirs.” P 194-195.

I hope the reader feels a Freedom of Information Act request coming on. For instance, the official report said that Ms Lauren Bessette’s body was found still strapped to the seat, but I feel pretty sure she swam a bit with me. Are there any photos?

Now here’s a 7<sup>th</sup> item, which did not come from Bollinger’s book. Rather, it is simply a fact, *viz.*, the body of “JFK, Jr” was cremated, and **his ashes were quickly scattered** in the ocean, from a Navy ship. As *The Cape Cod Times* put it:

“The ceremony, held the morning after the bodies were brought up from the ocean floor, provided a quick ending to the six-day national vigil that began when Kennedy’s plane vanished.”

Hmm. My baby brother Patrick Bouvier Kennedy (who reportedly died in 1963 at the age of 2 days) is interred with our father at Arlington National Cemetery.

Note: Bollinger credits two sources for much of his plane-crash information: Christopher Condon’s article “What Actually Happened to John F Kennedy, Jr?” and a DVD by John Hankey, “The Assassination of John F Kennedy, Jr.”

Mary doesn’t intend to investigate this, as she regrets having spent years trying to inform people about the lies such as the Boston Marathon ‘bombing’ and the Sandy Hook hoax. If, by now, US citizens can’t see that blatant lying is standard for government and for media, they deserve to be filled with nonsense.

**Jacqueline Kennedy Onassis**, b 1929, was the child of **Janet Norton Lee** (1907-1989) and **John ‘Blackjack’ Bouvier** (1891-1957), a banker, whom I never met. His ancestors lived in France as described in John Davis’ book *The Bouviers*. They had one other child – my aunt Caroline **Lee** Bouvier born in 1933.

The story of Jackie/Lee jealousy may be untrue. Lee married **Stanislaus Radziwill** (1914-1976), a Polish prince, making her a princess. They had two children, **Anthony** (1959-1999) and **Anna Christina** (b 1960). Stan’s son by a previous marriage, John, married a daughter of Greek shipowner Yiannis Carras. Lee and Stan were my godparents. Anna is my cousin. *I suspect Aunt Lee died in 1975, and it was her Replacement that died in 2019.*

Janet’s sister, Mary Lee, married a Vanderbilt. My grandmother Janet married Hugh Auchincloss, an heir to Standard Oil, in 1942 when Jackie was 11 and Lee 7; they lived in RI (photo above) and the Hamptons. Hugh’s nephew Jake Auchincloss, born 1988, was elected to Congress from Massachusetts, 2021. I know little of my ancestors via Janet, nor any Fitzgeralds.

**Two Generations of Joseph and Rose Kennedy Offspring:** Rose and Joe had 9 children. **Joe Jr** died in WWII. **Kathleen**

died in a plane crash. **Rosemary** was disabled by a lobotomy. Three of Rose's daughters married and had these children:

**Patricia Lawford:** Christopher, Sydney, Victoria, Robin

**Eunice Shriver:** Robert, Timothy, Mark, Anthony, Maria

**Jean Smith:** Steven, William; adopted Amanda, adopted Kim.

Three sons were senators, of which one attained White House:

**John:** Caroline, John Jr, Patrick

**Robert:** Kathleen, Joseph P, II, Robert, Jr, David, Mary, Michael, Kerry, Christopher, Matthew, Douglas, Rory

**Ted:** Kara, Ted, Jr, Patrick II [*I suspect Sen Ted was a Replacement*]

(Of the 27 children above, Caroline disappeared, David died of overdose, Michael died in a ski accident, Kara died of cancer, Patrick died 2 days old, Christopher Lawford passed in 2018.)

**These became officials in politics, or wives thereof:**

Kathleen Kennedy Townsend was Lt Gov of Maryland.

Joseph was US Rep from Massachusetts.

Patrick was US Rep from Rhode Island.

Robert F Kennedy, Jr is current US Secretary of DHHS.

Kerry Kennedy was married to Mario Cuomo, who later became governor of New York. Maria Shriver married Arnold Schwarzenegger, becoming First Lady of California [*I think Maria Shriver may be a Replacement. She could get a DNA test to prove otherwise. Replacements are much more common than you'd think.*]

Any cousins wanting to talk to me, I am all ears. And earlobes.

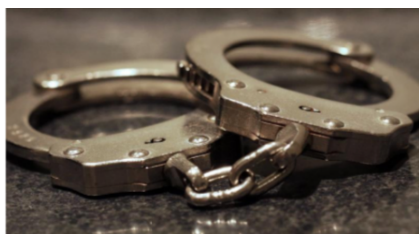

## Chapter 16. What Crimes Have Been Committed?

Now this book switches away from Part I, John's explanation of his life, to Part II where we look at legal remedies. It is an old maxim of law that "*Lex semper dabit remedium.*" – "The law will always furnish a remedy."

*Note:* This Part will not deal with crimes associated with JFK's 1963 assassination, as such; that is to be handled in Part Three. In order to find some remedies for John, we should first look to see which crimes have been committed against him, and by whom. Certain crimes are exclusively federal – they are found in Congressional legislation – a clear example is counterfeiting.

Other crimes come from state laws or were identified in old court cases, known as the common law. Some crimes, such as murder, could be from common law, or from an enactment by a state or by Congress. There are also statutes of limitations that determine if it's too late to adjudicate the matter. Three years is typical, but treason and murder have no time limits. For a person to be guilty of a crime, three things need to be proven: that the crime actually occurred, that the accused person had the intention of doing it, and that we have evidence.

We will first look at crimes committed against John, and then at crimes against others if he identified such in Part I. For example, he said Jackie was murdered. I will take him at his word. Sure, due process would have to come in, in a real prosecution, but we are talking about ideas here, for now.

### **Ten Crimes against John** (Chapter number square bracketed)

1. He was kidnapped at an early age. [2]
2. He was tortured under MK-Ultra. [10]
3. His identity was stolen. [3 and 11]
4. He was provided with a fraudulent birth certificate. [7]
5. He was worryingly warned that he'd be un-alived. [2]
6. He was forcibly sterilized. [9]
7. For years government forced him to do unpaid work. [12]
8. Someone baby-swapped his legal (not biological) son. [9]
9. Someone extorted money from him, for his son's rescue. [9]
10. Someone attempted to kill him by plane crash. [6 and 13]

I won't hold forth on any crime, here in Part II, if John hasn't mentioned it in Part I of this book, *The Historian's Tale*. For your information, in his other book, *Stolen Identity*, and in Sue Greenwald's book *Quest for Justice*, John reveals some additional, very gory things.

These include being raped, being kicked unconscious, being locked in a cage, being told to cut the ears off of dead soldiers, and being ordered to sign that he had killed his sister. In an interview, on YouTube, John told me that he was forced to drive a nail into wood by using his forehead as the hammer.

Now to prove that the ten crimes above are punishable, I will quote a relevant law. Do not attempt to use it until you check further – I'm just trying to demonstrate that a crime is a crime and therefore will be punishable by the relevant authority.

**#1.** California Penal code Chapter 3. Kidnapping [207 - 210]

207. (a) Every person who forcibly, or by any other means of instilling fear, steals or takes, or holds, detains, or arrests any person in this state, and carries the person into another country, state, or county, or into another part of the same county, is guilty of kidnapping.

(b) Every person, who ... hires, persuades, entices, decoys, or seduces by false promises, misrepresentations, or the like, any child under the age of 14 years to go ... is guilty of kidnapping.

**#2 and 5.** 18 USC [United States Code] 2340 (2)“severe mental pain or suffering” means the prolonged mental harm caused by or resulting from— (A) the intentional infliction or threatened infliction of severe physical pain or suffering;

(B) the administration or application, or threatened administration or application, of mind-altering substances or other procedures calculated to disrupt profoundly the senses or the personality; (C) the threat of imminent death; or... [Etc.]

**#3.** 18 USC 1028: (a)Whoever, in a circumstance described in subsection (c) of this section (1)knowingly and without lawful authority produces an identification document, authentication feature, or a false identification document; (2)knowingly transfers an identification document, authentication feature, or a false identification document knowing that such document or feature was stolen or produced without lawful authority;...

(b)The punishment for an offense under subsection (a) ... is (1) except as provided in paragraphs (3) and (4), a fine under this title or imprisonment for not more than 15 years, or both

**#4.** California Code, Penal Code – PEN sec 484

(a) Every person who shall feloniously steal, take, carry, lead, or drive away the personal property of another, or who shall fraudulently appropriate property which has been entrusted to him or her, or who shall knowingly and designedly, by any false or fraudulent representation or pretense, defraud any other person of money, labor or real or personal property,

**#6.** New Jersey Revised Statutes § 10:7-2 affirms that every individual in the state has a fundamental right to make personal decisions about their reproductive health. [Sterilization is not criminal as such. However the circumstances of how it was done to John involved assault and battery, etc.]

**#7.** 18 USC 1592: Slave-holding: Whoever confiscates the passport or identification ...to attempt to restrict that person's liberty to maintain their labor" [may be punished up to 5 years.]

**#8.** Vermont 33 V.S.A. sec 5102). Definitions and provisions. (3) "Child in need of care or supervision (CHINS)" means a child who: (A) Has been abandoned or abused by the child's parent, guardian, or custodian. A person is considered to have abandoned a child if the person is unwilling to have physical custody of the child; unable... [This is not about criminal law; it is a definition for purpose of state obligation to furnish care.]

**#9.** (a) Whoever transmits in interstate ... commerce any communication containing any demand or request for a ransom or reward for the release of any kidnapped person, shall be fined under this title or imprisoned not more than 20 years, or both.

**#10.** Massachusetts jury instructions on homicide: The Commonwealth alleges that the defendant committed murder in the first degree on the following theories: [list theories: murder with deliberate premeditation, murder with extreme atrocity or cruelty, and/or murder in the commission or attempted commission of a felony punishable by a maximum sentence of life.] ...You should check the box on the verdict slip as to *each* theory on which you agree...If you are unable to agree unanimously [on] murder in the first degree, you shall consider whether the state has proved the defendant guilty beyond a reasonable doubt of murder in the second degree.

See? It helps to quote the law to remind us that all is not lost. Punishing lawbreakers is standard behavior in human societies.

## Chapter 17. Johnny Comes Marching Home -- A Letter

Some sort of remedy is called for. Historically, the most highly developed remedy is law. To date, the cabal has been able to circumvent that, for example, by killing witnesses or buying judges. But that method is fraying at the edges. It can't possibly survive.

I recommend you do this as individuals, not as a group. Normally, you've run to the group for everything, and I grant that yours is a *marvelously* coordinated group. But your wishes and that group's wishes are not the same thing! You are a person and you want your own life.

Luckily you have the brainwork of a very special friend, Wendy Hoffman. She did what she needed to do to find her long-lost Self, even though she was near 70 when she began. Neil Brick has published her scheme at his website. I'll quote it briefly, but you should read the whole essay, entitled "After Amnesia."

"The perpetrators taught that the **natural force within me** turns into murder, that I had to suppress what earnestly comes out of me so as not to destroy. When controllers try to remove love, they try to leave their subjects with hate-filled souls. They feel they can create the kind of souls they want. Can any human distort another's soul? Who you are deep inside, in the well of your soul, does not seem moldable. [Yoo-hoo, the real you is you since birth.]

"Part of the new emerging self is grieving what happened to the old you, and what those inside parts had to do. Love yourself during the grief. Work on consoling yourself. If you choose to go through or continue with recovery from mind control and if you keep knowing the truth is your goal—then one day a new you will emerge from the ruins of your past." End quote.

Now, now, doesn't that beat having to face suffering retribution from those you have hurt? And who knows better than you perps what's on the 'discipline' list -- starvation, rape, electroshock, a kitchen table vasectomy, getting skinned alive, etc.

### Justice for Jacqueline – A Wrongful Death Lawsuit

Jury Trial Demanded [Filed March 11, 2025. Fee \$352 paid]

I. Introduction. After Aristotle Onassis died in 1975, his widow “Jackie,” was shot dead. Her 14-year-old son, the Plaintiff, heard shots and saw her in a pool of blood. A ‘new Jackie,’ who resembled her, took over the deceased’s public role until that new Jackie died in 1994.

II. Jurisdiction. This court has jurisdiction based on the location of the murder, Bullhead City, and is Plaintiff’s residence.

III. The Parties. Plaintiff is the true son of Jacqueline Bouvier Kennedy, born to her and President-elect Kennedy on November 25, 1960. His true name, John F Kennedy, Jr, was taken from him when he was placed with the Quigley family some time before 1970. The Defendants, John Doe’s, are unknown, but likely include the local Mafia, Secret Service, and FBI. Bullhead City cops probably did not record Jackie’s 1975 death.

IV. Statute of Limitations. Plaintiff asks the Court of Law, or of Equity, to permit this filing for wrongful death 50 years later. Plaintiff went to FBI in AZ but they dismissed him. Only in recent years when he published a book and found acceptance via social media, has he imagined that justice may be available.

V. Injury and Loss. Plaintiff has suffered greatly from the loss of his mother. He missed out on her love, guidance, and protection. As this was his fourth big loss to murder after father

in 1963, beloved uncle in 1968, and helpful step-brother (Alexander Onassis) in 1973, Plaintiff was in continuous fear of being killed himself. He also lost what would have likely been a prestigious career, doing only manual-labor instead. In the MK-Ultra program impoverishment was de rigeur.

VI. Requested Remedy. This is a wrongful death suit. Besides monetary damages, Plaintiff asks the court for declaratory relief by referring to the proper branch of government the entire matter of how his famous mother was killed and how knowledge of such an event could be totally suppressed.

VII. Additional Plaintiffs. If Plaintiff's siblings Caroline Bouvier Kennedy and Patrick Bouvier Kennedy should be found alive (now age 67 and 61 respectively) they should join this suit. Additional Defendants: All those who covered up the facts are indictable and the court may refer such for prosecution.

VIII. These pleadings are submitted by Plaintiff in good faith and with the hope that his amazing handicap – the theft of his identity – will not be used to dismiss him. Plaintiff is the boy held by Jackie Kennedy in this 1962 photo from RNN Media:

(d) Whoever violates this section shall be fined under this title, imprisoned not more than 20 years, or both. If death results ... the defendant shall be fined under this title, imprisoned for any term of years or life, or both."

Can we get together to discuss a request, by me, for back pay? I did much slavery for the CIA. Many others are asking for same. Please excuse my handwriting. I didn't get to finish high school.

## Chapter 21. Can the Law of Inheritance Help John?

Before becoming president, John F Kennedy, in 1954, wrote out a will, leaving his wealth to two trusts. The beneficiary of The First trust is Jackie, whom he had married in 1953. The Second Trust is for his children, although none were yet born. Kennedy named three executors, instructing that a majority vote would prevail if they disagreed. Those three were his wife Jackie, his brother Robert, and his brother Ted. And if somehow those were not available to serve, JFK named his three sisters: Jean Smith, Eunice Shriver, and Pat Lawford.

### **The Carrying Out of a Will, under Massachusetts Law**

In Massachusetts, if the testator names one or more executors, as Kennedy did, those executors hold legal authority. I don't know how many executors have served until now. All six that JFK named are deceased. New executors were named -- probably by the signature of then-existing executors. (I am guessing that the last was Eunice. She died in 2009.)

In 1986, Caroline Kennedy married Edwin Schlossberg and they have three children, Jack, Rose, and Tatiana. At some point, Edwin became an executor of Kennedy's will. At least as recently as November 2024, according to a case filed by a man claiming to be the son of Marilyn Monroe and JFK, the court listed the two current executors as: Edwin A Schlossberg and Martin L Edelman. The attorneys for the trustees are at the New York City law firm Shulte Roth and Zabel LLP (NY). However, the jurisdiction over the trust is Massachusetts.

### **Can John Approach the Court Now?**

Private wills and trusts don't have to be probated by a court -- that is mainly for intestacy (no written will) cases. However, contending beneficiaries can seek justice, for instance if there is fraud. Also, executors can be sued for mismanagement -- they are under fiduciary duty to work for both the estate and the beneficiaries. Massachusetts General Law, known as MGL,

requires that the executors notify all heirs. John says he was not notified. The law says that if an executor is unable to locate one or more of the heirs, he must diligently try various means. For example, under MGL Chapter 190B, the efforts may include: “Searching public records (e.g., voter registration, property records). Contacting known relatives or associates of the heir. Using online databases or social media. Hiring a professional heir-search firm... Publishing notices in local newspapers...”

**Fraud.** That statute is probably irrelevant, as John was not considered ‘missing.’ But the MGL covering the crime of fraud says, in Chapter 151A, section 47: “Each false or misleading statement, representation, or submission and each failure to disclose or **concealment** shall constitute a separate offense.” Superior Court Civil Instructions Misrepresentation says: “A party may also be liable for fraud by knowingly concealing or omitting material information in violation of a duty to disclose it.” The MGL requires an estate to be probated within 3 years of the decedent’s death. However, it says that this deadline does not apply in cases of fraud or exceptional circumstances.

The Kennedy Trust still has funds, as, over the sixty years, the principal was not handed out. Rather, per Kennedy’s instructions, each year the beneficiaries get the income from trust investments. It appears that the real John F Kennedy can now ask the trustees to include him as a beneficiary. Why ever not?

In general, our wonderful law can sort out John’s rights.

Did Callas ever hug George? Did he know that she was (if I’m right) his mother? It’s very telling about human nature (I mean about our stupidity) that the public adored the dapper “future president,” George, without knowing anything as to his upbringing. Meanwhile, the proper heir feels royally pissed off.

*Note:* I have the feeling that planting an outlier in another family is standard office procedure for Illuminati. It could mean that we are ruled by them while they wear another identity. Bill Clinton appears to be the son of Gov Winthrop Rockefeller. Obama’s grandmother Payne was, I think, from Henry B Payne of Ohio who likely was an outlying Rockefeller. If so, everybody is covering up for each other. John says he was always told Jimmy Carter is a Kennedy. Justin Trudeau, Canadian prime minister, was sired by Castro. Barbara Bush was sired by Alistaire Crowley. The current Putin is not the 1990s Putin.

The reappearance of the real John *proves* how a few people “in authority” can foist a false story on us. We are unhealthily glib. I recommend we *train up* to reject a falsity the minute we hear one. You can really defend against attacks by putting your foot down and insisting on truth. Your listeners’ brain will react to it, too. And your neighbors may consider *imitating* you!

Far be it from me to say everybody must become honest. We will never be honest; humans are sneaky little buggers. But we can draw a line somewhere. When powerful people lie, and their lying enables their takeover of our society, we shouldn't be so dumb as to just sit there and take it.

The Banality of Evil. Now for a related matter. We can see that we practice 'doublethink.' This is partly because the division of labor allows various occupations to formulate justifications for their daily routine. Consider what the man on trial for the Holocaust, Adolph Eichmann, claimed in 1960:

“You say illegal. Today I have a very different view of things.... But if anyone had asked me about it up until May 8, 1945, the end of the war, I'd have said: This government was elected by a majority of the German people... every civilized country on earth had its diplomatic mission [to us]. Who is a little man like me to trouble his head about it? I get orders from my superior and I look neither right nor left. That's not my job. My job is to obey and comply.” [Emphasis added]

Sure, that's the old “I have to obey” routine. We all seem to be obeying our masters today, and we even pretend they're nice. Eichmann argued that since the German government was legitimate, its policies can't be evil. Ah, that's so familiar! And it's why conspiracy theorists are rejected. (See my 1991 book *Morality among Nations* for the biology of this.) Attending Eichmann's trial, Hannah Arendt noticed “the banality of evil.”

Has moral autonomy ceased to exist? There was a time, in our pre-history (i.e., tribes with no writing) when a society had, say, a hundred members. “Morality” could be policed by everyone against everyone. If A did not keep the promise he made to B, B could get back at him. Population later increased and at this time the major religions of the world emerged. Robert Sapolsky, in his 2018 book *Behave: The Biology of Humans at Our Best and Worst*, says we had to ask a god to do the policing as we could not see each other. But even that is lost now, says Lionel Tiger in *The Manufacture of Evil*. There isn't a well-shared

national religion. So one does not get praised for being virtuous. And not the ‘free-rider’ problem -- we can tolerate a few individuals jumping the turnstile while we pay our fare, but we lose motive to pay if too many do it. Today, a majority are free riders. People have lost the sense of social obligation.

Meanwhile, as with Lahaina’s fire, our leaders boldly deny the wrongdoing that they are clearly doing. During the Covid pandemic, virtually every person in a position of authority transmogrified what they were doing into something helpful.

So, I’ve suggested here that we employ our larynx when we hear a public lie. And we should generally reject the culture of deception. Elderly Americans can remember when it was not like this. Most people behaved honorably; you were expected to do so. Integrity itself was a beautiful thing, one of life’s joys.

This may be because truth is well-connected to justice. Conversely, bad people try to get out of blame and punishment by lying about their real deeds. Government is endlessly putting a new spin on facts. I disapprove of the words of the Marine Hymn: “First to fight for right and freedom, and to keep our honor clean.” That’s *not* why we fight. As General Smedley Butler famously said, “We fight to help the banks.” The lies in that song diminish the real patriotism of courageous Marines. The solution is not to alter the song but to correct the facts on the ground: our military should cease working for banks!

*Note:* I sent a copy of this book, *The Historian’s Tale*, to Navy veteran Ron Kukal in Wyoming, who is known for his heroism aboard the *USS Liberty*. He phoned to tell me that when he opened the package that had this book in it, and saw the cover, he was so startled he dropped the book on the floor. (He gives me permission to relate this to you.) Kukal said he had always felt, at an emotional level, a connection between the 1967 *USS Liberty* incident and the 1963 JFK assassination – namely because both were so intent on hiding the truth.

## Chapter 25. When Does Secrecy Betray the Nation?

In 1967 Israel planned to do nuke war on Egypt. Or was it really the US's plan? Israel was supposed to sink a spy ship, our *USS Liberty*. The attack plane would be false-flagged as Egypt, to justify nuking Egypt. (I am guessing it's because Nasser was becoming a Third World leader.) To sink the ship, its crew – our boys – were *napalmed*.

A call for help was sent and nearby US aircraft duly went aloft, but they were soon called back, on the order of President LB Johnson. No one has been punished, nor have the heroes been thanked. When an investigation was held, the men were forbidden to tell the truth.

On page 100 of Nelson's *Remember the Liberty*, Ernie Gallo reports that many sailors were transferred "so we could not reminisce together over forbidden secrets." On page 71 of that book, Phillip Tourney wrote: "But as angry as I was at the time, it was nothing compared to the anger I felt later, when I learned the terrible truth that we were betrayed not only by Israel, but by the highest levels of our government."

On page 98, Ronald Kukal wrote that as senior enlisted man (age 27) it was his job to go below and pick up the dead. "The White House lawyers had removed all written testimony provided by the 165 crewmen." "Working in the midst of this was tiring. The smell cannot be described by me as I never smelled a thing. 25 men with some of them slipping out the torpedo hole. We gathered the unknown parts into a body bag and called it the six men we didn't find. They're buried at Arlington."

Tourney, who now heads an Association to tell peeps about the *Liberty*, says on page 95: "Admiral Kidd warned the men to NEVER say ANY THING to ANYONE else, especially the MEDIA or we would end up in PRISON or WORSE...." (On some false charge, of course.) "Admiral Kidd's face turned into a twisted mask of hatred. I know in my heart that he hated the fact that we were still alive and breathing. That was not the plan. I was looking into the eyes of the devil himself."



I [MM] think the *Liberty* incident fits the Constitution's definition of treason. Kidd and LBJ "levied war" on us.

JFK, Jr knows a lot about feeling betrayed -- as no doubt Dad did, too.

## Chapter 26. “Where Were You That Day?”

JFK’s murder was never accounted for. It is still an open case today. Is there anyone who can file a wrongful death suit? That’s a civil lawsuit, not a prosecution. JFK’s surviving son is willing to file such a suit. Probably Jacqueline would not have been able to file, from 1963 till the day she was murdered in 1975, owing to her great and justified fear of “Them.”

JFK was not the only victim that day. Gov Connolly was wounded by the same gunmen. Officer Tippit died from gunshot. Two days later Ruby killed Oswald. Those persons have family members that could file a civil action for their wrongful deaths. Many who tried to blow the whistle, got killed. But there were many fake ‘investigators.’ It may include congresspersons, and members of the incoming Johnson team.

Barr McClellan, who was a law school student on the day of the assassination, later worked intimately in President Johnson’s office. He says on page 279 of his *Blood, Money, and Power*, (2001) that **LBJ confessed his guilt to his psychiatrist**. LBJ then told his friend Don Thomas about the confession, and Thomas explicitly told this to McClellan. Very likely McClellan, age 84, would want to give testimony about it. He has poignantly stated (on page 273):

“And we will bring an end, a sunset, to the darkness planted on our history by Lyndon Johnson.”

No doubt others are eager to come forward with information, to a court or a grand jury, or if necessary to a Citizen-led Truth Commission. John Jr is willing to give his endorsement to such a commission. Ethically, he can't run that commission as he is not a neutral party, he's an aggrieved party. But you can do it.

Consider this. President Kennedy, in his speech to the Press Association about the existence of a monolith, said:

“... It is a system which has conscripted vast human and material resources into the **building of a tightly knit, highly efficient machine** that combines military, diplomatic, intelligence, economic, scientific and political operations.”

“Ask what you can do for your country.”

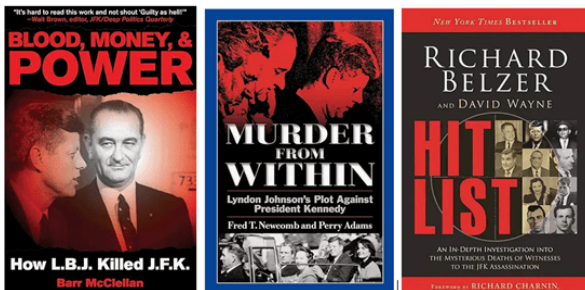
## Chapter 27. 'Rep Moona' Gathers Six JFK Researchers

It gave me a fantasy of probing more deeply. So I conjured up another congresswoman – “Rep Moona” (me) – who would invite eight ‘dissident’ authors to speak, *viz.*, Barr McClellan, Fred Newcomb, Richard Belzer, Laurent Guyénot, Greg Poulgrain, and the late John Coleman

I now present their (fictional) testimony, in three sections. *Note:* I have put words into their mouth – words from their own books, slightly paraphrased. You are asked (begged) to read the whole thing, a picture of humanity’s fall after 1963.

### SECTION ONE — McClellan, Newcomb, and Belzer



**Rep Moona:** Hello, Mr Barr Oliver McClellan, I have read your book “Blood, Money, & Power” (2011). You were “3

down from the top” in Texas politics in your later career, though only a law student in November 1963. Is that correct?

**Mr Barr McClellan:** Yes, at a major law firm I answered to Don Thomas, who answered to Ed Clark, who was LBJ’s lawyer. (From p 23): I found myself partner with the man who had killed Kennedy. Namely, Johnson. My admiration for Kennedy and his ideas was buried under the ethical prohibitions of the attorney-client privilege. Granted, there was also a visceral pleasure: I was part of an organization more powerful than the law itself. We simply subverted justice.

**Rep Moona:** What do you say about the assassination today?

**Mr Barr McClellan:** (p24) I say Justice has yet to be done.

**Moona:** Please give us more about what happened.

**McClellan:** There was social pressure on Ed Clark. He had to keep the oilmen happy, as Kennedy had had the colossal gall to lower their favorite tax deduction, the oil depletion allowance, to 15%. So they wanted Kennedy out before he reduced 15% to zero. There was behind-the-scenes pressure on LBJ, stemming from a murder committed by Mac Wallace at Johnson’s behest. That case could break open at any time; Lyndon was scared. Finally, my trusted friend Don Thomas told me that LBJ, near the end of his life, confessed to his psychiatrist that he was the guilty party.

**Moona:** You don’t mean he wielded the gun?

**McClellan:** No, he actually got Mac Wallace and an un-named man to do it. I have the professional forensic evidence of Mac Wallace’s fingerprint on a box in the 6<sup>th</sup> floor of the Texas School Book Depository. \*\*\*.

**Rep Moona:** Good morning, Tyler Newcomb. I see that you are here to speak up for your deceased father, Fred Newcomb, and his co-researcher Perry Adams.

**Mr Tyler Newcomb:** Yes. Dad started to do the research in 1966 after he read Edward Epstein's book, "Inquest." He gave it his all until 1974. But instead of publishing it, he shared it only with members of government. Finally, in 2011 before he died, I and Perry's widow Valerie, got it published and he was pleased. It is called "Murder from Within."

**Moona:** What does that book's title mean?

**Newcomb:** Two things. First that it was an inside job, that the government — especially the Secret Service — did it. Second, that we needn't look for shooters on the Grassy Knoll or in a drain, as the shots came from "within" the car. The limo driver, William Greer, did it, perhaps with a new-tech gun. He held his right hand on the steering wheel, but turned and used his left hand to shoot, as he swiveled around. Gov Connolly was in his way, so he shot Connolly in the chest. If Fred and I are correct, both Jackie and the president must have seen Greer shoot.

**Moona:** Why do we not see this on the Zapruder film?

**Newcomb:** It *was* on that film. But that film spent the week-end Nov 24-25 in a special lab where Secret Services doctored it. Dad was an expert in photography and graphics. This is how he was able to figure out how many frames of the film were missing. Dad also had access to the photos taken by Altgens.

**Moona:** I am familiar with eye witnesses and ear witnesses, but Perry came up with "nose witnesses." Please explain.

**Newcomb:** Many people reported, on the day of the shooting, that they got a strong smell of gunshot. Those people were behind the president's car. This supports the idea of the bullets moving from the front to the back of the car. Dad also thought that a person in one of the follow-up cars fired a shot as a decoy, near the Depository building. Some people in that area smelled gunsmoke. But there was no smell up on the 6<sup>th</sup> floor.

**Moona:** I see that the book *Murder from Within* is astonishingly detailed in its documentation, such as explaining whenever the your work differs from the Warren Commission report.

**Newcomb:** Yes, Dad spent a fortune to buy all 26 volumes of the Warren Report. On page 80 he notes drily that the Warren Commission deleted Mrs Kennedy's reference to wounds:

“The General Counsel for the Commission, in a letter of December 10, 1964, explained the removal [of Mrs Kennedy's words] “as a matter of good taste and because it could contribute nothing to the Inquiry.” [That is also in John D Weaver's book “Warren: The Man, the Court, the Era.”]

**Moona:** I see that your father also went to some trouble to find out what happened at Bethesda Hospital re thee autopsy.

**Newcomb:** Chapter 5 is all about Parkland Hospital and Chapter 6 covers what happened at Bethesda. I can summarize. Assuming the plotters had well-rehearsed the entire plan, the president was to have been shot dead and Gov Connolly was not to have been wounded. The limousine was to speed on to Love Field, never stopping at a Texas Hospital.

But Connolly needed treatment. Also we now know that Kennedy did not die until 1pm in Parkland. He still had a pulse on arrival. Kennedy's time in Parkland is all anyone needs to know as to government chicanery. The doctors there all concluded that the bullet entered from the front and blew out much of his brain. Yet no word from any Parkland doctor got included in the Warren Commission Report. The false story of a bullet from the back was to be maintained at any price.

Dr Rose, Texas's medical examiner, forbade the Secret Service to take the body out of Texas as it was a homicide. Quoting page 130 of “Murder from Within,”

“In 1963, the murder of a president was not covered by federal law. If a federal agent, however, was killed, the federal authorities could intervene. Such an agent was **fictitiously** slain ... At 1:23 p.m., Walter Cronkite announced on CBS, ‘A Secret Service man was also killed in the fusillade of shots.’ At 3:33 p.m., a denial was issued in Washington DC. By that time, the ploy had served its purpose.”

**Moona:** And Bethesda Hospital? **Newcomb:** I’ll make the long story short: Since the set-up of the scapegoat was already taken care of, it had to be pronounced from autopsy doctors that Kennedy had been shot from the back, by a bullet from the Book Depository. The doctors massively interfered with his body to hide the real wounds and create false ones. \*\*\*

**Rep Moona:** Greetings, Mr Richard Belzer. I am aware that you and David Wayne compiled a list of suspicious deaths of people who “knew too much” about Kennedy’s murder.

**Mr Richard Belzer:** Yes, it is called “Hit List” (2013). It became a best seller. many citizens became aware of the suspicious deaths of, say, Dorothy Kilgallen, George de Mohrenschildt, and Johnny Roselli. **Moona:** Is it fair to say that your book proves that each of the 50 victims had some connection to the JFK assassination?

**Belzer:** No, no. We named 50 people who are possible victims, but then we identified those for whom death-by-natural-causes can reasonably be argued. There were some deaths that occurred just before the person was scheduled to give testimony (e.g., George de Mohrenschildt) to Congress — or to the court in New Orleans where Jim Garrison was conducting a trial. If so, we deemed it “NOT a coincidence.”

Similarly, if police declared the death a suicide, but friends who knew him had recently seen him in fine spirits, we used our deeming prerogative. It’s a very commonsense book.

**Moona:** Please run through a case for us. For example, you mentioned Johnny Roselli.

**Belzer:** OK. Roselli was big in the Chicago mob and had Al Capone as a tutor. He was sent to Hollywood to extort from the movie business, and sent to Vegas to shake down the casino profits. Roselli was also involved with Howard Hughes. His murder, when it occurred, consisted of having his legs sawed off and stuffed, with his body, into a 55-gallon drum, and sunk off the Florida coast.

The date was August 1976, when he was scheduled to testify before Congress. So who did the murder? A reasonable guess is the Mafia, judging by the 55-gallon drum. But it could have been the US government. **Moona:** Is this a Cuban connection?

**Belzer:** Almost certainly. But I should first say that mercenaries are mercenaries. It may be possible to hire a hitman for a job with no regard to his ethnicity or political leanings. That said, there were plenty of Cuban men, in Cuba, who did not want Castro to continue on as leader. They would have liked to see the US declare war on Cuba, to get rid of “the Communist threat” to America – or at least people talked like that.

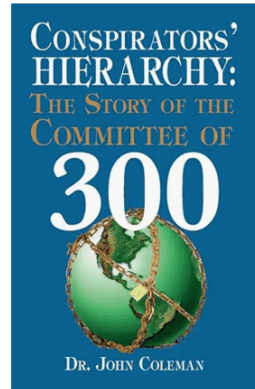
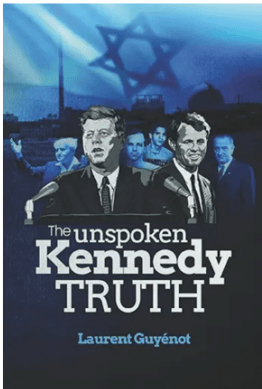
It seems that the US Military was happy with the prospect of killing Castro, but the US president, John F Kennedy, did not agree. At one point, in 1961, various men gathered many upstarts on Cuba’s island and hoped to direct a private uprising of Cubans. JFK put the kibosh on it. **Moona:** You say the US military was in on it, but the Commander-in-Chief was not.

**Belzer:** Yes. This is known as the Bay of Pigs fiasco. Kennedy accepted responsibility for the fiasco. As for Johnny Roselli, I assume he was mafia but at times it is hard to distinguish a mafia person from a US government employee, be it CIA, the NSA, or the US Military. **Moona:** What is your personal guess

as to who “drummed” Roselli? **Belzer:** I can’t decide. But here is a quote on page 113 of our book, “Hit List.” It’s from a 2001 article that Paul Golais wrote at The Citizen’s Voice in the UK. Gary Underhill had told a woman friend:

“This country is too dangerous for me. I’ve got to get on a boat. Oswald is a patsy. They set him up. It’s too much. The bastards have done something outrageous. They killed the president! They’re a bunch of drug runners and gun runners – a real violence group. I know who they are. That’s the problem. They know I know.” \*\*\*

## SECTION TWO – Guyénot, Poulgrain, Coleman



**Rep Moona:** I invited you to this hearing, Mr Guyénot, because of your 2021 book “The Unspoken Kennedy Truth.” It mainly blames Israel for the assassination not only of JFK in 1963, but also RFK in 1968.

**Mr Laurent Guyénot:** There are hundreds of books on the JFK assassination. Setting aside those that were published for distraction or misinformation, there are many whose author noticed something amiss and went from there. For example, they may have recognized a woman in the crowd at Dealey Plaza to be carrying a tiny revolver. Or, if they work in a government office, they may have seen an old letter from a

diplomat that suspiciously tied together two persons who testified at the Warren Commission.

That is not my style. I am an anthropologist, born in Europe. I developed a theory, or at least a hypothesis, as to who made the decision to get rid of President Kennedy – Israel. Then I went looking for facts that would support it and found even more that I needed. Here it my pitch, in brief:

The state of Israel, especially its prime minister David Ben-Gurion, wanted Israel to become powerful. (In 1963 it was only 16 years in existence, and was weak.) But JFK was on a peace kick and he said he would block Israel's plans to go nuke. He worried that the Dimona plant would not be, as promised, a nuclear power plant for energy but would put Israel into the club of N-states: US, UK, France, and USSR.

I hypothesize that Israel made use of James Angleton in the CIA to sketch out a way to kill Kennedy. An important person in Dallas was nightclub owner Jack Ruby, formerly Jacob Rubenstein. The most crucial person on Israel's side was LBJ.

**Rep Moona:** I now ask you to spend a few minutes each on Angleton, Ruby, and LBJ, to show how they played a role.

**Mr Laurent Guyénot:** James Angleton (1917-1987) was age 30 when he joined the brand-new CIA in 1947. He had also been involved in Gladio in Italy. Angleton ran his shop in the CIA in an extremely secretive manner. Allen Dulles, the first CIA Director, had named Jim Angleton as Chief of Counter-intelligence. That (Co-Intel) is meant to track foreigners in one's own country who may be spies. Indeed, Angleton went on a search for Soviet moles in the CIA itself.

That said, I would not rule out that he actually worked directly for Israelis. Jefferson Morley has done intense research on this

in his book “The Ghost” (2017). Starting in 1951, Angleton ran the Israeli desk within the CIA. Ben Gurion had come over to America to help establish a connection between Mossad so they would exchange secret information. Angleton visited with the diplomatic staff from Tel Aviv almost every day.

Israel considered Gamal Nasser, leader of Egypt, its enemy. Yet Angleton failed to warn his own US government (Eisenhower) that Israel, France and UK were going to invade Egypt because Nasser nationalized the Suez Canal. I quote Morley:

“Angleton’s influence on US-Israeli relations between 1951 and 1974 exceeded that of any secretary of state with the possible exception of Henry Kissinger. His influence was largely unseen by Congress, the press, and other democratic institutions, and much of the CIA itself.”

I note that Angleton was not a Jew, therefore to speak against him cannot be said to reflect anti-semitism.

**Moona:** Is that all you have to say about Angleton?

**Guyénot:** Yes, until I discuss Dimona, below. So now for Jack Ruby. He is known to the public for having shot Oswald, which he said he did in order to spare Jackie Kennedy from having to watch a trial of her husband’s killer. That’s ridiculous but media reports things like that and no one laughs.

Ruby was the owner of a strip joint, the Carousel Club. One of his dancers, Gail Raven, said: “He had no choice... Jack had bosses just like everyone else.” I think we have a very clear picture of who his bosses were: Gangsters for Zion. Even his permission to enter the police room where he shot Lee was covered by his alibi of being a translator for the Yiddish Press.

Importantly, I also hold that this Zionist criminal organization in Dallas included Abraham Zapruder, and that he was hired to film the assassination. As I note on p 82 of my book, “The Unspoken Kennedy Truth,” Mr Zapruder didn’t flinch as shots were fired behind him. He sold his film to *Life* magazine for \$50,000, but in fact the government seized it.

The Government doctored the film to disguise the fact that Kennedy was shot from the front, and therefore Oswald is not the killer. I do not know which particular persons in the CIA made sure that this doctoring was done. But it must have been they who employed Zapruder to do his famous job.

**Moona:** Will you now position Johnson into all of this?

**Guyénot:** Yes, but I first must talk about Dimona. I endorse what James Douglass said in his book “JFK and the Unspeakable” (2008) -- that Kennedy had character and vision and wanted to build lasting peace, but was up against the hawks of the military and intelligence establishment. But I disagree with Douglass’ exoneration of Johnson.

Consider that Kennedy and Ben Gurion had a correspondence going, in which Kennedy tried to get Ben Gurion to join the move to nuclear disarmament by not joining the nuclear club in the first place. Kennedy insisted on inspections of the Dimona plant, at the price of withholding aid, but Ben Gurion kept delaying a decision on that. Moreover, plutonium was snuck out of a nuclear plant in Pennsylvania over a period of several years. This enabled Israel to build two A-bombs.

Assuming that Israel had every intention of joining the nuclear club, JFK was in the way. He needed to be disposed of. When you look at how aggressive Israel subsequently became in the Middle East, it is not too much to think an assassination had to happen in 1963.

Once Johnson was in office, everything went in Israel's favor. And he did all that was needed, including endorsing the Warren Report, to have the nation believe the assassination was the work of a lone gunman. As far as I can see, this new United States president participated in harming the Non-Aligned Movement, that is, countries that did not want to be in the camp of either superpower: US or USSR.

Thus, when Egypt's Gamal Nasser stood out as a great leader of the NAM, Johnson backed Israel's effort to get rid of Nasser. This 1967 affair included the planned attack by Israel on the USS Liberty. Many American sailors died as a direct result, which of course means Johnson committed high treason. \*\*\*

**Rep Moona:** Now we come to a little-known theory of the assassination, thanks to Prof Greg Poulgrain of Australia, who thinks Indonesia was involved. How can this be?

**Prof Greg Poulgrain:** My story about Indonesia is somewhat parallel to that of Guyénot's story about Israel at the time of JFK's death in 1963. In both cases, Kennedy was ready to support self-determination of new countries – 'new' in the sense of being recently released from European empires. Egypt had been partly controlled by Britain, and Indonesia was, until 1949, a colony of the Netherlands.

But instead of Angleton as the traitor, I name Allen Dulles (1893-1969). It's true that Kennedy fired Dulles as head of CIA in 1961 but there was still opportunity for Dulles to play behind the scenes in 1963. Basically, Dulles represented the interests of Standard Oil, that is, Rockefeller.

**Rep Moona:** Was there oil in Indonesia?

**Prof Greg Poulgrain:** Yes, and copper, but there was also another rich resource, gold, high up in New Guinea's 'Alps.' Here is a new comparison of Dulles and Angleton. Just as Angleton had known that Israel was stealing plutonium in Pennsylvania

yet did not pass that vital information to his president, so, too, Dulles knew that the Rockefellers had their eye on the unannounced discovery of a huge gold mine, yet he stayed mum.

I'll put this crudely: Standard Oil, i.e., Rockefeller and therefore Sullivan and Cromwell Law Firm, wanted the gold and knew how to get it with the aid of the CIA and also the US Navy. This meant keeping JFK in the dark about it. The poorly informed president was trying to help Sukarno, Indonesia's leader. JFK would give them economic aid and he would help them in regard to a confrontation with Malaysia.

Dulles wanted to stop American support for Sukarno. But in November 1963 President Kennedy agreed to pay a visit to Jakarta (capital of Indonesia) in early 1964. Oh-oh. This would have made Sukarno popular throughout the Third World. The solution was: assassinate JFK.

**Moona:** But how does that tie in with setting Oswald up as the patsy in Dallas?

**Poulgrain:** Funny you should mention it. I have been digging away on this case for 40 years. I found out that Allen Dulles, in 1920, was friendly with George de Mohrenschildt's dad, Baron Sergius von Mohrenschildt. He was negotiating with Rockefeller's Standard Oil. Allen was only 27 at the time and not yet part of US government. The dealing occurred in Constantinople (today's Istanbul, known in Roman times as Byzantium).

Anyway, his son George committed some sort of crime in regard to Standard Oil and needed to escape so went to New Guinea, which was then part of Indonesia colonized by the Dutch. Although I cannot tie George de Mohrenschildt to my theory of Allen Dulles arranging for JFK to be killed, I can say that it looks like it, because de Mohrenschildt, in Dallas Texas, became the handler of Lee Harvey Oswald.

To repeat the correct biography: Lee was in the US Marines and then got recruited for the CIA. He was asked to act out a “defection” to the USSR (Union of Soviet Socialist Republics) and may not have realized that this would make him suitable later as a patsy. The American public fell for the story – which was kept alive right up till today – that Lee liked communism. “Sure, he likes communism so he would naturally kill the US president!”

Upon his arrival back to the United States, Lee was accompanied by his Russian wife Marina and their two small children. A Dallas resident, George de Mohrenschildt, befriended Lee and another Dallas person, Ruth Paine, befriended Marina and the children, even moving them into her home when Lee went off to New Orleans in 1963. Upon Lee’s return, Ruth got him a job at the Texas School Book Depository, now famous for its 6<sup>th</sup> floor window. Imagine that.

**Moona:** How did Ruth Paine come into the story?

**Poulgrain:** I don’t claim to know, but when asked by mainstream TV she stated that she wanted to practice her Russian. This had to do with her church’s offering some kind of help to Russian immigrants. Ruth Paine gave a similar answer when asked by the Warren Commission. Don’t forget that Allen Dulles was a major player on the Warren Commission, so she would not have been grilled. I imagine you could invite Ms Paine to these hearings on the Declassification of Files. \*\*\*

**Rep Moona:** Five who have so far testified before me are still alive: Barr McClellan, Perry Adams for Fred Newcomb, Richard Belzer, Laurent Guyénot, and Greg Poulgrain. Now I will hear about a book written by John Coleman in 1992. The title is: “Conspirator’s Hierarchy; The Story of the Committee of 300.” Coleman was born in 1935 and worked for Britain’s MI6, that is Military Intelligence 6, whose members spy on foreign nations, or on anyone. I am not sure if Coleman is alive

but a man has offered to speak for him by reading from The Committee of 300. Welcome, O substitute for Mr Coleman!

**John Coleman's reader:** The book "Conspirator's Hierarchy" is very sophisticated and I mustn't pretend to be a master of it. So I will quote verbatim the various remarks Coleman makes about Kennedy, as such. This one is from page 17:

"The Club of Rome has its own private intelligence agency and also 'borrows' from David Rockefeller's INTERPOL. Every US intelligence agency cooperates very closely with it, as does the KGB and the Mossad. The Club of Rome also has its own highly organized political and economic Agencies. It was they who told President Reagan to retain the services of Paul Volcker, yet another important Committee of 300 member.

"The Club of Rome, after playing a key role in the Cuban Missile Crisis [wow]attempted to sell its 'crisis management' (the forerunner of FEMA) program to President Kennedy. Several Tavistock scientists went to see the President to explain what it meant, but he rejected the advice they gave. The same year that Kennedy was murdered, Tavistock was back in Washington to talk with NASA. This time the talks were successful. Tavistock was given a contract by NASA which was then farmed to the Stanford Research Institute and Rand Corp."

**(Rep Moona:** This is the first I have heard of Club of Rome or Tavistock, but I know RAND and NASA.)

From pages 139-141: "What helped The Perkinses a lot was that Morgan was a powerful member of the Committee of 300, which enabled Thomas N. Perkins to rapidly further his career in the China opium trade. All the Morgans and Perkinses were Freemasons, which was another tie that bound them together, for only Freemasons of highest rank have any hope of being selected by the Committee of 300. ....

“In addition to his membership of Morgan’s elite bank, Newbigging doubles as an advisor to the Chinese government. Opium for missile technology, opium for gold, opium for high-tech computers — it is all the same to Newbigging. The way these banks, financial houses, trading companies and the families who run them are intertwined would perplex Sherlock Holmes, yet somehow they must be unraveled and followed if we are to understand their connections.

“The two-track entry into the United States of alcohol and drugs were products of the same stable occupied by the same thoroughbreds. First, prohibition had to be introduced into the US. This was done by the British East India Company heirs who set up the WCTU, Women’s Christian Temperance Union. In the case of those who railed against the ‘evils of drink,’ we find they were financed by the Astors, the Rockefellers, the Spelmans, the Vanderbilts and the Warburgs who had a vested interest in the liquor trade. On the instructions of the Crown, Lord Beaverbrook came over from England to tell these wealthy American families that they were to invest in the WCTU. (It was the same Lord Beaverbrook who in 1940 ORDERED Roosevelt to get involved in Britain’s war.) ...

“The drug trade has a connection with the murder of President John F Kennedy, which foul deed stains the national character and will continue to do so until the perpetrators are found and brought to justice. There is proof that the Mafia was involved in this through the CIA.

“This brings to mind that it all started with the old Meyer Lansky network which evolved into the Irgun terrorist organization, and Lansky proved to be one of the best vehicles for peddling cultural warfare against the West.

“It is worthy of note that Tibor Rosenbaum’s bank was used by the shadowy chief of British Intelligence, Sir William Stephenson, whose right hand man, Major John Mortimer

Bloomfield, a Canadian citizen, ran Division Five of the FBI throughout the Second World War. Stephenson was an early member of the 20th century Committee of 300.

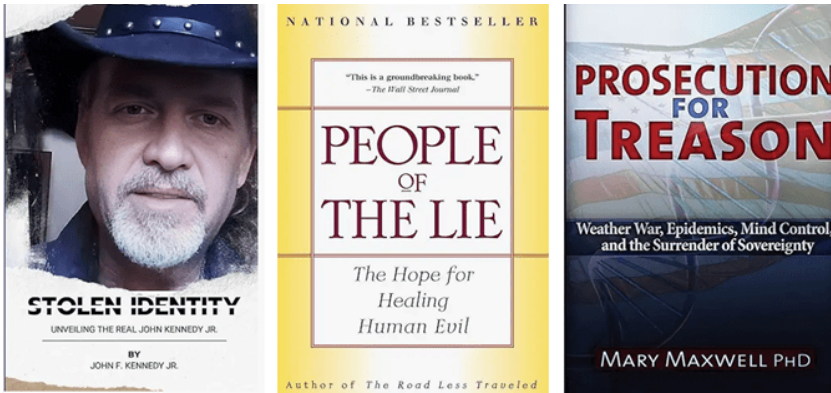
“As I revealed in my series of monographs on the Kennedy assassination, it was Stephenson who master-minded the operation which was run as a hands-on project by Bloomfield. Fronting for the Kennedy assassination was done through another drug-related front. Permanent Industrial Expositions (PERMINDEX), created in 1957 and centered in the World Trade Mart building in downtown New Orleans.

“Bloomfield just happened to be the attorney for the Bronfman family. The World Trade Mart was created by Colonel Clay Shaw and FBI Division Five station chief in New Orleans, Guy Bannister. Shaw and Bannister were close associates of Lee Harvey Oswald.”

**Moona:** I must tell you I am flabbergasted.

**John Coleman's reader:** I'll finish up, using pp 171 to 178: “A second assassination bureau is in Switzerland. The operations were financed by the Oltramaire family-Swiss Black Nobility, owners of the Lombard Odier Bank of Geneva, a Committee of 300 operation. This group was also closely allied with Allen Dulles and Jean de Menil, an important member of the Committee of 300 and a very prominent name in the oil industry in Texas.... David Ben-Gurion [was] a member of the Committee of 300. In 1951 Sir William Stephenson of MI6 restructured it into a single unit as arm of the Political Department of the Israeli Foreign Office, with a special operations group for espionage and ‘black job’ operations. British intelligence gave further assistance in training and equipping. This service unit of the MOSSAD is never mentioned by name and is known simply as ‘The Guys’- merely an extension of British intelligence’s SAS unit who continually train them.”

## Chapter 28. Moona Invites Junior, Maxwell, and Prouty



*Note: In this chapter, the imaginary Congresswoman, Rep Moona, talks to three more persons, JF Kennedy, Jr, Mary Maxwell, and Fletcher Prouty.* In Chapter 28 we heard six book authors each answering the question “Who killed President Kennedy?” Roughly their answers were as follows:

1. Barr McClellan: **Lyndon Johnson** 2. Fred Newcomb: **The Secret Service** (with William Greer pulling the trigger), 3. Richard Belzer: **the mafia** (dovetailing with **CIA** with reference to Cuba). 4. Laurent Guyénot: **Israel** (with help from James Angleton and Jack Ruby), 5. Greg Poultrain: **Allen Dulles** (working with Rockefeller on Indonesia’s gold) 6. John Coleman: “the **Committee of 300**,” under **British** control.

This is an unsatisfactory state of affairs 63 years after the 1963 tragedy. The Great Republic had a coup d’etat but since the media controls the public’s knowledge, most people still think the assassination was done from the 6<sup>th</sup> Floor of the Book Depository on Dallas’s Elm St. No, it was an undertaking of vast proportions, including resolute attempts to silence the voices of truth-seekers. Citizens urgently need to understand how our “open government” can act so secretly and can lie so prodigiously. To ignore the facts is to live in a fantasy.

**Rep Moona:** Mr Kennedy, I invited you to the hearing to see if you have anything to tell us about the assassination of your father.

**Mr John F Kennedy, Jr:** I have no value as an eyewitness, as I was only approaching my third birthday when Dad was killed, and I wasn't in Dallas. Whatever I may have to contribute to an understanding of the event is based on the strange life I lived after 1963 and particularly after my mother Jacqueline died in 1975. I have written a book about it, called "Stolen Identity."

**Rep Moona:** The official narrative says Jackie died in 1994.

**Mr John F Kennedy, Jr:** And there you have it! It is called identity theft. The lady who lived at Park Av, New York, was not the real Jackie. I had witnessed my mother's death by gunshot in 1975. Then, in 1994, that other Jackie (an impostor) died. Similarly, my identity was handed over to a newcomer, the famous, dark-haired JFK Jr. And then he died in a plane crash in 1999. I am trying to get the word out to the public that Identity Theft is common. It is often directed at very wealthy, unmarried people. The impostor has no trouble cashing the real person's bank account, selling her house, etc.

**Moona:** Your story sounds pretty unbelievable. **Kennedy:** But it will start to be believable as soon as people get used to it. I am using social media to tell my story, and have thousands of viewers who can easily see through the old deceptions. When I get thwarted in my legal quest to regain my identity, this further shows who is running this world.

**Moona:** In regard to the assassination, please tell us anything you've learned over the years from your special vantage point as a family member.

**Kennedy:** Thank you. I am eager to tell. In fact, I am bursting to get it out before they kill me. One thing comes straight to

mind. People in power often use mind control on their slaves. The variety I am most familiar with is MK-Ultra. The prospective victim is tested as to his vulnerability or suggestibility. If he looks like a good potential slave, he is trained by torture. Drugs come into it, but I myself was trained mostly by torture.

The idea is to keep the person from having his own will, and even his own sense of self. Much is done to make him feel degraded and scared. He also feels confused, as the part of the brain that should be showing him how to get from A to B is sort of wiped out. Much of his memory gets lost.

Don't take it from me – this stuff is all on the CIA's website as "historical" material. Just think how ruthless these bad guys are! **Moona:** How can this help us understand the assassination?

**Kennedy:** In two ways. First, when you find out that nice Americans – say doctors and teachers – have participated in such inhumane treatment of their fellow man (including children) – that opens your mind to the fact that humans can do terrible things, even though it is considered impolite to say so. I believe many people knew about the assassination before it occurred and many more accepted that it should be hushed up. They went along with it because "Hey, it's the done thing."

Second, I am pretty sure that MK-Ultra is a key to understanding that a lot of people are obeying bad instructions under a sort of hypnosis. It is now well known that the technique, which was once called mesmerism, involves a skipping of rational thought. The hypnotist is able to say "Go open the window" to his patient, and she is not going to say "That's not a good idea, it is freezing out there." Or "My arm is sore; I can't lift that window." All she can do is go to the window and open it without fuss. This is in the nature of our brain, provided the hypnotist has used the right trick to get past the rational parts.

I'd like you to know that military are trained to "not think" and it looks as though media and politicians are trained to "not think." Somebody manipulates them. This is acceptable in an army, and how bootcamp does it is public information. But in ordinary society we shouldn't tolerate this kind of slavery.

**Moona:** OK. Anything else about the assassination? **Kennedy:** Yes. From age 7 or so, after the assassination of my wonderful Uncle Robert in 1968, I lived with mafia people on a daily basis. Their god is Money. I want everyone to know how far the thinking of mafia people has penetrated our culture. It allows many crimes to flourish, from money-laundering to identity theft to murder. I say again: Money is the mafia's god.

It is also likely that satanism has added to the problem of money and greed. I am unable to estimate the prevalence of satanic belief in US today but it is not inconsiderable. Most of the Satanists I know go to normal church on Sunday to cover it up. They also join volunteer organizations, perhaps to compensate. Anyway, if they are in MK-Ultra that is enough to help them not be bothered by scruple.

It may end up that my biggest contribution after getting liberated a few years ago, is to make known the extent to which mafia people are inside government now. It is huge, huge. \*\*\*

**Rep Moona:** Mary Maxwell, I see that you have a PhD in Political Science, and you have written many books including "Prosecution for Treason." **Dr Mary Maxwell:** Yes, I also have a law degree and am especially interested in meting out punishment to persons who are harming our society by messing up the Republic.

**Rep Moona:** I give you the floor.

**Dr Mary Maxwell:** Thank you, I thought you might give me the floor. ....

I recently wrote a book entitled “The Historian’s Tale: The Amazing Return of President Kennedy’s Son.” While researching it, I had to wade through many old videos of President Kennedy. I was truly surprised at how people adored him. I was 16 when he died, so it was natural for me to be in the adoring crowd, but it was the atmosphere of trust and optimism that is so noticeable in these videos. Also, the tears that flowed at his funeral – we haven’t seen, at any subsequent presidential funeral, such a display of emotion.

Therefore, what I want to say about the assassination has to do with the new road that we all went down after JFK’s passing. The deceitfulness of it all has become normal, almost required. We simply lie all the time, as M Scott Peck says in his book “The People of the Lie.”

We see it all the time in product advertisements. At the moment, the penchant for false identity and for the miracle of photoshopping has gone so far that, if you see a YouTube video featuring Melania Trump you have to squint to check if it really is Melania or someone doing a spoof. “Sky’s the limit.”

The fact that people are paying attention to your “Task Force for Classification of JFK Files” ought to provide a specific, well-defined opportunity for us to consider the entire JFK files as an exercise in lying, starting with the Warren Commission. We never heard a voice on TV or radio saying “Wait a minute!”

There are rules to follow. Let me name two: First, lying under oath is a crime and if a Commission sees lying, it can refer the person to the DoJ for indictment for perjury. Second, the crime of perjury during investigations always goes unpunished. Why? Because the People of the Lie have to have an atmosphere in which people say “Oh, yeah, we lie. It’s natural.” No one gets picked up for perjury as that would make people notice that some folks are allowed to perjure themselves. Sorry if it sounds like I’m talking in circles.

**Moona:** Do you wish to point to specific lies in the Warren Commission? **Maxwell:** Not exactly. I prefer to point to the hopelessness of the task of ferreting out lies until we all firmly state that it was a *coup d'état*. For years, people were told that the assassination resulted from one man's preference for Communism. Oswald had both defected from the US to the USSR, and had been seen, shortly before 22 November 1963, handing out leaflets that said "Hands Off Cuba."

The government was being wholly dishonest. Oswald was in fact a covert operative for the US Government, and of course some government employees knew this. So who made up the story? The purpose of it was to take all eyes off the real killer. And it was to add to Cold War fervor by saying "Oh that awful commie punk, Lee Oswald, harmed us!"

It won't suffice just to reveal such trickery now. We need to punish the guilty and make a big brouhaha over the fact that some powerful Americans have the nerve to do psy-ops like that on us. My own career went off onto a tangent of trying to find the truth when a false-flag is present. For example, the entire story of the 2013 Boston Marathon bombing is a lie. The false flag said a pair of brothers from Russia wanted to express their hatred for America, or something like that.

Every media employee was required to babble the same nonsense. Every cop was required to show anger that an officer got hit by gunshot. Every defense lawyer was supposed to shut his mouth when noticing that the Public Defender of Tsarnaev was skipping every known protocol of due process, and that the judge's behavior was way off the charts. Every priest was to get up in the pulpit and acknowledge that "the 3 deceased and other 264" victims needed prayers. In Boston already!

**Moona:** Hasn't that Tsarnaev case been corrected by now?

**Maxwell:** Not in the least. In fact the US Supreme Court overrode a ruling from the Appeals Court that had reduced the

prisoner's sentence from death penalty to life in prison. They put it back to death penalty! Surely they did so 'on command.'

Each month that goes by, the hearts of America's lawyers get hardened. They do know, deep down, it is wrong, but the way to deal with their own guilt for being silent is to say it is NOT wrong. In his book "The People of the Lie," Dr Peck, a psychologist, learned from a veteran that, after realizing he should not have stabbed innocent Vietnamese, he got over his guilt by stabbing them with more gusto. Apparently, we all do that.

**Moona:** Could you bring this back to the JFK assassination?

**Maxwell:** Yes. All of us, me included, have come to accept that any board of inquiry, such as the Warren Commission, is a joke. Thus, when we really need a board of inquiry, or any way to pin down the truth, we all accept that there is nowhere to go.

We are all contributing to this loss every day. Even your very own Task Force will contribute, unless you raise a flag of ideals – such as the ideal of honesty and the ideal of a society being able to punish wrongdoers. Will you say that we need to judge which of the documents are bold-faced lies? Will you say that a few media corporations have a monopoly and that this itself is criminal per the Sherman Anti-Trust Act?

**Moona:** Who killed Kennedy?

**Maxwell:** I like the theory that the driver did it: Greer, a Secret Service man. If he did it, he was probably under mind control

**Moona:** I don't mean who pulled the trigger. I mean how do you explain the overall conspiracy?

**Maxwell:** Greed, arrogance, fear. Brits were the bosses. Let's not allow them to get away with it. \*\*\*

**Moona:** Finally, I ask Fletcher Prouty's proxy to tell us what Prouty conveyed in his book *The Secret Team*. Prouty was in charge of many CIA clandestine activities from 1955 to 1964.

**Prouty's proxy:** The seeds were planted in 1945 at the UN, or maybe in 1919 at Versailles. I don't want to go back earlier to the Freemasons, Illuminati and all that. Once there was a country with enough rich men or wannabe rich men with willingness to act as a team, it was all but guaranteed that they would develop a habit of killing anyone who stood in their way.

**Moona:** So is that how Prouty put it? Is that his "team"?

**Prouty's proxy:** No, he was more specific. His gripe was that the 1947 National Security Act was written in a way that did not call for any "fun and games" by the CIA – yes that's his terminology. But Alan Dulles pulled some tricks and before you know it, a large number of military men were working for CIA. Conversely, many CIA people donned army uniforms.

**Moona:** Did they therefore kill Kennedy?

**Prouty's**

**proxy:** Almost certainly. It was a huge undertaking.

**Moona:** Who was the Manchurian Candidate du jour?

**Prouty's proxy:** Not Oswald (See Judith Baker's *Me and Lee*.) Your committee should have called Ruth Paine. And I doubt de Mohrenschildt really died at 65. Hurry up and take control.

Congress is at fault for its wording of the 1947 National Security Act. I want you to take Prouty seriously on his major revelation – that the CIA could -- and still can -- place countless of its men into military positions, and use all the army's weaponry. What Prouty referred to as The Secret Team are persons who are officially unaccountable to government. They could just as well be Soviets working for Russia – no one would know. But Prouty did realize that Alan Dulles had a big part in all this!

## Chapter 29. Junior Says “It’s the Mafia, It’s the Mafia”

On numerous occasions I have asked John F Kennedy, Jr what was really going on, that could have led to his receiving such harsh treatment in his youth. He says: “Organized crime has taken over the government.” And “Organized crime is huge, huge.”

Probably his perception of the mafia is bigger than it should be, as he was personally targeted for ‘decimation.’ He had to protect himself from death, on a daily basis, by guys and gals who were under mind control to mess him up. This is probably because as an assassinated president’s son he was a threat to the system. John considers his attackers to have been working for the mob, yet he was not aware of whom they took instructions from.

His own handler, Wayne, appears to John to have been high-level mafia. (John speculates that Wayne’s father was the head of the mafia. Is there a head?) John tells us “Wayne was so powerful he could march into the White House just by flashing his badge. “He could tell presidents what to do and they would do it.” Wow.

The mafia works directly. When one or two men come by your shop asking for the monthly pay of “Protection” money, you hand over whatever they require. One simply accepts that the mafia’s ruthlessness and fixed purpose will defeat resistance.

I suppose this cooperation by shopkeepers is sensible: they have no choice. Only a big crackdown by law enforcement, or major protest by the population, could overcome the ability of the mafia to rob you. Back in the 1950s, mafia’s source of revenue was its provision of illegal things that the public wanted: drugs, gambling, prostitution, loan-sharking. The mafia took charge of the distribution of those ‘goods.’ The only significant “overhead” was paying police to turn a blind eye.

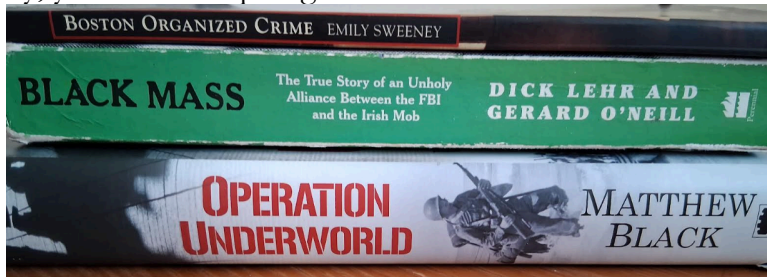
Later, the mafia branched into other activities that helped protect their control. They needed to get into politics, or at least into the elections game, to make sure a Nuisance didn’t get in.

They also needed to ‘launder’ their wealth, and this would have led to them getting involved in banking and also into apparently-neutral businesses, from farming to the airline industry. I assume that most of the largest industries today have made their peace with mafiosi, but I don’t really know how it’s done.

### **A ‘Book Tour’ about Mafia, Government, Business, Intel**

Walk with me through stages in which US government and business got married. This is not an area I have deeply researched and I may be wrong. (Whitney Webb is great at it.) One part of “the marriage’ that looks plausible is simply that the wealthy can hire anyone to do dirty work for them. John says that after he was vasectomized (on the Quigley’s kitchen table) the ‘doctor’ who did it, Charlie Brown, disappeared. He was probably killed to shut him up.

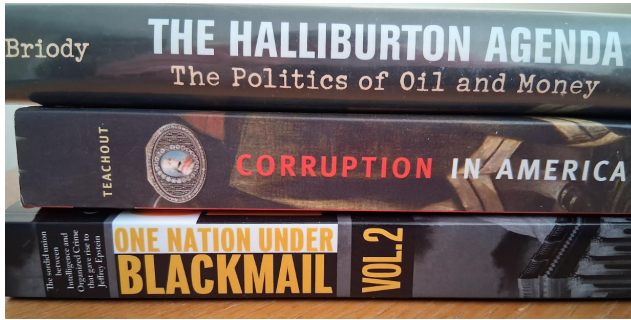
I muse that it’s **impossible to have, simultaneously, a lawless America and a good government**. If yucky crimes go unpunished, ‘governance’ has ended. I think this is happening today, yet even its top dogs don’t see it will backfire on them.



Of the above books, the one on Boston crime in the 1930s shows that organized crime people ended up in jail. Good. The next one, *Black Mass*, is about Whitey Bulger and how an FBI agent protected him. I should mention that Whitey (later killed in jail), got his start when he accepted an offer to undergo MK-Ultra type experiments, including LSD, to get earlier parole. I don’t know how much this contributed to his later brutality.

The third book paints a scene of NY longshoremen doing what criminal longshoremen do, such as falsify freight, but with a

nice story about Lucky Luciano helping the US military defeat the WWII enemy, in Italy. It is highly personalized regarding the workers' loyalty to one another -- made me think how male bonding works. Perhaps enticing deals were offered for helping the war, but the author shows men doing their tasks dutifully.

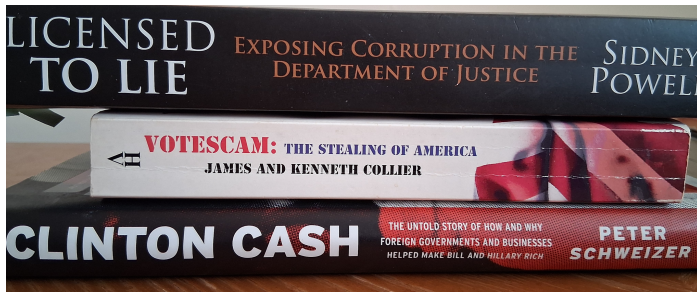


In the next set of books, the scene switches to the inevitability of the law-enforcement positions becoming corrupt. Although *The Haliburton Agenda* demonstrates how a big business gets very cocky and eliminates its competition, it also needs political sway over any politician who would stick up for the law.

The next book, by Zephyr Teachout, gives a history of corruption in America, including the rare cases where the public's refusal to go along with the marriage of crims and pollies (Australian word for politicians) led to a temporary turnaround.

The third book is Whitney Webb's amazing study of high-level organized crime completely interwoven with political activity. She has studied Myer Lansky, Roy Cohen (Trump's mentor) and Trump himself, plus Jeffrey Epstein. As everyone knows Epstein ruled his Island roost, not only without trouble from, but with actual visits from, judges, royalty, and celebrities.

Let me repeat: If criminals are adept at corrupting government, we will end up with no law at all, and actually no 'government' just a slave society in which you, the member, have no say. I have seen in the last 30 years that this is definitely on schedule!

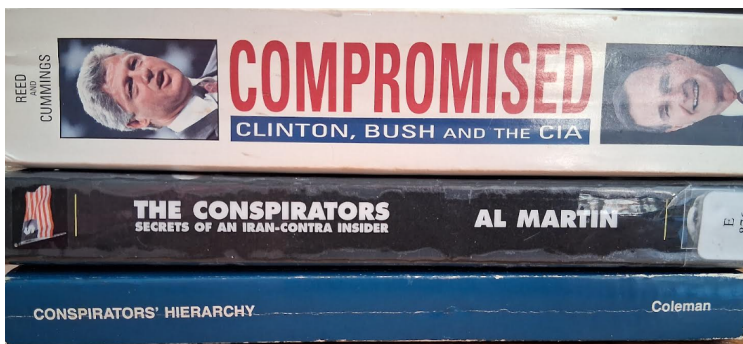


Above are three books on that theme, emphasizing the failure of law personnel. The title of Sidney Powell’s book, *Licensed To Lie* refers to the DoJ’s allegedly having given itself “legal” permission to present untrue facts to the court. Fathom it.

**Foreign Involvement.** A nation that does not stop domestic organized crime is soon mixed up with foreign criminality:



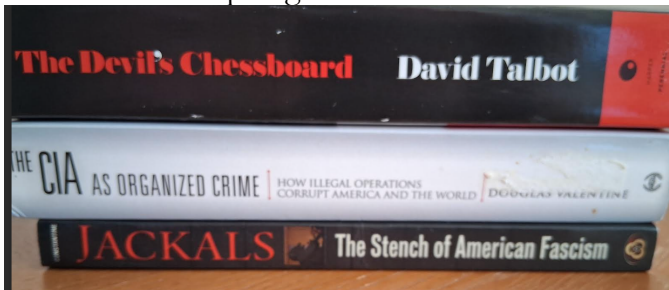

pinned it to Bill Barr as the mastermind of Iran Contra -- Barr being the US Attorney General at the time. In *The Conspirators*, a low-ranked member of government, Al Martin, holds forth on his anxiety about whistleblowing the Iran Contra thing which dovetailed with the Savings and Loan scandal.

John Coleman said that the UK business of dementing the Chinese during the opium war of 1840, is the correct place to look for UK's control over America. Then we did it too, including by getting our soldiers hooked on cheap heroin, in Vietnam.

Coleman then goes further, claiming in *The Committee of 300* (written in 1992), that the UK is the general boss of US. He also says it was Permindex that killed JFK --- on behalf of Queen Elizabeth for the Committee. Note: In his 2023 book *Stolen Identity*, John F Kennedy, Jr says that a year after the assassination, his mother greeted Her Maj by calling her a bitch, to which the queen replied "You're a bitch too." As remembered by a 4-year-old.

**Secret Government.** Secrecy is part and parcel of crime, isn't it? But when a Republic establishes a whole section of its Executive branch that claims a right to absolute secrecy, it's curtains for the idea of open government.

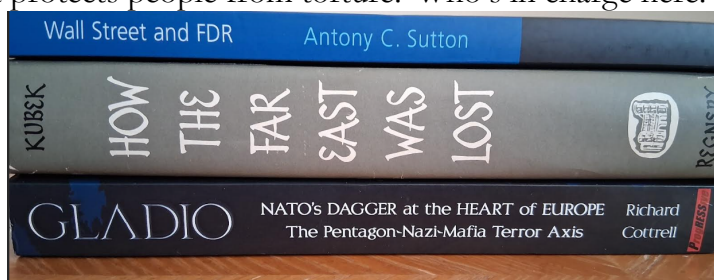


The subtitle of David Talbot's book *The Devil's Chessboard*, is "Allen Dulles, the CIA, and the Rise of America's Secret Government." (Dulles' brother John was Eisenhower's Secretary of State.) Kennedy fired Dulles, probably for obeying foreign bosses. (I was told by my late friend Blanche Chavoustie that

Alan Dulles was her personal trainer, in Syracuse NY, in 1940, on “how to break the mother-child bond.” Fancy that.)

Note also the CIA book by ex-Vietnam man, Douglas Valentine. Coming up to more recent times, we have Alex Constantine’s book, *Jackals*. Its back cover says “The Knights Templars of the corporation at the CIA have a long history of striking alliances with undesirables... Its Chapter 14 is about Satanist Michael Aquino – a colonel who was allowed to get away with (as they all get away with) MK-Ultra child torture.

Is there something going on here? Isn’t America the country that protects people from torture? Who’s in charge here?



The subtitle of Antony Sutton’s book *Wall Street and FDR* is “How Franklin D Roosevelt Colluded with Corporate America.” In his earlier book, *National Suicide*, Sutton while researching the Ford Company’s activities happened to see that Ford sent trucks to our ‘enemies’ even when our soldiers were fighting them. What!

This startling theme is also expressed in Professor Kubek’s 1963 book *How the Far East Was Lost* (meaning lost to Western capitalism or to American interests). Yet Kubek’s subtitle is “American Policy and the Creation of Communist China 1941-1949.” It contains piles of evidence that members of the US State Department kept us from finding out that we were helping Mao obtain his famous dictatorship. This stuff is mind-boggling, no?

## Chapter 30. A Philosophical Defense of the Use of Force

In the Gospel of Matthew, 5:28-41, we find Jesus preaching: “Do not resist an evil person. If anyone slaps you on the right cheek, turn to them the other cheek.” That occurred during The Sermon on the Mount when Jesus was setting a new ethic of generosity and forgiveness. But give an ear to a Russian man, Ivan Ilyin, writing in 1922 to oppose Tolstoy’s pacificism, re 1917 Bolshevism. In *On Resistance to Evil by Force*, Ilyin wrote:

P 7 “What would “non-resistance” mean, in the sense of the absence of any resistance? **This would mean accepting evil: letting it in, and giving it freedom, scope and power.** If under these conditions the uprising of evil occurred, it would mean subordination to it, a surrender of the self to it, participation in it, and finally turning oneself into its instrument.

P 8 “The non-resistor of evil sooner or later arrives at the need to assure himself that evil is not so bad and that it is not so definitively evil, that it has some positive features.... And when aversion subsides and evil is no longer experienced as evil, then acceptance imperceptibly becomes total: the soul begins to believe that black is white, adapts to match, becomes black itself.... P 184: “When a person enters into conflict with villains and resorts to force, the sword, or cunning, he has [no] right to lay aside the burden of decision and transfer this to the divine. **The man who fights villains must evaluate all the conditions... understanding that he is forced to resort to these means....**” [Emphasis added]

Am I approving of the use of force? Yes. The non-violence preachments of Gandhi and MLK just do not cut it. Possibly both those men were planted to teach us to ‘stifle it.’ Still, I am not saying Go shoot somebody. Who is available for you to shoot? The teller in a bank that cheats you? The decision to cheat was made higher up the chain. I want you to go through channels! Just like we were taught to do.

## Exhibit A. How the CIA Can Make a New Person



*US Navy Captain Russbacher (1942-2005) a high-ranking CIA man who claims noble title in Austria. The article appeared in Rayelan Allan's "The Obergon Chronicles." Slightly edited and bolded by MM:*

**Recruitment.** A preset group of our people (from Intel community) canvasses the county hospitals and immigration centers in order to find viable candidates. We locate and select people who have no close family or friends. Once they have been selected, they are put under heavy, Level One hypnosis. At this time a clear and definitive pattern of their usefulness is determined by our psychiatrists and field officers.

**Levels 1 and 2.** The subject will be told when and where to report. The subject will have no memory of being given these instructions, he will just report on time to the proper location. IF the subject was given a "trigger" word or symbol, **he will report to the designated location upon activation of the "trigger".**

**Level 3.** The next step is Level 3 hypnosis, where the subject will become an "**overwrite**" upon his own personality. An "**overwrite**" is a **new identity or personality**. It is similar to having multiple personalities, except the original personality is repressed or hidden under the "overwrite" and will not surface for a set period of time which is determined by the Programmer. The "overwrite" is not a complete new identity. There is just enough information written into the subject's personality for us to determine his viability.

In the case of a Field Operative, Level 3 hypnosis is how the operative is prepared for a covert mission which requires a temporary new identity. **Just enough information will be written in for the operative's alias and story to be believable by everyone, including law enforcement officials.**

For the field operative who is being prepared for a deadly covert mission, a Level 3 “overwrite” can eliminate all fear and nervousness, and allow him to function under the nose of his enemies without the added stress of being discovered.

**During Level 3 programming sessions, the new subject is told that anything his “friends”, i.e., programmers, ask him to do, is okay, even though it may be against all laws of the land.** At Level 3, the person is also **programmed** to believe that he must and can do everything his “friends,” i.e., programmers, ask him to do.

**The higher the IQ of a given subject, the further the programming goes!** [We] determine how the subject can be further used. Once this determination is made, the subject will be brought to “The Farm” or one of our numerous facilities. (Doctors Hospital in Dallas, TX is one of our main centers!) If he has to perform a particularly suicidal or important assignment [in Level 5] we do our job at Stoney Mountain facilities.

**Level 4.** This is the Level that turns a subject into a “Clear Eyes”, i.e., a fully programmed “sleeper” assassin, who can commit crimes as serious as murder, and afterwards **have no shame or guilt.**

The Level 3 Super Human “overwrite” replaces the subject’s own morality and/or religious ethics with a program that **makes him believe he is beyond all human laws.** If the intent is to create a programmed assassin who will kill on cue, all morality, fear, and **revulsion of bloody body parts must be eliminated.** The Super Human “overwrite” eliminates both. The Super Human “overwrite” also gives the subject the feeling of immortality and **invincibility.**

Once the Level 4 programming is complete, the subject will be a different person with no memory of his former life. **He will not be an amnesiac, he will have memories. Ones which we gave him.** He/she will be relocated to a new state and town and given a new life.... Passport, credit cards, and birth certificate will be created or supplied by us and will be valid and legal.

The subject will also be provided with all the small things that ordinary people have in their lives, such as photos of his family. His family won’t really exist, but he won’t know this. **He’ll have all the feelings of love, hurt or anger that normal family members feel.**

The photos of family and friends will be of deep cover agency personnel. If ever a mission goes “sour” and the news media starts looking for his family, the “agency created family” will be produced for a news conference or an interview. **Agency personnel have been well coached and are trained actors and actresses.**

They will fill their roles perfectly, usually letting the public know that the “Clear Eyes” subject has always had a deeply troubled and violent past. **The media will present the “Clear Eyes” as a nut case who went on a tragic and senseless rampage.** Within a month, the public will have forgotten the incident. [How true!]

If the subject is going to be used to infiltrate a patriot group, religious commune, political campaign or environmental movement, the subject will be given all **the knowledge and beliefs that are commonly held by people in his targeted group.** The subject will believe that his fervently held opinions are his own. He will be believable to other members of the group.

Many politicians and government officials on a worldwide level have been given “new agendas”. They are given super-human talents such as a photographic memory, and the ability to lie convincingly.

**President Clinton is an example of a world leader who has been programmed with this technique. Senator John McCain and Secretary of State Madeline Albright** are two other examples of an “agenda overlay” being “overwritten” onto the subject’s own personality. Next, I began to get a sense of the numbers of the rapes, and how much of her natural reactions had to be suppressed. I got in touch with my young girl’s incredible frustration, the tragic powerlessness of being forced into sexual acts with hundreds of grown men, smelling their sweat, ...

I asked her: “What if you could do anything you want?” She smiled with glee. I asked her if she needed anything, and again, she smiled impishly, as I offered her a big, freshly sharpened Samurai sword. She went straight to work, and I quietly observed as she caused a terrific bloodbath, torturing and killing her naked rapists, screaming with laughter.

When she pulled at the penis of one of the hairy, pale-skinned, big-bellied rapists, she asked him: “Do you want me to cut it off in one hew or would you like it to be cut off little by little?” Her wide-eyed victim was speechless.... He stammered that he preferred that she do it fast.

“Okay,” she decided, bringing the sword to his penis: “I’ll do it slowly.” And as she proceeded to saw, and he screamed in bewilderment and extreme physical agony, she revelled as she scoffed: “What? She wanted to eat, and to be served. I was slightly puzzled at her mood, as I am used to parts who, after they receive what they need, are the sweetest little children, perfectly content.

This part wanted to continue to feel the high of power, and be surrounded with beauty and refined things while being waited on. As I allowed her to indulge, I felt, through this part, the pleasure of status and power. Perfectly relaxed, her presence and sense of humor were very attractive. I, as the parental self, happened to know that

her power high, which induced her ease, covered the same rage she had channeled during her debauchery. This part helped me to understand elite perpetrators better, who appear to lead charmed lives, but are secret power addicts, switching from part to part without any connection to their spiritual essence, or the Self.

Power is based on anger, and offers a platform from which revenge can be had in perpetuity on all those lower in rank. And since power or any addiction do not heal, and can never remove the underlying frustration and rage over past abuse and humiliations, the need to channel the anger increases rather than decreases.

It is difficult to grasp the vast dissociation power addicts experience. We only get to see the front part that may be charming or relaxed or intense or brilliant, which is nothing but the calm after the storm. If we would understand how disappointing, how ridiculous and banal are their secrets, if we got a glimpse behind the lies and the enormous machine they control to keep us believing that we need them to lead us, we would instantly take charge.

We have to be the change which they, by the nature of their position, can never be. Power can only protect itself; its slaves pretend to create change while creating nothing but a world in the image of their frightful internal chaos.

## Exhibit C. Former Cult Programmer, Svali, Speaks Out

## Exhibit D. Wendy Hoffman, Political Parties and Satanism

.... The political rituals already described were exclusively for one major political party and guests. That is because some from the other hold similar rituals but in more elaborate quarters, mansions. They also hold ceremonial rituals in landmark restored places. Their double-lined silk drapes, brocades, marble, furniture, ornamental decorations, materials can appear so rich that they stop appearing like what they are and look like money.

In the U.S. at least in the 1940s and 50s, programmers decided which political party the mind-controlled youth would belong to. Controllers wait until their boys are at least eight years old, girls, twelve to thirteen to start the process of selection. If the subjects show a charismatic personality, **are good in front of cameras, have the ability to double talk and not answer questions**, programmers start testing them for political offices.

The first party's candidates have to want to indulge all their senses. The second party's candidates primarily have to want to make others suffer. They also indulge their senses, but mostly they like sadism, and the first ones hurt others, but mostly they show no self-restraint. Programming leaders consider those traits the underlying male character. Candidates are tested repeatedly and depending on their stronger urges, they are assigned to either political party. **Those who passed numerous tests become some of our political leaders.** If they show no preferences, they are not included in political roles that these groups control. How old they are when finally assigned may be fluid. They chose many potential candidates as youths, knowing that the majority would fall away. There may be new methods of testing now.

Since I was not deemed to be in line for political office, I did not undergo this kind of testing. However, I was forced to watch some of it and participate. They would place a dish of ice cream and a slice of chocolate cake in front of the tested youths. They also placed a drugged cat or small dog in front of the children. The administrators told the children to eat all of the desserts and to twist the legs of the lethargic animals. They then measured the speed, and which tasks they performed first. Then they asked the children if they would like to repeat any of the tasks. Afterward, the children were hypnotized and the **testers ascertained the children's preferences from what they stated in a trance.**

There were lines of **sexualized adolescent and young adults displayed at later political rituals.** This kind of line-up could also serve as a trigger. Some of these housewives did not have to be coerced to play their role. For a minority, some part of their mind-controlled brains seemed to relish exhibitionism. They came alive and swelled into their truer, less depressed beings. I suffered during this memory retrieval, but not as I suffered when I had to live through it. I understood early on, the shape of my world. While others learned trust and had okay parents, I understood deceit and betrayal. **Those who trusted, often don't see the deception in our world leaders, and those who learned mistrust may have trouble seeing good in people.**

During the second political dinner party-rituals, children were intentionally terrified. They based their sadism on the pathways programming. Here children, sometimes blindfolded, were forced to walk down the long halls of mansions. Men and women would jump out at them. They also used murdered animals to scare them, then laughed at their child victims.

Yesterday I cried most of the day off and on. Someone inside, some part of my brain, said there were sacrifices at the second's party-rituals. They were similar to the ones in the basement of a revered New York City hotel. During the first's party-rituals, there also were sacrifices. I had different robes, but for sacrifices I had to wear a black robe, occasionally a white one. There was a sacrifice during every ritualized 'party' -- its victims all ages from infants to middle aged, all races. [I found the above on Neil Brick's website: ritualabuse.us.
