In 1960, John F Kennedy ran for president against Richard Nixon and won. The honesty of that November 8th election leaves room for doubt; my grandfather Joseph P had ties to Chicago's Mayor Daley who controlled some of the unions. The electoral college vote was 303 Kennedy, 219 Nixon.

Anyway, what did I care? Just 17 days later I entered the world -- on November 25, 1960. My childhood in the White House was as happy as could be. Even after my father's assassination in 1963, I remained close by my mother's side, for a while.

The story I will tell below contains information about deaths in the family, ones that have been hidden from the public. There is no point hiding it any longer. The truth won't kill anyone, and it may bring relief -- or even a major turn-around.

I recounted part of my story in the book *Stolen Identity* (2023). Jackie Goldman assisted me in writing it. I had been trying to "step forward" since 2019, or earlier, but was, naturally, not believed. That book made it possible for podcasters to offer me an interview, for which I am deeply grateful.

Because of MK-Ultra, I have many gaps of memory. Almost the entire chunk from age 14 to age 30 is missing. Some memories are starting to come back, however, as is happening to many mind-control survivors. And I have a woman friend, Robin, who helps me figure things out, and is a source of joy.

Any help with my court cases would be appreciated.

## TIMELINE OF EVENTS from 1917 to 1974

**1917.** **John F Kennedy** is born in Brookline, Massachusetts, to parents Joseph P Kennedy and Rose Fitzgerald Kennedy.

**1937-1940.** His father, “Joe,” is US Ambassador to the UK.  
**1940.** John graduates from Harvard, *cum laude*, joins US Navy.

**1947.** John elected to US House of Reps for Massachusetts’ 11th district, then elected a **Senator** in 1953.

**1953.** Marries **Jacqueline** Bouvier. Child **Caroline** born 1957.

**1960.** John wins November 8 **election** against Dick Nixon.

**1960. John Jr** [That’s me!] born prematurely, November 25.

**1961-63.** The Camelot Years: **Americans proud and happy**

**1963.** Jacqueline gives birth to **Patrick** Bouvier Kennedy on August 7. Reportedly, baby dies Aug 9, hyaline membrane disease.

**1963.** President **assassinated** in Dallas, November 22. John’s saluting father’s casket (on his 3rd birthday) becomes iconic.



**1965.** John Jr is placed near Fresno Cal, with Quigley family, and is given the legal name of **David Keith Quigley**. He’s “bought” by a powerful ‘federal agent’ code-named **Wayne**.

**1965-1988.** Suffered in the **MK-Ultra** program for many years. Sometimes stayed with mother Jackie in New York. Attended first grade at St David's New York, then Collegiate School.

**1971.** But, amazingly, **John's 'double'** is also at Collegiate. Two students with identical names: John F Kennedy, Jr. (Huh?) The origin of that other boy will be discussed in Chapter 12. His birthdate was March 1960. In 1983 he graduated from Brown University in 1983, became a NY District Attorney, and published **George** magazine. So he will sometimes be called 'George' in this book, or 'the fake JFK Jr.' In 1999, he died in a **plane crash**, at age 38, with his wife Carolyn Bessette.

**1968.** Assassination of **Robert F Kennedy**, and a few months later, the **marriage of Jackie** to Aristotle Onassis. John was pleased to gain step-siblings Alexander and Christina. From 1968 to 1975, John was sometimes on Skorpios Island with Mom or in NY with Mom, or else with Quigleys in California.

**1973.** **Alexander Onassis**, age 24, was shot dead in a plane, as witnessed by John. Ari ordered John "Never, ever, tell or we'll look weak." The public was told it was a plane crash. Note: This book avoids repeating things covered in *Stolen Identity*. However, the **three murders of 1975** are vital, so:

I, MM, will state them in the way JK saw them, at age 14. I have not researched their validity, but they strike me as plausible:

**1975. Death of Ari.** First it should be noted that both Jackie and her spouse Ari moved to Bullhead City Arizona, perhaps out of fear of being killed in Greece or NY. One day, John saw children carrying axes to a yard where Ari was alone, and a man carried a video camera. John says the kids were told to do the murder. They'd be caught on camera, to blackmail them. Thus, **Ari died**. Media said he died in Paris of respiratory trouble. The media have the capacity to fool us about everything.

**1975. Death of Martha Moxley.** It's undisputed that a girl in Connecticut died by being beaten with a golf club, within a block of the house where the Skakel family lived. A nephew of Ethel Kennedy, Michael Skakel, was convicted (probably wrongly) of Martha's murder. John says there is a possibility that Martha was really his sister **Caroline**. Martha was 15 but if it is Caroline, the girl's true age was 18. John Junior isn't sure about it, but he estimates that the last time he saw Caroline she was age 10 or 12. He thinks she was replaced by the lady we all know as Caroline Kennedy Schlossberg, who is now an ambassador. I [MM] am sorry about challenging her.

**1975. Death of Jackie Kennedy Onassis.** Starting even in the White House there was one or more body doubles for Jackie, including her press secretary Pamela Turnure. John's real mother (who, he says, was bullied and given LSD) **died in 1975**. It took place in Bullhead City and was by gunshot. John heard the noise and found Mom on the ground. After this, he, at age 14, hid on the yacht, with Christina's kind permission.

**1988.** Christina died at age 37, survived by her daughter Athina.

**1994.** It was announced that the Jackie who lived on Park Av died of lymphoma. The public mourned her (as we always unquestioningly do). She is buried in **Arlington Cemetery**.

**1999.** Fake JFK Jr dies, **piloting a plane** that crashes near Cape Cod. His wife Carolyn Bessette and her sister Lauren also die. The real John Jr [that's me] is also on the plane, but survives.

## Chapter 1. Introduction to Part I: What I Can Offer?

My father had just a bit more than 1,000 days in office. All around him, people were feeling something new. The feeling extended overseas, too. Because I was only two, going-on-three, I can't claim to have been aware of "The New Frontier", "the Peace Corps," or any of his policies. At this late date I am only hearing about them. And noticing his strength.

Evelyn Lincoln was Kennedy's personal secretary from 1953 until he died. On November 19, 1963, her diary records: "As Mr. Kennedy sat in the rocker in my office, his head resting on its back he placed his left leg across his right knee. He rocked slightly as he talked. In a slow pensive voice he said to me, 'You know if I am re-elected in Sixty-four, **I am going to spend more and more time toward making government service an honorable career.** I would like to tailor the executive and legislative branches of government so that they can keep up with the tremendous strides and **progress being made in other fields.** -- from Evelyn Lincoln's 1968 book, *Kennedy and Johnson.* [Emphasis added]

I am 64 and my last 50 years were pretty tough. Still, there are crises of this nation that must be worked on urgently, and I see some ways to get started. One is "a restoration of truth-telling." That would turn things around quickly, wouldn't it?

Another theme I can contribute, based on my particular biography, is “Let’s start caring for each other.” Or to paraphrase a famous American: “Ask not what your country can do for you. Ask how you can give some love to those in need of it.”

To prepare for this book, I surveyed umpteen old photos and was touched to note the expression of very great sadness on the face of people at President Kennedy’s funeral -- including Army and Navy men. In this book I give my impressions, partly as in Insider, of what is going on at the top – with those Illuminati people who make decisions. Not that I knew them pre-1963. 

## Chapter 2. I Thank God for My Detached Earlobes!

This will be a short chapter, as it exists only to make one point, *viz.*, the little boy whom everyone saw in the White House, had a certain type of earlobe known as “detached.” Clearly, he must be the real son of the president! Not because he has detached earlobes, but because it would have been impossible for photographers to doctor so many photos ‘retroactively.’

Are you with me? The kid shown above with Jackie is indisputably JFK, Jr (myself). No one makes any argument against *that*.

So where did he disappear to? And how is it that when he reached 15 or so, the newspapers started to show a different boy, with that name, in photos with his sister Caroline?

Unless transhumanism occurred sooner than we realized, that teenage boy is a substitute. We call it, in the trade, a Replacement. Oh, which trade is that? Um. It may be either “Identity Theft,” done for money. Or sometimes there are “baby swaps” in which a baby gets inserted into another family, with a plan for him to emerge later. I think in my case it was Identity Theft. I hypothesize that the Mafia knew that President Kennedy was

very wealthy and that it would be possible to kill off his son, insert a new one, and that son would inherit the money.

Naturally I was too young to see exactly what happened, and I may be wrong that the motive was money. But rest assured that the dark-haired man shown on the previous-page cannot be the son of Jacqueline. Her real son has *detached* earlobes but that guy has attached – see? Which kind of earlobes have you got?

### **How Did ‘George’ and I Meet?**

As stated in this book’s Timeline, I was effectively orphaned when my mother was killed in 1975. But even before that, as early as age 5, I underwent the torture known as MK-Ultra. By now it’s “declassified” that the CIA conducted that kind of mind control (which involves electric torture, gas-lighting, starving, and other terrible things). My memory of it is hazy.

However, I do recall meeting “George” when I attended the Collegiate School in New York City near my (widowed) mother’s apartment. You won’t believe it, but both of us boys attended that school using the same name: JFK, Jr. You could ask them to explain it.

I am calling him George in this book to relieve the need for sarcastic quote marks 'JFK'. It's based on the magazine he later edited called *George*. In person I don't know what name I called him. Here's a photo that a French Canadian recently sent me (*merci!*), that shows both of us boys, plus 'Caroline,' in a boat.

The girl, who looks like my sister Caroline, is a Replacement. On the very day, in that very boat, she told me she did not want to see me anymore as she knew that "They" were planning to 'un-alive' me. It's miraculous that I did not get un-alived.

If you meet people who say I'm an interloper or a mental case, please tell them that I admit I haven't yet got the proof that I am Jackie's baby. But there is conclusive proof that George is *not* Jackie's baby. And what is that proof? Attached earlobes.

So far, contributors have given me \$2,600 to obtain a DNA test, but the lab in Colorado took that money and won't give me the results. I apologize to -- and am grateful to -- the folks who have been showing much care. I won't let you down.

## Chapter 3. My Days As a Child Actor in Hollywood

If you are old enough, you may recall seeing me on TV-shows *Adam-12*, and *Mayberry-RFD* (with 'Gomer Pyle'). Many of these shows are still available; some are on YouTube.com.

Since going public on podcasts, I have received material from kind citizens, to help me prove my identity. A very valuable one was found to have been published by NBC. It shows that I was a child actor from around 1968 to 1972, using the stage name "Richard Steele." You can find it at Archive.org.

I was also in commercials, possibly including Wrigley's Double Mint Gum. I don't claim to have played leading roles -- only small parts. My age was 7 to 11. I met the real John Wayne at Hollywood rehearsals and he was very impressive. Actors who knew me then were aware, I believe, that I was the son of the late president. That didn't create a troublesome issue, as my Replacement had not yet made his debut.

'Wayne' is my code-name for a man who was assigned to me as a child and watched out for me as an adult. He was powerful in many organizations including military, the casino business, and Hollywood. It was he who introduced me to music stars and actors. They all seemed to know him and they obeyed him. He saved my life. I think maybe his father was big in the mafia.

For sure, Dolly Parton knows my story and I think so does Kevin Costner, Rosie O'Donnell (with whom I had a few fights), and Clint Eastwood. Others whom I remember who would likely recognize me: Kid Rock, Jim Fallon, Ozzie Osborne, Reva McIntyre, LaToya Jackson, and Hank Williams.

Some of them were hurting, like me. Most were MK-Ultra'd. And don't forget that Mel Gibson and Corey Feldman have said that child abuse is institutionalized in Hollywood.

Here is the lovely document made by **NBC**. It helps a lot since it lists me as both John Kennedy, Jr *and* David Quigley:

In 1980, I was in Australia with Wayne when *Roadgames* was being made. I was 20 and Jamie Lee Curtis was 22; she is the daughter of Tony Curtis. She was in the movie, but I wasn't -- I just helped out with props. I called Jamie my sister, and I am sure she will stand up for me.

Note: Grandpa Kennedy had big investments in Hollywood.

## Chapter 4. Conspiracy Theories of JFK's Assassination

The guilty party to my father's assassination in 1963 must be a compound of all the government personnel who refused to examine the evidence in the well-established ways of justice.

The main body of inquiry consisted of the Warren Commission, headed by the then-Chief Justice of the United States, Earl Warren. Two members, Alan Dulles (head of CIA) and Gerald Ford who became president later, were extreme tormentors of children. I'm mentioning that to alert you to the fact that "official commissions" for anything don't necessarily contain honest persons. More likely the opposite.

In 1964, the "**Warren Report**" came out. It was backed up by 26 volumes of testimony. However, Sylvia Meagher (1921-1989), an official at the WHO, made an index-card collection of the material, and found that the final Report didn't accurately reflect the contents of those volumes. Thus, from the beginning, someone was covering up. Note: coverup is a crime.

In 1976, the House of Representatives took it upon itself to establish the **HSCA** -- House Select Committee to do "a full and complete investigation of the circumstances surrounding the deaths of President John F. Kennedy and Dr Martin Luther King, Jr." who was shot dead on a hotel balcony in 1968.

The conclusion drawn by HSCA was that Lee Harvey Oswald was guilty, as Warren Commission had said, but that he seemed to have had a helper and therefor a conspiracy is “probable.”

Next we had The President John F. Kennedy Assassination Records Collection Act of 1992. It ordered the executive to release all the files. So there you have the proper chain of command. The Congress is the People’s branch of government. I’m a People and have a right to know what is known about JFK.

The Act allowed for some material to be held back, due to National Security concerns [?]. Presidents Trump and Biden did release thousands of documents but with huge redactions. Retired Judge Andrew Napolitano says that Trump told him that he was *shocked* when he saw what is still secret. Let’s have it.

## Prominent Theories

The first theory of the assassination, which was spread by the media and therefore supports the official narrative, is that Cuba was involved. Since the Cold War was a major cultural theme in the US in the 1960s, people readily believed anything about The Communist threat. Over the decades, many theories were proposed and over two thousand books written on the subject. (Whilst, may I interject, no book was being printed on “Where Did Junior Go?”).

There was never a trial. Oswald was killed on November 24, 1963 by Jack Ruby, so no one has ever been subpoena'd to tell what they know. Along the line of circumstantial evidence, we have the book *Hit List* by Richard Belzer and David Wayne, listing 50 deaths of likely witnesses or whistleblowers. These include journalist Dorothy Kilgallen, scientist David Ferrie, and strippers from Jack Ruby’s Carousel Lounge.

Of many books blaming the CIA, one is by ex-CIA man Fletcher Prouty. Some blame CIA man James Angleton, who

was a friend of Israel and this leads to Laurent Guyenot's *The Unspeakable Kennedy Truth* which blames Ben Gurion -- re JFK wanting to halt Dimona, Israel's "factory" of nuke weapons.

A main guilty party must have been LBJ, as he got what he wanted, a sort of accelerating of the 1964 election. His mistress Madeleine Duncan Brown wrote a book in 1987, *Texas in the Morning*, claiming that LBJ said to her, the night before the assassination: "After tomorrow, those goddamn Kennedys will never embarrass me again." He was referring to both Dad and Uncle Robert who, as US Attorney General, was hounding the mafia, and had even deported Carlos Marcello.

Since the mafia had also helped our family, this was deemed a betrayal which, among mafiosi, calls for clear revenge. Because my life experience involved suffering under the mafia, I should be pleased to blame them for anything. However, I lack any direct knowledge about 'Dallas.' I was only a toddler in '63.

One possible player remains out there and she could now be called to give testimony: Ruth Paine, age 92. I have seen a website comment: "Ruth is a paine in the assassination."

Note: I can testify about murders that I witnessed of Alexander Onassis in 1973, and of my mother Jacqueline in 1975 and my stepfather Aristotle Onassis in 1975.

## **A Wrongful Death Suit**

I can file a wrongful death claim re my father. (You may recall the Goldman family did so for the death of their son, against OJ Simpson). Clearly I am the sole survivor of JFK -- unless, possibly, Mom's baby, Patrick Bouvier Kennedy, didn't die but was sent into hiding like me. I'll talk about baby-swaps below.

Oh, Brother, hope I'm not encouraging fakes to come out...

## Chapter 5. My Sweet Son, David R.

Now I'd like to tell you an even more hard-to-grasp story. It is about my dear boy, born 1988. He died 6 months ago at age 36 and I should be in mourning. However, the pressure to get other things done as fast as possible today means I am not giving him his proper due.

It was lovely to have his companionship for all those years. When a baby is first placed in your arms, you fall in love with it. And you start to imagine his or her future. This is true whether the child is adopted or natural born, and even some foster parents get completely attached and love their 'ward.'

When David called me "Dad" I was thrilled. By the way, don't forget that for much of my life I have been operating as David Keith Quigley. (I was told it was a name assigned to me under a Witness Protection arrangement, but I don't really know.) I was said to be the child of Max and Dorothy Quigley, who had no love for me whatsoever. We lived near Yosemite Lakes, CA.

**The Right To Life and the Right To Procreate.** If you don't want to hear sad stuff, that's OK. Just jump over this chapter. It is about what took place when I was age 27.

There was a plan, apparently, to make me become the legal father, but not the biological father, of a child. How to do that? First, I was forcibly vasectomized. It took place on a kitchen table and made me ill for two weeks. The amateur surgeon, Charlie Brown, was later killed, as far as I can figure out.

Second, I was dragooned into a marriage. I was given some drugs and then taken to the Northern California home of the grandparents of my then-girlfriend, Lisa. They had set up a Las Vegas chapel wedding ceremony for us. We went to it and we did the legal thing, complete with a wedding cake.

Subsequently, in 1988, Lisa birthed a child. Oddly, she took it to Vermont and swapped it with a friend's child. After two weeks, she brought that other boy to me. I named him David R, and cared for him until he was in school but I had no money. (Absolute impoverishment is part of the MK-Ultra' experiment.') Later, Dorothy Quigley got full custody of my boy.

Although I was a long-distance truck driver, I came home as often as possible to see David R, my dear son, and I will miss him. In his adulthood we did everything together.

We have high heat in Arizona, over a hundred degrees. In July 2024, David passed away at home. I was not there. By the time I got to him, he was sitting on the sofa, deceased. Evidence suggests he had been outside doing exercises, in high temperature, and suffered heat stroke.

Yet it could have been a programmed suicide. The thing known as 'programmed suicide' does exist – a person is unfairly planted with a code that tells them when to kill themselves. By the way, I, and many others, are walking around with chip in the brain that allows our controllers not only to see what we are doing, but makes it possible for them to control us long-distance, such as by buzzing us when they need us to wake up.

## Chapter 6. Did Grandpa Joe Have Illuminati Morals?

When this book gets printed, it will no doubt cause an outbreak of criticism of the Kennedy family. Let me pre-empt that! This chapter is about Joseph P Kennedy. It is also about the Illuminati and its moral code which completely *opposes* virtue! I need to fit myself into this picture. I am not a saint. There are no saints. Every person, like every animal, tries to survive. For humans, this may mean using virtue (which brings support from one's community), or may rely on selfish calculation.

For a half century I've been more or less alone -- from Jackie's passing in 1975 to today in 2025 when I suddenly have friends, thanks to Internet publicity. I know that I am craving a role in society where **I can at least rescue the many people** who have been as controlled as I was, plus share some high ideals that seem to come naturally to me. I have a warm heart.

The book at hand, as you can see, is a shared book with Mary Maxwell. Mary told me, when we first met in November 2024, that she is not here to help me, she is here to "use" me. In writing this book, we're happily using each other, for example, I'll now draw on her knowledge of the Illuminati.

Using Fritz Springmeier's deep research, in *Bloodlines of the Illuminati*, we see that the Kennedy's are from both Scotland and

Ireland. Their name was also spelled Caeneddi and by 1500 they married into royalty. I have not yet found out how “Joe” is an American representative of the Illuminati, or whether he took orders from above. Someday I may get into that research.

For now, I think he was more like business-mafia than like a “World Orderist.” Mary Maxwell tells me that my story so far -- which means material in my book *Stolen Identity* plus remarks I have made in several interviewers -- has made her think that by the 21st century the mafia guys and the World Order guys must have merged, in order to protect each other.

**Grandpa Joe.** By the time Joe -- my father’s father -- was born, in 1888, there had already been a generation of political involvement in this family. Namely, his father PJ Kennedy had been a ward boss in East Boston. Politics was a standard way for Irish immigrants to get power.

I do not yet know much about Joe’s life. I met him, of course, because we all assembled regularly at ‘the Kennedy Compound’ in Hyannis Port (a boat haven in Cape Cod, Massachusetts). There are now many histories of the 35th presidency in which it is claimed that Joe pushed JFK into politics and that he gave many firm instructions, such that Bobby must be appointed Attorney General. By the way, someday I may find out if Joe had any part in my getting the name “Quigley” in 1965 or so.

Grandpa has got much criticism for sending his daughter Rosemary off to be lobotomized. This incapacitated her, but it motivated my Aunt Eunice Shriver to found the Special Olympics.

## Sexual Morality and World Order

When Joe married Rose Fitzgerald, who seemed to get her strictness from Catholicism, there might have been an agreement that he could keep mistresses. She put up with it. I have read that she allowed a mistress to go on vacation with them! It could also be that he had a sexual addiction. I think JFK’s need for extra-women may have been an actual addiction. Joe was mean to his lover Gloria Swanson. He contracted with her to produce a movie together. She did not read the fine print that made her liable for all losses, so she ended up in debt.

My chapter title, *Illuminati Morals*, hints at something bigger. It is known that some branches of Illuminati are devil worshippers. In fact **satanism** has recently been outed in connection with **child trafficking worldwide**. The gist of satanic belief is, as Aleister Crowley put it “Do what thou wilt is the whole of the law.” *Paraphrased*: “We smarties think morality is stupid.” I do not know if my family had any satanic involvement. ## Chapter 7. And So to MK-Ultra

As you'll see in Chapter 9, I had the strength to survive a plane crash in the ocean. Maybe it's thanks to my basic training in both Army and Navy Special Forces. I am a strong dude. It's also possible that some of the victims of MK-Ultra are able to make up their mind to *not* be defeated, even by torture.

This chapter is not about me, but about MK-Ultra in general. You can see the video of Mary Maxwell interviewing me about my experience. She says she wasted her money traveling to Arizona to inspect me, as she already knew from my book that I had been 'under' (that's a name for mind control or hypnosis).

To sum it up, MK involves taking your life and ruining it. It involves hurt, humiliation, and hunger, plus sexual abuse, terror, and using you for their needs whatever that may involve. The perps include politicians, psychologists, doctors and nurses, priests, military personnel, just about anyone.

### The CIA (What the Hell Is the CIA, Anyway?)

You are free to doubt anything I say, of course, but if you doubt what the CIA did on mind control, you can just hop over to their website, [cia.gov](http://cia.gov), where they admit their horrors (with no apology). This includes radiation experiments carried out on children and soldiers, and dispensing of LSD to the unwary.

CIA also gave syphilis to Tuskegee men, and Abu Ghraib pix show CIA torture and military dogs. (Did you try to stop it?)

In 1976, Senator Frank Church held hearings on mind control. The program used on me had been called Project Artichoke. But in 1953, it was renamed MK-Ultra. I've only started to come out of it and won't add to the literature yet. I offer instead some quotes for survivors who published books:

**On suppressed memories.** From Juliette Engel, MD, *Sparky, Surviving Sex Magic* (2020), p 194: “The Aeroflot charter landed and our group of Americans was escorted into Moscow. I’d never been to Russia, but it looked familiar...I could read the street signs in Cyrillic. Russian words kept popping out of my mouth. I pointed out where ancient churches along the river had been torn down. Then I recognized Taganskaya Square. I heard the clicking sound of a wheel and a remembered voice said “You’ve made it! Good work.” I asked my KGB host “Are there tunnels under here?” “Of course, we have bomb shelters for hundreds of kilometers....”

**On Hope.** From Fiona Barnett, *Eyes Wide Open* (2021) p 155:

“I hear of people giving up hope because they don’t want to live in the emerging social structure in which people are subjected to the same torturous conditions I experienced as a child at the hands of military mind controllers: **isolation, deprivation, confusing and contradicting instruction, loss of identity** and culture, discrimination, shock and trauma, excessive scrutiny, **humiliation, and reduced self-worth.**

“To such fragile folk, I implore: Humanity has been promised that we will never be tested beyond what we can endure. What you experience now, I have endured my entire life. I say with confidence that even in these dark times there is indeed Hope.”

**On Love Bonds.** From Wendy Hoffman, *White Witch in a Black Robe: ... about Criminal Mind Control* (2016) pp 41-42: [Note: Those who run MK-Ultra are experts at giving a child love so they can manipulate this later. Wendy Hoffman speaks of her friend Daniel, who was ritually sacrificed at age 13. He had been her only way experiencing the love of a caring soul]:

“Even though the criminals made us get rid of body parts together, the year I spent with Daniel (he, 12, me 3) became the year of my connection, the year of learning about love. Take me as a child who know only about torture and betrayal take a depleted, harmless 3-year-old and add the heartbeat and genuineness of a grieving boy.... I imagine they calculated that this grief and anger would motivate my murdering people. [Such a goal!] But the pressure of his heartbeat never left me.”

Hoffman: “I continued my awful life ...I thought I walked alone... but at times ... when in the deepest despair or an assignment overseas or in the black chair that administered electric shock... or while walking in luscious, invigorating nature, I would, out of the blue, feel a curtain fall over my face ... covering me with an adoring kind of caress... My eyes well. Then he never left me. Daniel said he would be with me always. Sixty-eight years later I still feel his heart giving birth to mine and turning me into a human being.”

**Sexual Addiction.** Anastasia Sprout spoke out, in her 2015 book *Naked in Public*, about sexual addictions, but she did not discover until later that a person can be mind-controlled into it. She also verifies tunnels: “Driven to Paine Field by the Everett WA Boeing Plant to an elevator, to a tunnel far, far below ground. With two men, I boarded a magnetic levitation train to the *Las Vegas underground*. This place was a massive Death-Cult nest that I believe remains in criminal use there to this day.”

**On Recontact programming.** From *Svali Speaks*, by the marvelous Svali, a former cult programmer, at [omnia-veritas.com](http://omnia-veritas.com):

“All Illuminati members have recontact programming. It is never left to chance. The group has put in years of effort into training them. They may be given false screen memories. Hang up calls, three or six in a row, or calls where a series of tones are heard, may fire off internal programming to make the person come back to the cult. Birthday or we miss you cards may be sent.” [At one point, the Quigleys said “We miss you. We love you” and sent me \$5000 to travel back to them – JK.]

**Multi-generational Incest.** Note: It’s not always CIA. There are families who have been doing “intergenerational incest” and/or satanic ritual abuse for centuries. Wendy Hoffman connects her torture in New York to Josef Mengele of Nazi fame, (yes) but her grandfather was a pro at it. Fiona Barnett says some Slavic immigrants brought sadism to Sydney after 1945.

**Exhibits.** Please read exhibits at the end of this book: Gunther Russbacher shows how they can wipe an old personality and insert, or “overlay” a new one. [This did not happen to me. I doubt I underwent a change – JK.] Svali who programmed many, describes Illuminati plans for world takeover. James Perloff validates that point. Mary Maxwell describes an imaginary bootcamp for elites. Anneke Lucas mentions revenge. Wendy Hoffman discusses satanism in the two political parties!

## Chapter 8. Cousins: Bouvier, Radziwill, Kennedy

I have 25 living Kennedy first-cousins, most of whom I've met, and many Bouvier second cousins. **Janet Norton Lee** (1907-1989) wed **John Bouvier** (1891-1957). They had two kids, Jacqueline in 1929 and **Lee** in 1933. John was a 'name' on Wall St. Janet was unhappy with his infidelity, so high-tailed it off, later marrying Hugh Auchincloss, an heir to Standard Oil. She and Hugh birthed more kids, giving Jackie half-siblings. Mary, daughter of Janet's sister Marion, married a Vanderbilt.

I see from a very fine 1993 book, *The Bouviers*, by John Davis, that Michel Bouvier, in France, had been a soldier for Napoleon, but in 1815 came over to US. He had ten kids which led to at least 60 descendants of which I am one. Apparently I also have umpteen cousins in France, near Avignon. *Bon jour!*

Aunt Lee married Prince Radziwill, the title being a remnant from the Holy Roman Empire. It is said that Lee had Onassis on her dance card and was jolted by my mother's 'stealing' him. That may be garbage. I recall Lee on Ari's yacht. I hereby say that I believe she died in 1975 and was given a Replacement. Lee's son Tony died in 1999; luckily her daughter Anna is alive.

**John:** Caroline, John Jr

**Robert:** Kathleen, Joseph P, II, Robert, Jr, David, Mary, Michael, Kerry, Christopher, Matthew, Douglas, Rory

**Ted:** Kara, Ted, Jr, Patrick II *[I suspect Sen Ted was a Replacement]*

(Of the 29 children above, Caroline disappeared, David died of overdose, Michael died in a ski accident, Kara died of cancer.)

**These became officials in politics, or wives thereof:**

Kathleen Kennedy Townsend was Lt Gov of Maryland.

Mark Shriver was member of Maryland House of Delegates.

Joseph was US Rep from Massachusetts.

Patrick was US Rep from Rhode Island.

Robert F Kennedy, Jr is current US Secretary of DHHS.

Kerry Kennedy was married to Mario Cuomo, who later became governor of New York. Maria Shriver married Arnold Schwarzenegger, becoming First Lady of California *[I think Maria Shriver may be a Replacement. It's more common than you'd think.]*

Any cousins wanting to talk to me, I am all ears. And earlobes.

## Chapter 9. The 1999 Plane Crash Near Martha's Vineyard

Here is a transcript of Mary Maxwell questioning me, unrehearsed, on Nov. 14, 2024. Note: When I say 'John' I am referring to my Replacement, 'George.' There were 4 of us on that plane.

MM: We are here in Arizona at a truck wash, and I have asked Mr Kennedy if he will show us ... what happened on the night of the plane crash. I must say I didn't believe it when I first read it in his book [*Stolen Identity*]. For one thing, I thought if a plane is underwater, you'd have no hope of opening the door against the pressure.

So I'll ask him to explain that, and ask him to as to how quickly he thought about what he should be doing. Apparently, he's no slouch. OK, here we go. Mr Kennedy, please sit on the edge there, like you are doing, and pretend you are in the seat of a helicopter. Now where would your shoulders be?

**JK.** Uh, it was actually an airplane. MM: OK, a plane. So you're in the back seat.

**JK:** Yeah, and it was really tight quarters, just like we are now, and John was the pilot to my [front] left and his wife to the right, yep, and it was really tight quarters so the seats were right at our knees. When John announced that he could not steer the plane, we were in a left-hand turn. Um, the minute he said that, his wife started arguing with him; he started arguing with her.

They were swearing at each other; it got worse, it didn't stop. I told John "If you can't steer the plane, just reduce your speed and we'll just keep going in a circle until we slow down and crash." They were too busy arguing to hear what I said.

I reached down at my feet and grabbed the life preserver. I put it over my head. I put my arms in the position over the preserver in front of my body as a cushion. I put my shoulder and head down behind the seat and I don't know if I instructed Lauren to do the same. Maybe she followed my instructions, but I was already in the position to crash before we crashed.

MM: So what you're saying now occurred before the water was reached by the plane. **JK:** OK, yes, when we hit it was like hitting a brick wall, like a head-on collision. We hit hard. I probably dislocated my shoulder into the back of the seat.

MM: Was there any blood? **JK:** I do not know. I was concerned about that when I was in the water, because sharks are very intelligent: it only takes a drop and they will track you down. So it was a big concern. Um, the door was in the forward position, but like you said we were already on top of the water we had not gotten under the water as soon as we hit I was opening the door. I grabbed her probably by the arm and drug her away.

MM: Was there a question of seat belts? Were you using seat belts during the flight?

**JK:** I was not. I was in the position with no seat belt, already bracing myself. I had the life preserver as a cushion in between me and the ... once we got out, like I said about the same distance as that van there um 20 ft or so, and the plane was like this and we were to the right of the aircraft and it was nose dived into the water and she [Lauren] was struggling with me.

So, we were at the right of the plane, she was screaming she had to go check on her sister, and she was struggling with me. I let her go at that time and as soon as she reached the plane the plane disappeared.

MM: Did you ... **JK:** I never saw the three again.

MM: Now at that point, was it night time? Had darkness to fall?

**JK:** Yes, it was night time. There were clouds and a mist in the air, and the waves were as tall as that white car right there [a small car, maybe 4.5 feet tall]. Once a wave hit, I would float up and I was in this position the whole time, holding the life preserver against my body. When I would get to the top, I would turn my head.

I think I messed up my neck and my shoulder. It was really hard for me to move my neck but I would look for lights in the distance. I thought I had seen a light way off in the distance. Um, once I got to a top and I just started paddling. And the shark concern was really concerning.

MM: And wouldn't you mainly freeze? Was it frozen?

**JK:** It was really cold and I went, I did go, into shock and um my guess is I was conscious for 20 minutes or a half hour. I wasn't conscious long. I was trying to get to shore but after that time all I remember is being hoisted on the front end of a ship, the bow, and covered with blankets.

MM: And you probably were carrying a GPS. Even though that's 25 years ago, you probably were traceable.

**JK:** I probably, as a son of our president, had one at that time, at a very, very young age.

MM: Yeah, OK, and now at the moment of a ship coming for you, did they know who they were looking for?

**JK:** I was so out of it. All I remember is being covered with blankets and what I believe was the captain of the ship walking in front of me pacing in front of me. And I was in shock, they just kept covering blankets on me and that's all I remember that was it, OK.

MM: Well, thank you for the description. Now that night, before that happened, you were waiting on another island, or back on the mainland, to get on the plane? Where were you?

**JK:** I was actually at a truck stop, and a Secret Service agent picked me up, along with John. I didn't want to go; they were like "Come on you'll have fun, we're going to a wedding." I was like "I really don't want to go," and they persisted. And I just was like, what the hell, I got to figure out what this is all about. Um thinking they were planning on killing me. Which, come to find out, they were.

MM: At that wedding. But you were kind of an incidental death to the other deaths, were you? **JK:** I believe that they wanted all of us to die that day, and cover up the whole story, his story, my story, all of it at once, yeah.

MM: Do you think Lauren is really Carolyn's sister? They don't look at all alike. But then I don't look like my sister.

**JK:** I really, I really couldn't answer that. I don't know, OK?

MM: All right, thank you very much. I'm going to end that little interview right now, in the truck stop of Kingman, Arizona.

*Note: I [JK] welcome any challenges to my claims. Note: I [MM] do, too.*

## Chapter 10. Builder, Lumberjack, Cleaner, Trucker, CIA

Let's face it – it's not every child of a head of state who gets to sweep gutters, fill potholes, or deliver parcels in most of the 50 states. None would have a Hell's Angel's patch, or be as tatoo'd as I am. Very few would have been *behind* enemy lines in war. And this head-of-state's kid has no high school diploma, OK?

The guy named Wayne was always in the background, I guess, which must mean that he designed the many set-ups I encountered of getting fired from one job after another. (But at the same time, I am sure Wayne meant to strengthen me as though for an important occupation later; he surely helped me survive.)

**Roofing.** In this chapter I'll name some jobs I did, to show you that I'm a hard worker, and in hopes of connecting to people out there in these occupations. At one point I believe I roofed all the new houses in Yosemite Lakes Park, working for Vic Bright at YLP. I can build a house from scratch. I can do plumbing, electrics, and the pouring of cement. When I was getting \$8 or \$10 an hour for this, around 1990, the same company would pay other guys \$25. Somebody kept me on a leash.

**Lumberjack.** One thing I did freelance – at least I think it was freelance, was to cut down the big trees, not easy. I also sold oak at low price of \$100 per cord. People would buy fire wood even in summer because it cost them \$350 a cord elsewhere.

**Telephones.** Wait till you hear this. Looking back now, I see the pattern. Around 1990, two guys, Silkwood and Bigelow, each started a phone company. Then the Silkwood guy died. Although I was hired only to do phones, they asked me one day to feed the cattle and fix the cattle fences. While I was doing this, their bigwig flew in from New York and fired me for feeding the cattle. Frank Bigelow is a California legislator.

**Restaurants.** This is a nice part. At least there was some food around. I was always hungry. When I was around 30, and my son was a toddler, I got hired as a dishwasher in Broken Bit Steakhouse in Coarsegold CA. It was owned by Dan Landon, bro of Michael of *Little House on the Prairie*. One night Wayne locked me in the basement's liquor-safe. God knows why.

**Toilets.** Let's not mention that I was employed at Pilot Truck Stop in Madera County. You know, if truckers stay there all night (and when I was a trucker, I did) they have to use the 'lav.' I was the cleaner thereof, and of showers. Somebody has to do it and why not President Kennedy's and Jackie's son?

**CIA?** Just think of all the people who get knocked off if they are in the way of the bosses. I was not, as far as I know, a killer for the Mafia. But I have done Black Ops for the CIA. Me and the similarly situated haven't yet gotten any pay for our work. I was a 'volunteer' behind-the-lines in Cambodia circa 1968.


**Submarines.** Later in my career, if you could call this a career, and why not, I found work at a company that made submarines. I am not referring here to the fact that I also was a

**Trucking USA.** I heard there were scholarships available for a 6-week course at Truck Drivers Academy, Fresno, so I took it. Later I started my own truck-driver school. Over the years I've been a long-distance driver. I went east to Cumberland Co, PA, making deliveries of Heinz katsup. The carrier Carlisle also gave me work changing tires on trucks. Eventually they gave me a service truck so I could go around to help truckers in trouble, and repair trailers. I love to be of help.

This photocopy was given to me by Dorothy Quigley. It shows Dorothy as having birthed a boy in 1966. Not me, I was post-

kindergarten at that point. Did she have a boy in 1966? I saw her around that time and she did not look prego. Maybe I can do a DNA test with her... see if we are related.

Most likely this BC is a forgery -- yet California gave me a driver's license based on this photocopy, and banks have given me credit cards based on that license! [!!!] footsteps he bought a downtown saloon and launched his business career and he soon owned three bars and a whiskey import firm. Kennedy became a major figure in the Democratic Party. The last time I recall seeing my dear Caroline alive was around 1969; I was 8, so she was 11. (We have November birthdays.) In due course I may have further memories. I do not want to talk about the Martha Moxley case, but I did say in my 2023 book, *Stolen Identity*, that “Martha” could perhaps be Caroline. Since I will inevitably be quizzed, I will now state things that are on the public record about the murder of Martha. Michael Skakel was jailed for 11 years, but I assume he is innocent.

The Moxleys lived in California. The dad, who died many years ago, was high up in the accountancy firm Touche Ross. The mom who died in 2023, does not appear to have had a career. Her son John Moxley was seen at the trial of Michael Skakel.

In 1974 the Moxleys moved to Greenwich CT. Their house was only a block away from the home of the Skakel family. The dad of the Skakels was a brother of Ethel Skakel who became a Kennedy in 1950, upon marriage to my dear uncle Robert. (And yes, Mom and Robert were close and he looked after me well, so that was another assassination that was hellish for me.)

On Halloween morning, 1975, I was taken to see Martha’s body on the ground. Her hair covered her face. I don’t have anything to contribute. If it wasn’t Caroline, where is she?

## Chapter 14. Needed Remedies for Horrific Criminality

In Part I, thus far, I've referred to many wrongs that were done to me and to others, and which, I think, are technically crimes. I'll now list them, in rough order by date.

**Dallas.** Starting as early as 1961, there was a conspiracy to assassinate the US president. Conspiracy is itself a crime. Then there was the actual assassination, by those who pulled triggers. It must have been preceded by the knowing participation of various persons, who are therefore accomplices to that crime.

For purposes of prosecution, there is no statute of limitations on murder (or treason). The case of my father was never closed. It is an open case today. In this book I have contributed to "the case" tangentially. While I have no expertise on what happened the day of November 22, 1963, thousands of informal researchers have evidence and analyses to offer.

Is there anyone who can file a wrongful death suit? That's a civil lawsuit, not a prosecution. I am the sole survivor of JFK and am willing to file such a suit. I believe my mother would not have been able to file, from 1963 till the day she was murdered in 1975, owing to her great and justified fear of "Them."

JFK was not the only victim that day. Gov Connolly was wounded by the same gunmen. Officer Tippit died from gunshot. Two days later Ruby killed Oswald. All those persons have family members that could file a civil action for wrongful death. And note the many persons who, when trying to blow the whistle, got killed. Murdering a whistleblower is a crime. Maybe it qualifies as treason. Per the US Constitution, Article III, there is a penalty specifically available for treason: death.

A prosecutor can nab anyone who **knowingly covered up the truth** about the assassination. That includes media people and many “investigators.” It may include congresspersons, and members of the incoming Johnson administration.

Barr McClellan, who was a law school student on the day of the assassination, later worked intimately in President Johnson’s office. He says on page 279 of his *Blood, Money, and Power*, (2001) that **LBJ confessed his guilt to his psychiatrist**. LBJ then told his friend Don Thomas about the confession, and Thomas explicitly told this to McClellan. I believe McClellan, age 83, wishes to give testimony about it. He has poignantly stated (on page 273): “And we will bring an end, a sunset, to the darkness planted on our history by Lyndon Johnson.”

No doubt others are eager to come forward with information, to a court or a grand jury, or if necessary to a Citizen-led Truth Commission. I am willing to give my endorsement to such a commission. Ethically, I can’t run that commission as I am not a neutral party, I’m an aggrieved party. But you can do it. As shown in Part I’s chapters, I have plenty of *indirect* insight into the assassination of JFK. My father said, in his speech to the Press Association about the existence of a monolith: “... **It is a system which has conscripted vast human and material resources into the building of a tightly knit, highly efficient machine** that combines military, diplomatic, intelligence, economic, scientific and political operations.” Right on, Dad!

For half a century, I have involuntarily been privy to the workings of that group, at least at a street level.

**MK-Ultra.** And that brings me to another “Commission,” one that may take a large apparatus to run. It would bring out of the woodwork all of the MK-Ultra business to which I was subjected. Congress or any state’s legislature can pass laws today, without retroactivity, to identify mind control as a crime.

They should do so immediately. Why in the world not? The non-emphasis on criminality has allowed millions of people to talk about the whole affair as if MK-Ultra had been a legitimate government activity, albeit covert. The worst that gets said by officials is that it “went too far” or was “a mistake.”

Luckily, the whole program had within it plenty of actions that *are* on the books, as regular crimes: Kidnap. Torture. Bodily assault. Terrorism. Money laundering. Murder. Rape – I was anally raped at age five, as mentioned in my 2023 book *Stolen Identity*. I heard them said “This is how we teach ‘em.”

Also I was sterilized by vasectomy, at age 27, against my will. That was in 1987. Sterilization is the opposite crime to the one committed against females in MK-Ultra -- many are forced to become breeders, having many babies which are usually taken from them at birth. Such children are not registered and can be disposed of by “the authorities” off the record.

**Slavery.** Such children may be used for “organ harvesting,” may become slaves for labor, or sex slaves for pedophiles to use. I think many such kids end up with apparently straightforward day jobs in the ranks of government. My days in Hollywood also tell me that stolen kids are used in the movie and entertainment industry. No one is policing this at all. Slavery is a federal crime, per the Thirteenth Amendment to the Constitution, passed in 1868 when it seemed as though we had put

the practice of slavery behind us. No, we hadn't. I ask you to do that now. We who are (or were) slaves may be too messed up mentally to make our case. Oh, I hereby demand back pay for the labor we were forced to do. Including Black Ops.

**Theft.** Let me bring this list of crimes (only a partial list) to conclusion by mentioning theft. In my case, the "Kennedy fortune" was purloined from me by way of Identity Theft (which is itself a federal crime). Yet even as I was growing up, after my mother's murder, I was daily deprived of money, sometimes not having enough for food. I got low wages or no wages. I think many folks are like that today. "It's how we teach 'em."

I was also thieved of my real identity, my sense of who I am. Luckily this has now changed and I owe it to the many laypersons who have stood up for me, particularly on social media. The righteous indignation of my two co-authors, Jackie Goldman and Mary Maxwell, not to mention the guardian-angel activity of Robin, have probably saved my life.



## Chapter 15. Introduction to Part II: The Rosetta Stone

That stone would have information in "common English" — our daily language — and, right above it, the same material in a heretofore disguised lingo. ## Introducing My Half of This Book

At the age of 77, I was approached by John Kennedy Jr to write a book for him. I had to say No, as I am involved in a fabulous project. But after some coaxing, I agreed that if he’d write a half-book I would do likewise. But I stipulated that my half won’t be *about* him – rather, I’ll use his story as a launching pad.

I have been a socio-biology author for 40 years (*Human Evolution*, Columbia U Press, 1984). For the last 20 years I have been a conspiracy theorist, seeing events through my lawyerly-eyes (e.g., *Prosecution for Treason*, 2011). I’m a maniac for the US Constitution. My many books include ones on false flags, such as the Boston Marathon case, and I am a ‘force’ in exposing mind



Let's get right down to the matter of the fake JFK, Jr. As argued in this book, the dark-haired boy, aka 'George,' can't meet the requirement of authenticity as he has attached earlobes, whereas the little kid in the White House had *detached* earlobes. This goes along with the fact that, in August 1959, Maria boarded the famous yacht *The Christina*, and stayed for weeks with Ari. As each of them had a spouse, a pregnancy would be scandalous. On page 211 of *Greek Fire*, Gage reports his conversation with Maria's ever-faithful butler, Ferruccio Mezzadi:

“Ferruccio indignantly rejected the idea that Maria had ever had an abortion. ‘This never happened. Madame would never have done such a thing.’ But when I asked him about a baby ... and ... showed him the [Milan] birth and death certificates, Ferruccio’s face turned pale and he swallowed hard before asking me ‘Who told you about this?’ When I told him [the baby] had been named Omero for Onassis’ uncle [Homer], he said only ‘I’m sorry but this is something I will not discuss’.”

I am only speculating here but it sounds like that baby was born and I bet it did NOT die -- rich families can get any official record altered. I figure that baby is George, the fake JFK. **Protest.** Why did the triumvirate of Socrates, Plato, and Aristotle arise in ancient Athens? Because the human species had proceeded to the point where logic could come in. An issue could be talked about from all sides. Wholly fictional examples could be examined for their diagnostic clues. Thus there came to be a respectable method for criticizing those who usually

escape criticism: the state, the church, and one's elders. Not that it's easy to be a dissident. Think how long it took Luther to make a stink about the Pope's selling of indulgences (tickets to heaven). "Each time a coin in the coffer rings, a soul from Purgatory springs." Luther started the Protestant Revolution. That's *protestant* as in 'I protest!' and Revolution as in 'I revolt!'

**Job-scared.** As of now, John has not approached anyone in authority re his claim to be the son of the late president. All relevant officials and bureaucrats are expected to freeze up and say "He's a faker; he's got no proof." This could be because they believe their job demands adherence to the narrative.

In a blurb for Mattias Desmet's book *The Psychology of Totalitarianism*, Dr Peter McCullough, a leading dissident against Covid vaccination, writes:

"As I walk through the halls of a major US medical center, I see eyes that divert themselves away from me as I pass. When we [doctors] engage in our usual discussions on patients, the topic of COVID-19 vaccination brings a halting response: 'We don't want to talk about it.'

"I see fear, shame, and a never-ending cycle of groupthink that has been more contagious among physicians than aerosolized SARS in a crowded elevator." [I assume that this holds for all two-million gov't employees – MM].

Mattias Desmet is a clinical psychologist in Belgium. Hush-hushness about the dangers of the (malicious, in my opinion) vaccines for Covid, inspired him to formulate a theory of "mass formation." He means that our thinking stops as individuals and we repeat, like automatons, the propaganda story.

Why would Americans, who founded The Great Republic, be so quick in 2020 to give in to an unreasonable public policy? Per Desmet, we are in a *totalitarian condition* stemming from the following cultural factors [with my bolding]:

“An overall sense of **loneliness** and lack of social connections and bonds,      A **lack of meaning** -- unsatisfying “bullsh\*t jobs” that don’t offer purpose,  
Free-floating **anxiety** and discontent that arise from loneliness and lack of meaning,  
Manifestation of **frustration** and **aggression** from anxiety....”

Well, fine, but there is also each doctor’s selfish calculation, even if entirely sub-conscious, that he may lose his job. I find this also in lawyers, almost none of whom spoke up re Covid. With the naked eye, they could have seen that something was wrong with Medicare giving an extra \$39,000 to ‘health providers’ for putting patients on a (genocidal) ventilator.

What if the law *had* cracked down and, after indicting and convicting some for murder, had them hanged in the public square? Being ‘job-scared’ would then work the opposite way: doctors and insurance administrators would have been scared to give the shots or to assist the deployment of ventilators. Note: That isn’t “far out, man.” It is the mechanism by which us naturally selfish individuals have customarily lived. We make rules. The punishing of sin is the way we learn not to step out of the agreed-upon rules. “An eye for an eye.”



## Chapter 19. Give ‘Dallas’ the “Amen” Treatment

That are many “JFK assassination researchers.” I think they are all missing the boat. It’s been 60 years and the perpetrators have gone unpunished. Why didn’t our nation act in time? I hear you say “We couldn’t act because government prevented us.” Bingo! Super-duper bingo! That’s it! **The guilty party, the government, is able to protect itself**, and did so splendidly. What? Have I just nominated the assassin? Yep. The United States government killed President John F Kennedy.

### **Can We Punish Government, As Such?**

Let’s discuss the very simple matter of holding government’s feet to the fire. We punish laypersons all the time. If your car gets stolen, you will call the police unhesitatingly. “It’s their job.” Even if the wrongdoer is an organization, or an entity such as a ‘corporation,’ it is perfectly possible for it to be prosecuted. By the way, speaking of the killing of JFK, his son John, the co-author of this book, stated in his earlier book, *Stolen Identity*, that when he, John Junior, was at sea -- literally in the ocean -- after the 1999 plane crash, President Bill Clinton called the captain of the rescue boat (Coast Guard? I don’t know) and told him to throw John back into the water. Oh, and Clinton is still alive and can be indicted, tried, convicted ....

If you get directly hurt, you can ask the sovereign state (the US, or one of the 50 states) for “leave” to sue it. Thus, if you tripped on a slippery floor at a DoJ office, you’d probably get leave to sue. An exception is a soldier who is hurt on duty. She can’t sue. In the 9-11 attack on the Pentagon, an army private, April Gallop, was injured but the court dismissed her case.

I think it is common sense that government people not be sued or arrested for doing a lousy job. If, say, a judge had to look over her shoulder all the time, she would stop making firm rulings. But if any of them *commit a crime*, they are as liable as anyone else. **Coverup is a crime**, so all the persons who covered up at “Dallas” can be arrested. A criminal case can be brought from three sources: the police, attorney general, or grand jury.

At all times your state has a 23-person grand jury empaneled. They are ready to listen to suspicions. Word may have come in that A embezzled from B. Per our Fifth Amendment, the grand jury must discuss it secretly, so an innocent can’t get smeared by gossip. But when a case looks worthy, the GJ must pass a True Bill to have ‘A’ indicted. Any citizen can alert the grand jury to crimes and *it’s quite OK if the alleged criminal is a politician or official.* “I just saw Joe hand a bag of 100-dollar bills to my Congresswoman.” Bribery is a crime.

Note: Recently, SCOTUS ruled that presidents have substantial immunity when they are performing official acts. I consider that decision, in *US v Trump*, corrupt. The Brennan Center for Justice assisted “scholars of the Founding Era” to file an amici curiae brief stating the correct view: A crim is a crim is a crim.

**The John Judge Report about Nuclear Code Book**  
John Judge is the son of a woman who worked in accountancy at the Pentagon. She was told a few days after Kennedy’s death that our Vietnam involvement would go through the roof. When John Judge published this, various military people came

to him to confide about what had happened in the air while JFK's body was in Parkland Hospital. Namely, the nuclear code book had disappeared from the relevant Air Force planes.

The theme I wish to record here is "The military killed JFK." I imagine that the nuclear codes have layers of security and this *could not have been circumvented* by any civilians that day. Judge's mother had also said, that at the Pentagon on 22 November, **an inter-agency phone system** that was securable for private or classified discussions, went out of operation that afternoon at the same time news of the assassination reached their offices, and it stayed down for approximately two hours.

So who are our top generals and admirals? They don't strike me as patriots. I assume that they got their promotions by **kow-towing to the globalists**. If the above items prove true about Pentagon activities on the day of the assassination, there's no need for an interloper (e.g., from CIA) to have snuck in to change nuclear codes, turned off the phones, etc. Military *insiders* would have understood "the way the country is run."

Note: On another day of treason, "9-11," when Air Force protocols were amazingly neglected, such as by not sending fighter jets aloft, you don't need to accuse anyone outside the Air Force of collusion. AF General Richard Myers was Acting Chair of the Joint Chiefs of Staff that day and rose to Chairman on October 1, 2001. He got the "Medal of Freedom" too. See?

**Barr McClellan's Understanding of Texas Politics.** Now we turn to Barr McClellan's theory of Lyndon Johnson's guilt. I'll refer to Barr as BMC to avoid confusion about 'the bar.' BMC says Johnson got trapped into doing the assassination, to prevent exposure of a murder he had authorized years before, by Mac Wallace. BMC also says Big Oil was involved. BMC worked as the lawyer to Don Thomas who, in turn, was the lawyer for Ed Clark who basically ran the state's politics on behalf of LBJ -- and on behalf of himself, Ed Clark, as money

seems to be the driving factor for Big Texans. Having read *The Halliburton Agenda*, by Dan Briody, I was aware of the way that personal friendships are key to business deals.

BMC's 2011 book *Blood, Money, and Power* shows how politics works. Let me exaggerate: The governor needs to put his trusted servants into top jobs at the courts (to twist judges), and the prisons (to spring anyone who needs to be sprung). He also needs to have a 'hand-off' man -- think of J Edgar Hoover -- who snoops the sex life and illicit finances of all.

"If you need a loan to start up a small business, go see my Man." Does your sox factory need a big customer? Get Congress to be that customer by legislating that all soldiers will get 6 pairs of sox. "Have you committed a crime? My lawyer will be sure your evidence to be protected under the attorney-client privilege. Also, we are good at changing written records, be it in your bank, your doctor's office, your IRS file."

Anyway, **oil** was discovered in Texas only in the 1940s. Thus a few people became the first billionaires, such as Clint Murchison, who had to make sure the new president, Kennedy, wouldn't carry out the threat to reduce the 'oil depletion allowance.' Billy Sol Estes got rich on **cotton**. This was limited by cotton allowances made by US Dept of Agriculture.

BMC thinks Clark personally planned the motorcade scene. Mac Wallace was to snipe from the window. 

## Chapter 20. What about Using Force? They Use It on Us

John F Kennedy, Jr, age 64, didn't say much in Part I about the force that was used on him. He did say more in his earlier book, *Stolen Identity*, but the pain and trauma of remembering is enough to keep most survivors from working it through. He has said, like others, that he was kept in a dog cage, literally. He also witnessed humans being thrown to hungry pigs! Etcetera.

Here in Part II, I want to offer legal solutions to violence. Fact is, the usual legal solution to violence is violence. I am skipping the happier solution, in which a society maintains a disciplined police force that responds to help victims of the ruthless. John had no way to dial the law for help. He can't do it even now! We often hear that a death of a dissident is suspicious. I think courts should make it **a rebuttable presumption**, in law, that that the death of a whistleblower or dissident individual was homicide. The prosecutor can start by deeming the accused 'guilty,' but give him an opportunity to rebut that presumption.

Pictured above is Gary Webb who released valuable information that the US government was importing crack cocaine and channeling it to the ghetto. He "suicided." Udo Ulfkotte in Germany explained that he, like every other journalist, was paid off by the CIA to report things their way. He died. Mary Meyer knew too much about the assassination from ex-spouse, Cord Meyer of the CIA. Peter Janney says Mary was in a long-term affair with JFK and may be the person who led him on a global-peace mission. J. Kornbluth has made a movie of this.

## The Law of Self Defense

If Webb, Ulfkotte, or Meyer had seen their attacker coming, and had a gun with which to shoot him (or MACE, or any tool), would that have been OK? Yes, the law of self-defense says you may protect yourself or a nearby person from certain harm. (You might get arrested, but the court will acquit you.)

This law does not cover situations where the violence has an intermediary stage. I'll bet there are parents who would happily kill anyone who causes their kid to view pornography in the school's library collection. But parents who protested it at School Committee meetings were arrested as "terrorists."

Given the current setup, justice will not be attainable by violence. Even where people are hungry and homeless, it is illegal for them to steal food. It does not matter if another person or organization **has deliberately starved them**. Same for wrongly administered medicines, including vaccines. Violence against the perpetrator is prevented by *government protection of the perpetrators*. This is the essence of our situation today, is it not?

## The Law of Outlawry

In the 1800s, the Wild West did not yet have a police force. Bandits could get away with anything. Still, potential victims, could preempt theft by killing the bandits. Who was to complain? It came down to "Me or you, Buddy."

Note: There is a **law** of outlawry which has been on the books for centuries. Where an outlaw is unable to be captured by the authorities, or by the hue-and-cry, folks can effect the capture. Wait, folks **MUST** effect the capture. If someone else then interferes, to help the bad guy, THAT person is a criminal.

Now go back to the aforementioned example of parents who can't get help from the appropriate people, such as school committeemen. Are they to be abandoned? Left to watch their kids

suffer? I think this is where, logically, the law of outlawry can come in. And it should come in where the government, in general, protects high-mucky-muck crims. Shouldn't it?

Notice how easy it is for the “Department of Justice” to thwart justice. Sen Rand Paul caught Dr Anthony Fauci lying about something, under oath. Perjury is a crime and there is a separate crime of lying to Congress. Rand Paul used the standard mode of punishing Fauci. That is, he referred the matter to the DoJ, yet Attorney General Merrick Garland replied by silence. Note: Citizen’s arrest is legal in every state. Search your state’s details.

It is disappointing to see almost no law professor putting to the public the matter that I am putting here. Namely, our justice system has a huge flaw in it; it protects the violent and thus it throws the whole philosophy of ‘Murkin law’ out the window.

### ***Hosti Humani Generis***

Let’s go out on a limb. In international law (which in my opinion is a joke because it has no enforcer), there is a principle that was once applied to pirates. Any pirate ship out there is your enemy: it plans to harm you. You can try to do pirates in.

The principle is called *Hosti humani generis*, Latin for “the enemy of all mankind.” It’s in the very nature of piracy to be against the good of the people. Therefore, you won’t be seen to be starting a war against the country whose flag is on that ship. You will be doing all of humanity a favor. Sort of like removing the bandits from a highway in the Wild West – it’s logical.

### **A Philosophical Defense of the Use of Force**

In the Gospel of Matthew, 5:28-41, we find Jesus preaching: “Do not resist an evil person. If anyone slaps you on the right cheek, turn to them the other cheek.” That occurred during The Sermon on the Mount when Jesus was setting a new ethic

of generosity and forgiveness. But give an ear to a Russian man, Ivan Ilyin, writing in 1922 to oppose Tolstoy's pacifism, re 1917's Bolshevism. In *On Resistance to Evil by Force* Ilyin wrote:

P 7 "What would "non-resistance" mean, in the sense of the absence of any resistance? **This would mean accepting evil: letting it in, and giving it freedom, scope and power.** If under these conditions the uprising of evil occurred, it would mean subordination to it, a surrender of the self to it, participation in it, and finally turning oneself into its instrument.

I hasten to say that I [MM] never thought of this. I tend to diagnosed the central problem as conformity -- following the crowd is a strong controller of human behavior! More Ilyin:

P 8 "The non-resistor of evil sooner or later arrives at the need to assure himself that evil is not so bad and that it is not so definitively evil, that it has some positive features.... And when aversion subsides and evil is no longer experienced as evil, then acceptance imperceptibly becomes total: the soul begins to believe that black is white, adapts to match, becomes black itself.... P 184: "When a person **enters into conflict with villains** and resorts to force, the sword, or cunning, he has [no] right to lay aside the burden of decision and transfer this to the divine. **The man who fights villains must evaluate all the conditions... understanding that he is forced to resort to these means....**" [Emphasis added]

Am I approving of the use of force? Yes. The non-violence preachers of Gandhi and MLK just do not cut it. Possibly both those men were planted to teach us to 'stifle it.' Still, I am not saying Go shoot somebody. Who is available for you to shoot? The teller in a bank that is cheating you? The decision to cheat you was made much higher up the chain.

I want you to go through channels! Just like we were taught to do. Please know that your staying away is hurting people bad.

## Chapter 21. *We the People* Can Reenact the Constitution

There's nothing wrong with 21<sup>st</sup> century folks attempting to better their Constitution. In fact our Constitution says so. Its Article V gives the method. There are two ways for an amendment to be *proposed*: One is 2/3 vote in both houses of Congress, the other is "application by the Legislatures of the several States [to] call a Convention for proposing Amendments."

Then, once proposed, an amendment needs ratification. Congress will choose one of these two modes of ratification: EITHER by three-fourths of the states' legislatures (38 states today), or by **conventions** in three-fourths of the states.

We conservatives hope no Amendments will be proposed soon, before peeps get educated, as the Tricksters would very likely put bad things into the beloved parchment. Still, let's get ready in case our state legislatures call for a convention. Let's ask, in general, what should be in a new Constitution?

**Pretend You Are in Philadelphia.** As an exercise, imagine that instead of states each having a convention to propose, and then a convention to ratify, you have been sent with members of other states, to sit in the original Convention Hall at Philadelphia and try to dream up an ideal governance of America. That's sort of what those 55 bewigged guys were tasked with

doing, but only to federate ‘enumerated powers.’ Each state already had a society that was formerly a colony under King George III. But today we can pretend that there is a new tyrant that we need to fight off. For example, a pack of Illuminati-inspired guys who want to run a World Order. They are on the throne, but we -- in ‘Philadelphia’ -- could say:

“I do not fear it, I can have anofe [sufficient friends] to assist me in that afare; let them Come in to my field if they Dare, I will split theaire braines out.”

Thus, Article I of the revised Constitution could say, for example, “We hereby create a legal protection for the country known as USA. We set up a government, to be located in Joplin, Missouri. [Joplin is central, latitudinally and longitudinally. The original choice of land near the Potomac River was arbitrary.]

“Any individual seeking to nullify the sovereignty of the USA must report to the Committee for the Nation. They will be allowed to argue for a globalist position, and then, if they refuse to support our government, will be stripped of citizenship.”

I suggest that doing this, even as pure fiction, **would instill a sense of solidarity** into Americans, and confirm that the rules come from them, based on their wishes for a good life, rather than be imposed by badge-wearers from, say, FEMA, or FBI.

**Updating Our Outlook.** I hope I’ve got you realizing that it is legal to write a constitution today just as it was legal in 1787 -- *because folks decided to do it.* (To be exact, the Framers started out by updating the earlier Articles of Confederation.)

They wisely grandfathered in the whole of English case law, known as Common Law, rather than attempt to rewrite it. But the 13 states each had a constitution and a legislatures to make law. A fresh draft of a national constitution today, or of any state’s constitution, would be a nifty way to get people to own

up to what has happened to law in the last fifty years. The corruption of practitioners both in the political realm and in the legal profession has twisted everything, in my opinion.

Note: The Framers, writing Article I, sec 8, made sure to give only specific powers to the feds. These are the “enumerated” grants of power on which Congress is allowed to make law. If something does not appear there, it is forbidden to Congress.

Our Constitution now has 27 Amendments, of which the first ten are the Bill of Rights. None of the other 17 make any attempt to add a new federal grant of power to Article I, sec 8. Hence, don’t bother to look there for a right of the federal government to rule on medical treatment. Yes, the feds ‘do medicine’ today, but that’s wholly unconstitutional. See?

### **Breaches by Weak Politicians and Traitors**

On the other hand, Congress disgracefully **fails** to use some of its grants of power. See Clause 11 of the aforementioned Section 8. It says Congress “shall have the Power to declare war.” We know from Madison’s notes from Philly in 1787, that the point of this was to deprive the Executive of war-making.

Up until 1952, Congress stuck to its guns, so to speak, and did not let our Army or Navy go on regime-change operations unless it, the Legislative branch, the people’s branch, said Go, go.

Similarly, the parchment made Congress keeper of the **purse**. Look for it in Article I which is the Article for the Legislative branch. (Article II is for Executive, and III is for Judiciary.) I have no idea how recent presidents think they can give \$\$ away.

Note: President Kennedy’s book *Profiles in Courage*, written when he was a senator, is about 12 senators who had the guts to stand up against their fellow senators over an issue. Thus the Presidential Library of JFK is Boston gives awards yearly to any legislator, member of city council, whatever, who breaks ranks

to do the right thing. Y'all are invited – high school students especially -- to submit some nominations. – See [JFKlibrary.org](http://JFKlibrary.org). Two screamingly obvious 21<sup>st</sup> century recipients should be Rep Barbara Lee and Rep Thomas Massie. Ms Lee was the only person out of 535 who opposed the signing of the AUMF on September 14, a mere three days after “9-11” This Authorization for the Use of Military Force handed Congress’s war power to Pres Bush and has been used many times since. See:

“That the President is authorized to use all necessary and appropriate force against those nations, organizations, or persons **he determines** planned, authorized, committed, or aided the terrorist attacks that occurred on September 11, 2001, or harbored such organizations or persons, in order to prevent any future acts of international terrorism against the United States by such nations, organizations or persons.” [Emphasis added]

As for Thomas Massie, he insisted that all Reps come back to DC to vote on the \$2.2 billion spending bill in 2020 when these legislatures had given themselves permission to stay home to avoid Covid. (The next year they exempted themselves from vaccine mandates.) How did the *Washington Post* react:

“During his seven years in Congress, Rep. Thomas Massie (R-KY.) has established a reputation as a uniquely irascible congressional gadfly — one who is frequently at odds with his own party’s leadership [God forbid!] ... is willing to use the House rule book to inconvenience his colleagues.”

For the record, on Nov 5th 2024, I voted Thomas Massie for president, using a write-in, which every citizen can do. I gave the vice-presidency to an Arizona guy, John F Kennedy, Jr.

**Will the Judicial Branch Save Us?** During the thrilling 1960s, we ordinary folk had the vision of justice as coming from the US Supreme Court. It often supported the little guy, in keeping with what are major cultural themes of America: equality before the law, and Rule of Law.

That is no longer happening. I see the justices siding with Big Brother at every turn. In the *Albert Florence* case, where a man was strip-searched for a traffic violation, SCOTUS ruled it OK (to protect prison staff from men who keep a gun up their kazoo?)! In *Kelo v New London*, SCOTUS said if a developer wants your land, he can take it, albeit with compensation. In *Citizens United*, oh please just look it up. They gave the nation away.

Nor does the Dept of Justice (and probably all state DoJs) do the right thing. They say “If a crim is powerful we don’t touch. If kids are trafficked we look the other way. In fact we will ‘legally’ harass anyone who tries to make us do our job.”

**9-11.** The constitutional Branches of government, besides the three in ‘Joplin,’ are the States and the People, and also the citizens in any state who form grand juries, per Fifth Amendment. Re 9-11, architects and others who know how a building may fall, offered proof from a study at Alaska University that the steel beams of World Trade Center weren’t vulnerable to fire.

For a citizen to pass such information about crime to the foreman of his local grand jury, is legal, and traditional Experts went to the court that handled every 9-11 case – Southern District of New York, SDNY, and asked for Alaska’s study to be handed to the Grand Jury foreman. The famously corrupt court of the SDNY said “No way” and **SCOTUS supported that**, by declining to hear a further appeal. Eeks! That is pure treason.

So are we to throw up our hands? Hell, no. See Article III, sec 3, of our very adequate US Constitution. Moreover, life-saving statutes can be enacted by Congress. Back in 1890, they passed the Sherman Anti-trust Act: “Stop with the big mergers already!” It criminalizes the making of “combinations.”

Sometimes one business files a Sherman suit against another but why doesn’t DoJ enforce the crime aspect? Pamela Bondi, the new Attorney General, could go to town with it.

## Chapter 22. We Really Ought To Identify Big Brother

My country is falling quickly. All its good stuff is being torn away. Do I think some Big Bad guys are making this happen? Yes, but I also think the buck stops with me, and with you. I am horrified at peeps' ability to pretend we don't need to act. As Aleksandr Solzhenitsyn said, when he and fellow prisoners were "burning in the camps" (during the Soviet takeover of Russia): "We didn't love freedom enough. We deserved all that followed." So, what could they have done differently? I say they could have had better sense of their dignity and better sense that the conquerors should be resisted, at all costs.

### **Big Baddies**

Yes, there are big baddies and yes, their plans for us are obscene. You'd have thought they ran a contest among themselves: "Who can think up the most outrageous, sadistic way to put an end to any threat that our dear little selves may face from the multitude?" This book has been arguing that the trouble goes back to at least the 1940s for the MK-Ultra stuff.

You can bet it has been around since 1776 when our country was founded. A bunch of guys in Germany, such as Adam Weishaupt, had the bright idea to run a secret society, the Illuminati. (And a case can be made that it goes back to ancient times.) Thanks to them, the US has a fairly large group of palsy-walsies who feel entitled to control the 'cattle' or the 'idiots,' or whatever they call us. Heck, they can remove the son of President Kennedy and put in a substitute and the public won't even notice! Why? Because our media men can protect their secrets while giving us other "topics" for daily consumption. SEE?

## Introducing William Guy Carr (1895-1959)

Carr was a commander in the Navy of Canada. I am going to use his work, *Satan, Prince of This World*, to outline some of the Big Baddies' Luciferian goings-on. He hung around with top brass in the Navy, plus he devoured the conspiracy literature.

One remark Carr made convinced me of his bona fides. He understood that to be at the very top you have to refrain from letting the next-level-down know what you are really all about. (The lower ones can't be trusted.) He said the guys at the very top can recognize one another by "the fold in the handkerchief in their breast pocket." Note: Such men can never relax!

William Guy Carr's earlier book is *Pawns in the Game*. He did not publish his big work on Satan, as he ran out of time in 1959, but his son finished it up and published it. Thank you, son.

## They Think Lucifer Is Higher Than Satan!

Three men are pivotal in Carr's book: Adam Weishaupt, Albert Pike, and Mazzini. I think if Carr had looked at the post-war world, he would have added "Rockefeller." I do not consider Old Man Rockefeller (the oil trust, circa 1880) to have had any belief in Lucifer or anything supernatural (nor do I), yet his **business motives** had the same effect as the Luciferian ideas.

A key idea for us to examine today is the proposed takeover of the world, the New World Order, or globalism. The Rockefeller family in 1945 gave the land on New York's East River for the United Nations building. The UN includes the World Health Organization, from which we have now withdrawn.

Albert Pike may have been simply out of his mind. Or he may have been over-catering to the human instinct to follow through on a plan. He pushed hard, in the 1880s, for Europe and North America to yield the sovereignty of individual states and follow a grand plan for unity. Let's not rule out, too, that

when a big dude gets going, he fears making any slip that could cause people to doubt his power. He must do *everything*. Also, deception and secrecy were essential. In my opinion (but I have no expertise on this), Pike got Giuseppe Mazzini to “liberate” the people of South America from Spanish rulership, in order to give them democracies that are easier for “us” to rule.

Oops, Weishaupt may have done that to Britain’s American colonies, too. A little digging into the record shows that both Ben Franklin and Tom Jefferson, had a particular way to fold their handkerchief. (Or comb their wig, or whatever.) Franklin was often cavorting in London; Jefferson hung out in France.

Carr, on page 67 of *Satan*, says that the Luciferian dogma of Albert Pike teaches us the exact opposite of Holy Scripture. How did he find out? “Raids on Lodges between 1784 and 1924 produced documents which prove conclusively the continued existence of the Luciferian conspiracy to obtain ultimate world domination.” Note: this includes provoking wars galore.

*Proofs of a Conspiracy* (1798) was written by a Scottish scientist, John Robison, a Mason, as soon as he wised up to the facts:

[Robison]: “It is remarkable, that the Germans had been long accustomed to the word, the sign, and the grip of the Masons. **The aim of the Order is not to enlighten the mind of man**.... The more closely we examine the principles and practice of the **Illuminati**, the more clearly do we perceive that their first and immediate aim is to **get the possession of riches, power, and influence**, and, to accomplish this, they want to abolish Christianity. And then, dissolute manners and universal profligacy will procure them the adherence of all the wicked, and enable them **to overturn all the civil governments** of Europe.” [227 years ago!]. [Emphasis added]

Pause for a moment over the word “oath.” This is a marvelous trick. Members of a conspiratorial group are told that their

taking of an oath is the thing that turns right and wrong upside down. Per Robison: “The Order must possess the power of life and death in consequence of our Oath; and with propriety, for the same reason, and by the same right, that any government in the world possesses it: **For the Order comes in their place, making them unnecessary.** . . .” Tum de tum tum.

Back to Weishaupt. He was a Jewish Jesuit who worked for Rothschild. He made a similar use of the Jesuit concept “The ends justify the means.” Wm Guy Carr thinks the “Synagogue of Satan” historically preceded Judaism, and that also the famous Protocols of the Order of Zion’ came not from Zionists in 1890s but from an ancient Order.

We don’t need to study all its manifestations, be they Rosicrucians, Knights of Malta, or the Bilderbergers, or the Luciferian UN. The trick is to realize that there is an overall plan for a One World Government and much of it has been accomplished. (See our Exhibit D.) Albert Pike listed six phases:

1. The first world government shall be turned into “A totalitarian Luciferian dictatorship.”
2. The universal religion imposed upon those of the Goyim (human cattle) who survive the final social cataclysm, shall be “The True Light of the pure doctrine of Lucifer.”
3. That all the Goyim shall be enslaved and turned into “one vast conglomeration of mongrelized humanity.”
4. That breeding will be strictly limited to types and numbers “required to fill the requirements of the state (God).”
5. That all breeding, as far as the Goyim are concerned, will be done by artificial insemination [*aw*] practiced on an international scale, and limited to **5% of males** and 30% of females selected for this purpose.
6. That rigid control of the minds of the Goyim shall “*erase all knowledge of the past, including religions.*”

We can see, happily, that the Internet put paid to Number 6.

And increasing awareness may make all of it fall apart. Still, people are embarrassed to take up this story. Granted, it sounds ridiculous. But the fact is (I believe) that Weishaupt and friends caused the French Revolution of 1789 to happen. See Nesta Webster (a British writer in the 1920s) for evidence that the same Bozos did the 1917 Russian Revolution as well.

The French situation was characterized by The Terror and the Guillotine. In Russia, the takeover artists simply grabbed all property and brutalized people. Are we so ‘advanced’ that we are untake-able via violence? I have no clue as to how to confront the gang, if they invade my home. Henry Kissinger’s preferred method was sort of non-violent: just starve the people.

In July. 2024, when I heard about John Kennedy, Jr, this miraculous Illuminatus who was treated like a dog and who is innocently willing to spill beans, I was so happy. John provides validity to the real story. He’s a key to freedom. There are other folks out there, too, who are doing their darndest to help.

There is a wonderful group called Targeted Justice that is pleading with the new US Secretary of Defense Peter Hegseth to take command of the “experiments” being done (to them and others) in Arizona and elsewhere. ## Chapter 23. Put an End to the Liars' Lying

The reappearance of the real JFK, Jr, has given a *proven* picture of the ability of a few people “in authority” to foist a false story on us -- the ‘George’ story. We are unhealthily gullible. I recommend we train up to reject a falsity the minute we hear one. Trust me, you can really defend against attacks by putting your foot down and insisting on truth. Your listeners’ brain will react to it. And your neighbors will consider imitating you.

Far be it from me to say everybody must become honest. We will never be honest; humans are sneaky little buggers. But we can draw a line somewhere. When powerful people lie, and their lying **enables their takeover of our society**, we shouldn’t be so dumb as to just sit there and take it.

I notice that we have a mental habit of downplaying dangerous moments. Look at the Lahaina fire again. The perps practically held up a sign saying “We know you will fall for our claim that it was a natural fire, and by doing that you line yourselves up for a new hit, Dumbos.” Since that event, on August 8, 2023, directed energy weapons have indeed caused more fires.

At Substack.com (an online salon), Prof Robert Reich, a former US Sec'y of Labor, runs a weekly contest for the best caption to a meme. He draws the cartoon and you compete. Let’s find a prof who can run a contest for The Best Lie of the Week.

**The Banality of Evil.** Now for a related matter. We can see that we practice ‘doublethink.’ This is partly because the division of labor allows various occupations to formulate justifications for their daily routine. Consider what the man on trial for the Holocaust, Adolph Eichmann, claimed in 1960:

“You say illegal. Today I have a very different view of things.... But if anyone had asked me about it up until May 8, 1945, the end of the war, I’d have said: This government was elected by a majority of the German people... every civilized country on earth had its diplomatic mission [to us]. **Who is a little man like me to trouble his head about it?** I get orders from my superior and I look neither right nor left. That’s not my job. My job is to obey and comply.” [Emphasis added]

Sure, that’s the old “I have to obey” routine. We all seem to be obeying our masters today, and we even pretend they’re nice. Eichmann argued that since the German government was legitimate, its policies can’t be evil. Ah, that’s so familiar! And it’s why conspiracy theorists are rejected. (See my 1991 book *Morality among Nations* for the biology of this.) Attending Eichmann’s trial, Hannah Arendt noticed “the banality of evil.”

**Moral Autonomy No Longer Exists.** There was a time, in our pre-history (i.e., tribes with no writing) when a society had, say, a hundred members. “Morality” could be policed by everyone against everyone. If A did not keep the promise he made to B, B could get back at him. Population later increased and at this time the major religions of the world emerged. Robert Sapolsky, in his 2018 book *Behave: The Biology of Humans at Our Best and Worst*, says we had to ask a god to do the policing as we could not see each other.

But even that is lost now, says Lionel Tiger in *The Manufacture of Evil*. There isn’t a well-shared national religion. So one does not get praised for being virtuous. And don’t forget the ‘free-rider’ problem -- we can tolerate a few individuals jumping the

turn style while we pay our fare, but we lose motive to pay fare if too many do it. Today, a majority are free riders. People have lost the sense of social obligation. Obligation? What's that?

Meanwhile, as with Lahaina's fire, our leaders boldly deny the wrong-doing that they are clearly doing. During the Covid pandemic, virtually every person in a position of authority transmogrified what they were doing into something helpful. (Please note: I have re-stated the pandemic's crimes in a musical, set to Gilbert and Sullivan's *Mikado* tunes, at my website.)

So, I've suggested here that we employ our larynx when we hear a public lie. And we should generally reject the culture of deception. Elderly Americans can remember when it was not like this. Most people behaved honorably; you were expected to do so. Integrity itself was a beautiful thing.

This may be because truth is well connected to justice. Conversely, bad people try to get out of blame and punishment by lying about their real work. Government is endlessly putting a new spin on facts. I disapprove of the words of the Marine Hymn: "First to fight for right and freedom, and to keep our honor clean." That's *not* why we fight. As General Smedley Butler famously said, "We fight to help the banks." The lies in that song diminish the real patriotism of courageous Marines.

The solution is not to alter the song but to **correct the facts on the ground**: our military should cease working for banks.

Note: I sent a copy of this book, *The Historian's Tale*, to Navy veteran Ron Kukal in Wyoming, who is known for his heroism aboard the *USS Liberty*. He phoned to tell me that when he opened the package that had this book in it, and saw the cover, he was so startled he dropped the book on the floor. Kukal said he had always felt, at an emotional level, a connection between the 1967 Liberty incident and the 1963 JFK assassination – namely because both were so intent on hiding the truth.

## Chapter 24. Recap of *The Historian's Tale*, and Affidavit

When Geoffrey Chaucer penned *The Canterbury Tales*, in 1392, he pictured a group of pilgrims, en route to the Holy Land, entertaining one another with tales of their profession. There was the Cook's Tale, the Nun's Tale, the Pardoner's Tale, and so forth. (The pardoner was selling indulgences.)

There was no Historian in the group to tell his/her Tale. For this book's title, I chose "The Historian's Tale" to refer to John's telling of his wild story -- *as history*. I look forward to people complaining to me "But he's not a historian, he lacks the skills." Fine, but would my interlocutor please show me the skilled historian who recorded the event of John's kidnap?

This penultimate chapter will recount John's report, which occupied Part I. It will also recap my bit, Part II, parts of which proclaimed to adjust the historical record.

6. A short biography of Grandpa Joe Kennedy tells of his pushing his sons into politics, his blatant marital infidelity, and his investments in Hollywood, banking, liquor, and casinos.

7. John was in the Special Forces, but only off the books. That chapter surveys the writings of some great MK-Ultra survivors.

8. John's 26 first-cousins are listed; he invites communication.

9. John's survival from the 1999 plane crash is recorded in Mary Maxwell's interview conducted on November 14, 2024. He

reckons the crash was meant to kill his substitute, ‘George,’ and wife Carolyn Bessette, and her sister, plus himself, in order to get rid of ‘the Junior problem.’

10. John’s work-history includes construction, cutting wood, long-distance truck driving, submarines, roofing, and “other.”

I demand Justice for my mother Jackie, Justice for my sister Caroline, Justice for my father, for my Uncle


Robert Kennedy, and other relatives and of course myself that have fallen victim to this organized crime ring that we do have in our government.

## **Exhibit A. How the CIA Can Make a New Person**



*US Navy Captain Russbacher (1942-2005) a high-ranking CIA man who claims noble title in Austria. The article appeared in Rayelan Allan's "The Obergon Chronicles." Slightly edited and bolded by MM:*

**Recruitment.** A preset group of our people (from Intel community) canvasses the county hospitals and immigration centers in order to find viable candidates. We locate and select people who have no close family or friends. Once they have been selected, they are put under heavy, Level One hypnosis. At this time a clear and definitive pattern of their usefulness is determined by our psychiatrists and field officers.

**Levels 1 and 2.** The subject will be told when and where to report. The subject will have no memory of being given these instructions, he will just report on time to the proper location. **IF the subject was given a "trigger" word or symbol, he will report to the designated location upon activation of the "trigger".**

**Level 3.** The next step is Level 3 hypnosis, where the subject will become an **"overwrite"** upon his own personality. An **"overwrite"** is a **new identity or personality**. It is similar to having multiple personalities, except the original personality is repressed or hidden under the **"overwrite"** and will not surface for a set period of time which is determined by the Programmer. The **"overwrite"** is not a complete new identity. There is just enough information written into the subject's personality for us to determine his viability.

In the case of a Field Operative, Level 3 hypnosis is how the operative is prepared for a covert mission which requires a temporary new identity. **Just enough information will be written in for the operative's alias and story to be believable by everyone, including law enforcement officials.**

For the field operative who is being prepared for a deadly covert mission, a Level 3 “overwrite” can eliminate all fear and nervousness, and allow him to function under the nose of his enemies without the added stress of being discovered.

**During Level 3 programming sessions, the new subject is told that anything his “friends”, i.e., programmers, ask him to do, is okay, even though it may be against all laws of the land.** At Level 3, the person is also **programmed** to believe that he must and can do everything his “friends,” i.e., programmers, ask him to do.

**The higher the IQ of a given subject, the further the programming goes!** [We] determine how the subject can be further used. Once this determination is made, the subject will be brought to “The Farm” or one of our numerous facilities. (Doctors Hospital in Dallas, TX is one of our main centers!) If he has to perform a particularly suicidal or important assignment [in Level 5] we do our job at Stoney Mountain facilities.

**Level 4.** This is the Level that turns a subject into a “Clear Eyes”, i.e., a fully programmed “sleeper” assassin, who can commit crimes as serious as murder, and afterwards **have no shame or guilt.**

The Level 3 Super Human “overwrite” replaces the subject’s own morality and/or religious ethics with a program that **makes him believe he is beyond all human laws**. If the intent is to create a programmed assassin who will kill on cue, all morality, fear, and **revulsion of bloody body parts must be eliminated**. The Super Human “overwrite” eliminates both. The Super Human “overwrite” also gives the subject the feeling of immortality and **invincibility**.

Once the Level 4 programming is complete, the subject will be a different person with no memory of his former life. **He will not be an amnesiac; he will have memories. Ones which we gave him.** He/she will be relocated to a new state and town and given a new life.... Passport, credit cards, and birth certificate will be created or supplied by us and will be valid and legal.

The subject will also be provided with all the small things that ordinary people have in their lives, such as photos of his family. His

family won't really exist, but he won't know this. **He'll have all the feelings of love, hurt or anger that normal family members feel.** The photos of family and friends will be of deep cover agency personnel. If ever a mission goes "sour" and the news media starts looking for his family, the "agency created family" will be produced for a news conference or an interview. **Agency personnel have been well coached and are trained actors and actresses.**

They will fill their roles perfectly, usually letting the public know that the "Clear Eyes" subject has always had a deeply troubled and violent past. **The media will present the "Clear Eyes" as a nut case who went on a tragic and senseless rampage.** Within a month, the public will have forgotten the incident. [How true!]

If the subject is going to be used to infiltrate a patriot group, religious commune, political campaign or environmental movement, the subject will be given all **the knowledge and beliefs that are commonly held by people in his targeted group.** The subject will believe that his fervently held opinions are his own. He will be believable to other members of the group.

Many politicians and government officials on a worldwide level have been given "new agendas". They are given super-human talents such as a photographic memory, and the ability to lie convincingly.

**President Clinton is an example of a world leader who has been programmed with this technique. Senator John McCain and Secretary of State Madeline Albright** are two other examples of an "agenda overlay" being "overwritten" onto the subject's own personality. Their own personalities and memories are still present, to a large extent, although childhood and early adolescent memories are sometimes erased when this technique is used.

Once the future government leader is programmed, **he will be recalled on a yearly basis and given hypnotic reinforcement. ...** If no new programming is needed, the reinforcement programming can be done on a mass scale. In other words, "programmed sleepers" who are part of a lecture audience or a "think tank retreat", can have their programming "reinforced" through a lecture or film. **The rest of the audience, such as wives and children, will notice nothing out of the ordinary.** -- End of lengthy quote

## Exhibit B. Anneke Lucas on “Sweet Revenge”

I used a mindfulness exercise to make sure that I was approaching the young part [of me] from what I call the “parental self” – but it took some focus to connect with this part, with genuine interest. Next, I began to get a sense of the numbers of the rapes, and how much of her natural reactions had to be suppressed. I got in touch with my young girl’s incredible frustration, the tragic powerlessness of being forced into sexual acts with hundreds of grown men, smelling their sweat, ...

I asked her: “What if you could do anything you want?” She smiled with glee. I asked her if she needed anything, and again, she smiled impishly, as I offered her a big, freshly sharpened Samurai sword. She went straight to work, and I quietly observed as she caused a terrific bloodbath, torturing and killing her naked rapists, screaming with laughter.

When she pulled at the penis of one of the hairy, pale-skinned, big-bellied rapists, she asked him: “Do you want me to cut it off in one hew or would you like it to be cut off little by little?” Her wide-eyed victim was speechless.... He stammered that he preferred that she do it fast.

“Okay,” she decided, bringing the sword to his penis: “I’ll do it slowly.” And as she proceeded to saw, and he screamed in bewilderment and extreme physical agony, she revelled as she scoffed: “What? Did you think you really had a choice?” And I was reminded of ... my childhood when I was confronted with an impossible choice.

My young-girl-part cut off dozens of men's penises. When she grabbed it, she looked at the tip and joked that she was looking right into the single eye, their greatest secret symbol by which they give so much importance to their own phallus. "Why don't you use this to cover one of your eyes?" she squealed, cutting off the tip and handing it to its owner. She killed them quickly, slowly or not quite, but bloodied all of them, enjoying the looks on their faces: their shock, pain, their feeble attempts at fawning, blubbing, pleas and sometimes even their commands for her to stop. She had tremendous fun, and once ....saw that I was still watching, and then we smiled at each other.

The walls and floor of the rectangular room in which all the ugly nude men were gathered was covered in blood, with bodies piled up everywhere, with some survivors groaning or making faint attempts to move. As I wished to meditate, I checked with the part and she let me know that everything was fine; she was good, she was having the time of her life, and she did not need me. When she announced that she was hungry, and did not get served food instantly, she was frustrated and quickly became enraged again, so I asked if it interested her to enter back into the bloody room and perhaps kill off a few more of those who were still moving, but, she said, with surprising authority, that she did not even want to think about that place. She wanted to eat, and to be served. I was slightly puzzled at her mood, as I am used to parts who, after they receive what they need, are the sweetest little children, perfectly content.

This part wanted to continue to feel the high of power, and be surrounded with beauty and refined things while being waited on. As I allowed her to indulge, I felt, through this part, the pleasure of status and power. Perfectly relaxed, her presence and sense of humor were very attractive. I, as the parental self, happened to know that

her power high, which induced her ease, covered the same rage she had channeled during her debauchery.

This part helped me to understand elite perpetrators better, who appear to lead charmed lives, but are secret power addicts, switching from part to part without any connection to their spiritual essence, or the Self.

Power is based on anger, and offers a platform from which revenge can be had in perpetuity on all those lower in rank. And since power or any addiction do not heal, and can never remove the underlying frustration and rage over past abuse and humiliations, the need to channel the anger increases rather than decreases.

It is difficult to grasp the vast dissociation power addicts experience. We only get to see the front part that may be charming or relaxed or intense or brilliant, which is nothing but the calm after the storm. Without status, which protects the secret darkness, they could never keep up the pretense of the front.

Their motto “Do as Thou Wilt” creates the storm, much like my young part, reversing all the indignities she suffered, free to be the sadist, ridiculing victims while slaughtering them. Those in power all belong to secret societies, which only at the highest levels reveal why the secrecy is so important. If we would understand how disappointing, how ridiculous and banal are their secrets, if we got a glimpse behind the lies and the enormous machine they control to keep us believing that we need them to lead us, we would instantly take charge.

We have to be the change which they, by the nature of their position, can never be. Power can only protect itself; its slaves pretend to create change while creating nothing but a world in the image of their frightful internal chaos.

## Exhibit C. Former Cult Programmer, Svali, Speaks Out

The following is the **Illuminist agenda** at ALL levels. The Illuminati plans specific steps. Each region of the United States has “nerve centers” or power bases for regional activity. The US is divided up into 7 major geographical regions. Each region has military compounds and bases that are hidden in remote areas.

These bases are used intermittently to teach and train generational Illuminati in military techniques, hand-to-hand combat, crowd control, and all aspects of military warfare. Why? Because the Illuminati believe that our government, as we know it, as well as that of most nations around the world, are destined to collapse.

## **Exhibit D. Jas Perloff, 'Regionalism' To Worry About**



At JamesPerloff.net, we learn that James was an autistic child, as a result of the DPT shot, but struggled [successfully, says MM] to write perhaps the first textbook of conspiracy theory, back in 1988. He composed the following piece during Trump's Inauguration on January 20, 2025:

Trump's ambition to expand America is nothing more than a repackaging of an old satanic plan to establish world government through regional stepping stones. For a study of the globalist power brokers at the Council on Foreign Relations (CFR) in 1988, I went through every issue of *Foreign Affairs*, the CFR's flagship journal, going back to its first issue in 1922. There was no Internet then!

In *Foreign Affairs*, I saw that the CFR had abandoned the idea of, in one swoop, unifying the planet under a world government. Instead, they reasoned, they could gradually bring about global governance by organizing *regional alliances*. -- a "stepping stone" approach (also known as "boiling frog").

For example, in the *Foreign Affairs* January 1926 issue: The Locarno [collective security agreement] represents an attempt to arrive at the same end by stages,—by treaties and local regional pacts until they are absorbed by "one great world convention guaranteeing world security and peace by the enforcing of the rule of law in inter-state life."

Shortly after America joined NATO in 1949, Elmo Roper of the CFR issued a pamphlet entitled "The Goal is Government of All the World" in which he mused: "But the Atlantic Pact (NATO) need not be our last effort toward greater

unity. It can be converted into one more sound and important step working toward world peace. It can be one of the most positive moves in the direction of One World.”

In his April 1964 article “The World Order in the Sixties,” Roberto Ducci wrote:

*“Pending the formation of such wider ... political units, encouragement should be given to regional organizations, of the type recognized by the U.N. Charter. They should be strengthened so as to make them able to keep the peace in their respective areas: NATO in the North Atlantic and the Council of Europe in the European regions, O.A.S in the Americas, O.A.U. in Africa, SEATO in Southeast Asia.”*

The European Union is probably the epitome of regional government. It was, by design, evolved out of the Common Market. Today it has its own diplomatic representatives, the European Parliament, and a common currency in the euro. In the July 1968 *Spectacle Du Monde* we are warned by French statesman and journalist Raymond Bourgine: “[There is a] “Supranational Europe” to which member States will progressively surrender their attributes of national sovereignty. In the end their economies will be integrated by Administrators in Brussels while awaiting a European Assembly. The national states will then wither away.”

Zbigniew Brzezinski laid the strategy on the line at Mikhail Gorbachev’s 1995 State of the World Forum: “*We cannot leap into world government in one quick step. . . . The pre-condition for genuine globalization is progressive region-alization.*”<sup>5</sup> In 2005, President George W. Bush attempted to create a North American Union turning an economic partnership (NAFTA) into a political union, just as the EU had evolved out of an economic partnership (the Common Market).

Quoting my [Jas Perloff] 2013 book, *Truth Is a Lonely Warrior*. In 2004, the CFR’s Robert Pastor wrote in *Foreign Affairs*: “*Security fears would serve as a catalyst for deeper integration. That would require new structures to assure mutual security.... The Department of Homeland Security should expand its mission to include continental security – a shift best achieved by incorporating Mexican and Canadian perspectives and personnel into its design and operation.*”

### **Day Three — Ways To Obtain Control of Governments**

“Boys, as you have now learned, we can engage in violence and we can use distractions. But that’s a burden for us elites. Wouldn’t it be smarter to have the people think they are obeying a government? Naturally, you’ve got to make sure that the real governing personnel behind the scenes is us. It works wonders. Just do this”:

1. Place your puppets into appointed positions.
2. Increase authoritarian rule for the masses.
3. Have ‘staff’ assist legislators in drafting laws.
4. Use voter fraud to defeat some contenders.
5. Fill the judiciary with compromised persons.
6. Legislate unfair exemptions for corporations.
7. Legalize the central control of banking.

### **Day Six — Ways To Lower the Quality of Daily Life**

“Soldiers! Our experts have found that the programs you’re being taught this week will best succeed where there is general unhappiness. I don’t mean the kind of unhappiness that leads to vengeance — we don’t want that — but the kind of social distress that keeps people occupied, trying to solve each new problem as it arises. Of course, the mass media is a big help here as they tell people how to analyze the situation. That is, they provide incorrect interpretations. You must endeavor to do the following things”:

1. Dispense drugs to cause addictions.
2. Keep people sick, such as with cancer.
3. Let ‘Child Protectionists’ traffic children.
4. Incite one group against another.
5. Burden businesses with regulations.

8. Mix the roles of government and business.

### **Day Seven — Ways to Botch God’s Gifts**

“Well, have you been enjoying bootcamp? What’s that I hear you say, Shorty? You say you have learned that you are a god? Wonderful, by six o’clock tonight you may well be a god. As it happens, the scheduled topic for this final day is how to deal with the Creation. This planet is your planet. I mean it’s the planet of us, the elite. We can, and should, do what we please with it. So let’s not hesitate to”:

1. Re-design the weather.
2. Change natural crops to GMO crops.
3. Callously cause species to go extinct.
4. Pollute the oceans and destroy aquifers.
5. Spread toxic chemicals, e.g., pesticides.
6. Interfere with children’s innocence.
7. Undercut the basis of social trust.
8. Honor technology as Destiny.
9. Downgrade anything that’s considered divine.
10. Replace the masses’ love with loneliness. Yay!

## Exhibit F. Wendy Hoffman, Political Parties and Satanism

In an earlier draft of this essay, I wrote on our political scene and included an initiation ritual for a prospective political candidate. I connected an ex-mayor’s boosting ritual-party that took place before he was elected to the major political party1’s sexual rituals of the 1980s. A friend who read a draft of the essay pointed out I had the date off by over a decade. Mistakes are only mistakes for normal people, but mind controlled people don’t usually make meaningless mistakes. They are loaded and usually reflect mind control. They are more like Freudian slips. So I had to dig inside my brain and find what I had avoided.

Many surviving victims need this kind of trigger to discover who they are and what they witnessed. For me, this kind of self-probing investigation comes with hard emotional responses as the pertinent information makes its way from enclosed, guarded chambers of my formerly sealed brain to general awareness.

Slowly over the next two weeks, information dribbled out. One night, I had a headache. It lasted. I thought it was the weather but now I think it was a memory of head vises used on me during close-downs to make me forget what I knew and experienced. A little while later, I had a jolt from electricity—another body memory. I followed body pains as if they were bread crumbs leading to my mind. Dark facts emerged. **My difficult role on earth is to share this abhorrent information.** [Emphasis added]

The political rituals already described were exclusively for one major political party and guests. That is because some from the other hold similar rituals but in more elaborate quarters, mansions. They

also hold ceremonial rituals in landmark restored places. Their double-lined silk drapes, brocades, marble, furniture, ornamental decorations, materials can appear so rich that they stop appearing like what they are and look like money.

In the U.S. at least in the 1940s and 50s, programmers decided which political party the mind-controlled youth would belong to. Controllers wait until their boys are at least eight years old, girls, twelve to thirteen to start the process of selection. If the subjects show a charismatic personality, **are good in front of cameras, have the ability to double talk and not answer questions**, programmers start testing them for political offices.

The first party's candidates have to want to indulge all their senses. The second party's candidates primarily have to want to make others suffer. They also indulge their senses, but mostly they like sadism, and the first ones hurt others, but mostly they show no self-restraint. Programming leaders consider those traits the underlying male character. Candidates are tested repeatedly and depending on their stronger urges, they are assigned to either political party. **Those who passed numerous tests become some of our political leaders.** If they show no preferences, they are not included in political roles that these groups control. How old they are when finally assigned may be fluid. They chose many potential candidates as youths, knowing that the majority would fall away. There may be new methods of testing now.

Since I was not deemed to be in line for political office, I did not undergo this kind of testing. However, I was forced to watch some of it and participate. They would place a dish of ice cream and a slice of chocolate cake in front of the tested youths. They also placed a drugged cat or small dog in front of the children. The administrators told the children to eat all of the desserts and to twist the legs of the lethargic animals. They then measured the speed, which tasks they performed first and asked the children if they would like to repeat any of the tasks. Afterward, the children were hypnotized and the **testers ascertained the children's preferences from what they stated in a trance.** Housewives who lived in the building or neighborhood were told to line up semi-nude but wearing flowing chiffon capes in pastel colors. The women walk-danced in a line in

front of the children, most still too young to feel sexual. That may have been a precursor to the lines of **sexualized adolescent and young adults displayed at later political rituals**. This kind of line-up could also serve as a trigger. Some of these housewives did not have to be coerced to play their role. For a minority, some part of their mind-controlled brains seemed to relish exhibitionism. They came alive and swelled into their truer, less depressed beings.

Controllers said they thought I had psychic powers and wanted my opinion on who would be a successful future leader. They would ask me whether a little boy wanted to eat until he got a tummy ache or whether he preferred to hurt a cat. There was a line of us alleged seers and we all had to answer truthfully. A man with a gun intimidated us. I'm sure our answers had no bearing on how leaders assigned tested children but deliberately made us feel grandiose and like perpetrators.

I suffered during this memory retrieval, but not as I suffered when I had to live through it. I understood early on, the shape of my world. While others learned trust and had okay parents, **I understood deceit and betrayal**. Those who trusted, often don't see the deception in our world leaders, and those who learned mistrust may have trouble seeing good in people.

During the second political dinner party-rituals, children were intentionally terrified. They based their sadism on the pathways programming. Here children, sometimes blindfolded, were forced to walk down the long halls of mansions. Men and women would jump out at them. They also used murdered animals to scare them, then laughed at their child victims.


Yesterday I cried most of the day off and on. Someone inside, some part of my brain, said there were sacrifices at the second's party-rituals. They were similar to the ones in the basement of a revered New York City hotel. During the first's party-rituals, there also were sacrifices. Their altar and banquet tables were in different rooms, but in the mansions, the **banquet halls and altar were together**. I had different robes, but for sacrifices I had to wear a black robe, occasionally a white one. There was a sacrifice during every ritualized 'party'—its victims all ages from infants to middle aged, all races.

## 1. Introduction to This Addendum [MM]

In this part of the book, John looks for some sort of redress for what happened to him, and offers hope, and methods, to others. It's labelled 'Addendum' as it didn't appear in the first edition.

Once the *Stolen Identity* book was in print, John started to develop supporters. He gives almost daily podcasts; some of them feisty. He's aware that we tend to feel naughty when reporting government crime. We don't picture ourselves as a 'sovereign citizen' confronting tyranny or treason -- we feel that *we're* in the wrong.

"Even at the ripe young age of twenty, my gut told me that I had been conscripted against my will into participating in something so ugly – an incredibly horrible treason, **a betrayal that I had no control over**. The men who I have talked to, despite Kidd's warning not to, all agree that the worst part of the experience was being **made to feel like we were the criminals** for not obeying the order to sink, as commanded by the president." [Emphasis added]

Instead, they saved their ship, which was being torpedoed by Israel. Later, a whistleblower left a document in Johnson Presidential Library in Austin concerning "Frontlet615." ### 3. Justice for Jackie – A Wrongful Death Lawsuit

Mohave County Superior Court, Kingman AZ

John F Kennedy, Jr, aka David Quigley, Plaintiff, *Pro se*  
v

John Doe's Who Killed Jacqueline Onassis, Defendants.

Jury Trial Demanded [Filed March 11, 2025. Fee \$352 paid]

I. Introduction. After Aristotle Onassis died in 1975, his widow “Jackie,” was shot dead. Her 14-year-old son, the Plaintiff, heard shots and saw her in a pool of blood. A ‘new Jackie,’ who resembled her, took over the deceased’s public role until that new Jackie died in 1994.

II. Jurisdiction. This court has jurisdiction based on the location of the murder, Bullhead City, and is Plaintiff’s residence.

III. The Parties. Plaintiff is the true son of Jacqueline Bouvier Kennedy, born to her and President-elect Kennedy on November 25, 1963. His true name, John F Kennedy, Jr, was taken from him when he was placed with the Quigley family some time before 1970. The Defendants, John Doe’s, are unknown, but likely include the local Mafia, Secret Service, and FBI. Bullhead City cops probably did not record Jackie’s 1975 death.

IV. Statute of Limitations. Plaintiff asks the Court of Law, or of Equity, to permit this filing for wrongful death 50 years later. Plaintiff went to FBI in AZ but they dismissed him. My mother was murdered 50 years ago in Bullhead City. She was a famous lady, and soon after her death a “Replacement” lady was assigned to fake her role. That was in 1975. The public remained unaware of this arrangement and finally the Replacement died in 1994, still using my mother’s name.

I have a rough idea of where my real mother was buried in Bullhead City and a rough idea of the perpetrators of the whole affair. I was age 14 when it happened. I have recently filed a wrongful death lawsuit in Mohave Superior Court. There’s no time to waste, as much hangs in the balance. ## 5. Roadblocks on the Way to Legal Victory [by MM]

In the Bill of Rights, we find the beautiful **7<sup>th</sup> Amendment**: “In suits at common law, where the value in controversy shall exceed twenty dollars, the right of trial by jury shall be preserved....” Yet courts often try to stifle a tort (a suit for damages other than for breach of contract). And why? Because our courts are not, as we were taught, bastions of justice, protector of the little guy, etc. They are, naturally, **part of government’s power structure**. Courts are protectors of *that*, not of us!

What could be more obvious than a desire of the powerful to prevent John’s case from reaching the sacred shelter of law? I believe they will take horrible steps to suppress his story. They will even see it as their duty! They look upon Truth as a sort of bad thing. If our nation has done a false-flag, for example, “Don’t let anyone prove it!” (Just cogitate on *that*.)

In 2017, I filed a lawsuit against President Trump for threatening to make war “like the world has never seen” against North Korea. It – like many other individual’s war-powers cases – was dismissed on grounds of “the political question.” The Magistrate said she cannot adjudicate because the choice of waging war, or not waging war, belongs to the two political branches only.

Ah, but the US Constitution, in Article I section 8, clearly grants the war-making power to Congress, not the President. So when one of the three branches of government usurps the power of another branch, a constitutional question arises, right? My case should not have been dismissed. The judicial branch was not being asked to say Yes or No to a war with North Korea. It can make very narrow rulings about what the parchment contains.

Note: Even in a case, *Dellums v Bush*, where the plaintiffs were 50 Congressmen, who wanted to restrain a president in 1991 from ‘Gulf War I,’ the court snuck out of its responsibility by ending the case on ‘ripeness.’ They said Sec’y of State James Baker and Iraq’s Foreign Minister Tariq Aziz are negotiating in Geneva, so

no decision need be made today. Toodle-oo” (paraphrasing). In 2014, Capt. Nathan Smith went to court to ask “How can I tell my soldiers to go to war against ISIS when Congress had not done the necessities under Art I, sec 8?”. Court delayed ruling till Smith’s Army service was finished, then ruled the case “moot.”

Instead of listing particular instances of cheating by courts, it is quicker to make this statement: “When the Powers That Be don’t want a problem to get resolved, they successfully stand in the way.” As we all know, the same is true of mainstream media. If the PTB want silence on a subject, Silence will reign. For decades.

Courts also make their own rules and ‘doctrines,’ though they have no Constitutional authority for doing so. They also have dumped our Court of Equity without so much as a by-your-leave. The only way to oppose them is by other branches fighting turf warfare. The Founding Fathers *designed* the balance of powers to be maintained by turf warfare. To back up my claim that the courts do what they are told to do by the PTB, see the 10-year study done by Dr Richard Cordero in which he found that 99.82% of complaints against judges were dismissed. And what do law schools teach about this? Goose egg. The legal field is controlled by the American Bar Association. Does the ABA act like a guild for its members? Sometimes, but it always acts as the servant of higher powers. (AMA does it too.)

The late Sherman Skolnick, a self-trained lawyer, wrote, in the 1980s, that the requirement for a guy to become president of the ABA was to kill a person with his bare hands. He said Earl Warren did that, and that the person he killed was his own father. (I don’t know Skolnick’s source; he said judges often whispered to him.) Earl non-judicially headed the deceitful Warren Commission.

*Note:* just as ABA did a ‘takeover,’ the People can do a Takeover. Is the ABA really powerful? The fact that it has to hide its deeds suggests it lives insecurely. The fact (if it be fact) that the leader has to be aggressive suggests that People’s aggression is needed.

What about the foregoing Wrongful Death Claim by John Jr.? When a serious crime occurs, the miscreant should face prosecution by the district attorney, or the state, or by the feds if the crime was federal. If no prosecution takes place (as with Jackie's death), a family member or executor of the estate can file it, per their state or federal law. Also, 18 USC 241 makes it illegal to conspire to interfere with a person's constitutional rights.

John says the FBI came to pick him up when he was crying hysterically about his mom's killing. They threw him into a station wagon and asked him, at their office, to sign a confession to having done it. (Can you imagine!) Why didn't he mention this in his pleadings? Because an initial filing of a suit does not require details, or evidence. The judge is required to deem the allegations as true, for now. Also, pleadings shouldn't argue points of law.

John does not know the names and so listed "John Doe's" as the Defendants. Because a death is involved, this will require the authorities to do an investigation. Plaintiffs are told to send a summons to the Defendant(s). The Defendants are supposed to answer within 21 days, after which the judge may set a date for hearings and a trial, if either Party demands a trial.

Yet I've seen cases where the magistrate (low-level judge) publishes a dismissal, before the Defendants answer, based on "not my jurisdiction." This prevents 'Discovery,' by which both parties have the right to view relevant material in possession of the other. Judges also have the authority (based on something, or nothing) to seal a record. "National Security" is often cited, even when there is no foreign aspect to the case. In Australia, Senator Bill Heffernan has been unable to prize from courts the names of pedo politicians as these are under seal for 70 years!

Please think about it all, and calculate how likely it is that John F Kennedy, Jr will get satisfaction in his stunning litigation. Much has recently been revealed about corruption, so Citizens seem to be ready now to reclaim their duties as "the sovereign." Thanks be to Heaven.

## 6. Ear Print Forensics and Some Miscellaneous Pix

Each person has unique earmarks, so to prove who was at that door, they photograph the suspect’s ear.


Later, the mafia branched into other activities that helped protect their control. Naturally they would need to get into politics, or at least into the elections game, to make sure a Mr Goody-Goody did not get elected. And they could positively help the election of any of their workers who would be inclined to pass legislation that was safe for, or even beneficial to, the mafia.

They also needed to ‘launder’ their wealth, and this would have led to them getting involved in banking and also into apparently-neutral businesses, from farming to the airline industry. I assume that most of the largest industries today have made their peace with mafiosi, but I don’t really know how it’s done.


### **A ‘Book Tour’ about Mafia, Government, Business, Intel**

Walk with me through stages in which US government and business got married. This is not an area I have deeply researched and I may be wrong. Perhaps enticing deals were offered by government, for helping the war, but the author, Matthew Black, shows men doing their tasks dutifully – as men do.




In the above set of books, the scene switches to the inevitability of the law-enforcement positions becoming corrupt. Although *The Halliburton Agenda* mainly demonstrates how a big business gets very cocky and eliminates its competition, it also needs political sway over any politician who would stick up for the law. The book by Zephyr Teachout gives a history of corrupt-

tion in America. She has included rare cases where the public's refusal to go along with the marriage of crims and pollies (Australian for politicians) led to a turnaround, at least temporarily.


In the third book, Whitney Webb argues that organized crime is **completely interwoven** with political activity. Among her cases are that of Myer Lansky, Roy Cohen (Trump's mentor) and Trump himself, plus Jeffrey Epstein. As everyone knows Epstein ruled his Island roost, not only without trouble from, but with actual visits from, judges, royalty, and celebrities.

Let me repeat: If criminals are adept at corrupting government, **we will end up with no law** at all and actually no 'government' just a slave society in which you, the member, have no say. I have seen in the last 30 years that this is definitely on schedule!



Above are three more books on that theme, emphasizing **the failure of law personnel**. The title of Sidney Powell's book, *Licensed To Lie*, refers to the DOJ's allegedly giving itself "legal" permission to present untrue facts to the court. Fathom it. The Collier brothers, who I believe died for their trouble, discovered how 'software' makes a joke of elections, under the guidance of Legacy media. 



If death results from a violation of this section, or if the violation includes kidnaping, an attempt to kidnap, aggravated sexual abuse, or an attempt to kill, the defendant shall be fined under this title, imprisoned for any term of years or life, or both.”

Can we get together to discuss a request, by me, for backpay? Many others are asking for same. Thank you. John Kennedy

## 11. Why JFK's Death Changed the World [by MM]

I think the picture now points to President Kennedy's death as *not* set up by his various enemies: LBJ, Cubans, the mafia. And, naturally, it is outrageous to try to involve Oswald. 4. John Coleman, writing after seeing diplomacy documents, says Permindex (as suspected by Jim Garrison) played a role on behalf of UK. He also revealed that the Irgun gang that performed terrorist acts to create Israeli state evolved from the Myer Lansky underworld organization. This changes the picture re Jewish help; the globalists were the driving force.
5. David Ben Gurion was in the Committee of 300. He may have reported Kennedy's opposition to central power of world. See Guyenot's research on JFK's effort to withhold nuclear skill form Dimona in Israel. This led Guyenot to follow the role of James Angleton at the CIA, famously in cahoots with Israelis. I assume Angleton and Dulles would help each other.

6. In 2020, history professor Greg Poulgrain of Australia put forth a theory (which Americans ignored as too unfamiliar). Poulgrain learned of Rockefeller's desire to get control of a huge goldmine in New Guinea that no one knew about. But this would require the dumping of Indonesia's leader Sukarno in favor of Suharto. **My Musings.** In some ways I think it was a few individuals' desire for oil and gold that caused our political structure to become like it is today. What’s a **sweeter** thing to claim Than the **sound of one’s own, real name?** MK-Ultra screwed my **brain** .... Only **bits** left **in-tact**... ## 15. Can the Law of Inheritance Help John? [by MM]

Before becoming president, John F Kennedy, in 1954, wrote out a will leaving his wealth to two trusts. The beneficiary of The First trust is Jackie, whom he had married in 1953. The Second Trust is for his children, although none were yet born. Kennedy named three executors, instructing that a majority vote would prevail if they disagreed. Those three were his wife Jackie, his brother Robert, and his brother Ted. And if somehow those were not available to serve, JFK named his three sisters: Jean Smith, Eunice Shriver, and Pat Lawford.

### **The Carrying Out of a Will, under Massachusetts Law**

In Massachusetts, if the testator names one or more executors, as Kennedy did, those executors hold legal authority. I don't know how many executors have served until now. All six that JFK named are deceased. New executors were named -- probably by the signature of then-existing executors. (I am guessing that the last was Eunice. She died in 2009.)

In 1986, Caroline Kennedy married Edwin Schlossberg and they have three children, Jack, Rose, and Tatiana. At some point, Edwin became an executor of Kennedy's will. At least as recently as November 2024, according to a case filed by a man claiming to be the son of Marilyn Monroe and JFK, the court listed the two current executors as: Edwin A Schlossberg and Martin L Edelman. The attorneys for the trustees are at the New York City law firm Shulte Roth and Zabel LLP (NY). However, the jurisdiction over the trust is Massachusetts.

### **Can John Approach the Court Now?**

Private wills and trusts don't have to be probated by a court – that is mainly for intestacy (no written will) cases. However, contending beneficiaries can seek justice, for instance if there is fraud. Also, executors can be sued for mismanagement -- they are under fiduciary duty to work for both the estate and the beneficiaries. Massachusetts General Law, known as MGL,

requires that the executors notify all heirs. John says he was not notified. The law says that if an executor is unable to locate one or more of the heirs, he must diligently try various means. For example, under MGL Chapter 190B, the efforts may include: “Searching public records (e.g., voter registration, property records). Contacting known relatives or associates of the heir. Using online databases or social media. Hiring a professional heir-search firm... Publishing notices in local newspapers...”

**Fraud.** That statute is probably irrelevant, as John was not considered ‘missing.’ But the MGL covering the crime of fraud says, in Chapter 151A, section 47: “Each false or misleading statement, representation, or submission and each failure to disclose or **concealment** shall constitute a separate offense.”

Superior Court Civil Instructions Misrepresentation says: “A party may also be liable for fraud by knowingly concealing or omitting material information in violation of a duty to disclose it.” The MGL requires an estate to be probated within 3 years of the decedent’s death. However, it says that this deadline does not apply in cases of fraud or exceptional circumstances.

The Kennedy Trust still has funds, as, over the sixty years the principal was not handed out. Rather, per Kennedy’s instructions, each year the beneficiaries get the income from trust investments. It appears that the real John F Kennedy Jr can now ask the trustees to include him as a beneficiary. Why ever not?

In general, our wonderful law can sort out John’s rights. Yet his story is so shocking as to be truly bizarre. Understandably, people turn away from it. I think it possible that he will fail.

Yes, you heard me. Right here, smack dab in America, President Kennedy’s son, the one who saluted his casket, might go to his death without ever obtaining justice. We’re truly living in the jungle! Please do whatever you can to help. There are numerous groups springing up. I hope you’ll join one!
